property companies to prioritise these issues. In mining, engagement has improved health and safety oversight and encouraged better disclosure on carbon reduction strategies.

These engagements matter because if the companies that asset managers invest in fail to address these types of risks, it can harm their reputation, disrupt operations and weaken financial performance. This, in turn, affects the underlying value of those businesses and ultimately the returns delivered to investors.






Using votes to shape behaviour

Proxy voting is one of the clearest ways to influence how companies operate. Each vote is a chance to hold boards accountable and set expectations on governance, strategy and sustainability.

In 2024, our appointed asset managers voted on 23 501 company resolutions on our behalf, with almost no abstentions. This strong level of participation shows a commitment to making informed decisions rather than avoiding difficult calls.

Proxy voting is a cornerstone of stewardship because it turns ownership into influence. When used effectively, it encourages better corporate behaviour, improves transparency and helps preserve the integrity of company performance and management. This ultimately protects and enhances the value of companies and the returns delivered to investors. This is why we place such importance on monitoring and engaging with our asset managers around their voting practices. It's a critical lever for driving more sustainable investment outcomes.







Why does all this matter?

Stewardship is about making sure investments are managed effectively on every front. When companies manage ESG factors well, they reduce risk, build resilience and create more sustainable growth, all of which support stronger long-term returns.

As a multi-manager, we work with 25 asset managers overseeing R6 trillion in assets, from large global players to boutique firms, which allows us to influence practices at scale. This reach strengthens our ability to protect and grow the value of our portfolios.
