

The manager of the funds is Alexander Forbes Investments Jersey Limited (AFIJ) and the fund range currently consists of the following funds:

- Alexander Forbes Conservative Fund
- Alexander Forbes Balanced Fund
- Alexander Forbes Dynamic Fund
- Alexander Forbes All Equity Fund

Within each fund are a range of Mercer building blocks specifically designed to give access to different investment strategies. Only the highest rated managers on Mercer's in-house rating scale are used to create the building blocks.

## **AFIJ** follows a **broad three-step process** which is continuously repeated:

Asset allocation

Identifying where
to invest in broad
asset classes, such
as equities, bonds,
cash, property and
commodities, to try
and achieve the target
return for a given level
of risk within each fund.

Strategy allocation

Pinpointing styles of investment within each asset class that are more likely to provide outperformance over time. For example, which are more predictable and which complement each other, so that risk (exposure to loss) is effectively managed over time. The objective is to deliver value for money by deploying strategies that work together in the most cost efficient and effective manner.

**Implementation** 

Asset managers best placed at implementing the desired strategies in given asset classes are selected from a vast universe of managers continuously monitored and rated by Mercer. No single asset manager is expected to be an expert at everything, so, from the top managers recommended by Mercer a portfolio of investment strategies based on the asset allocation required is constructed.

- How long you wish to invest
- The goal you want to achieve
- The level of risk you are willing to take
- Your capacity for investment loss
