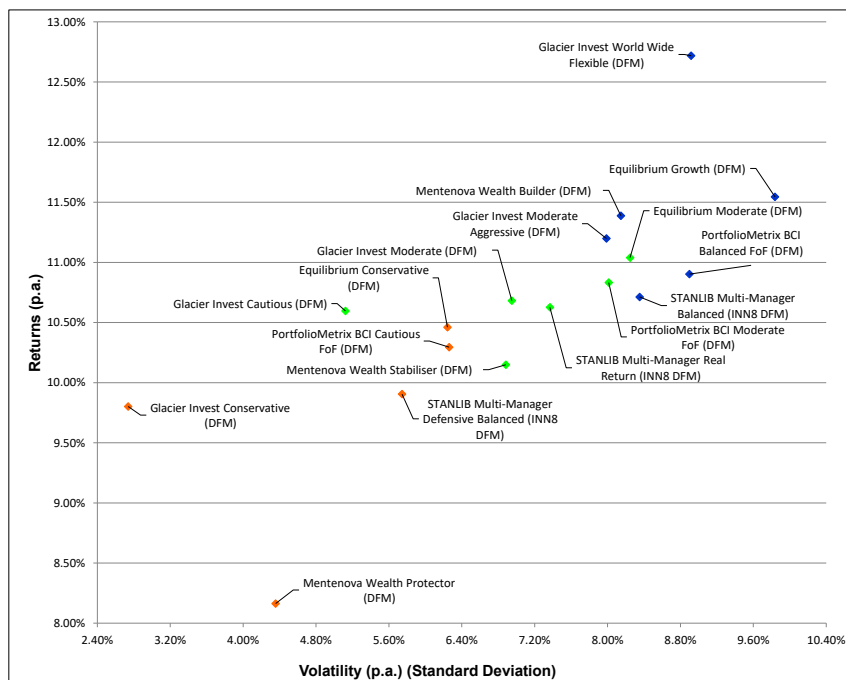

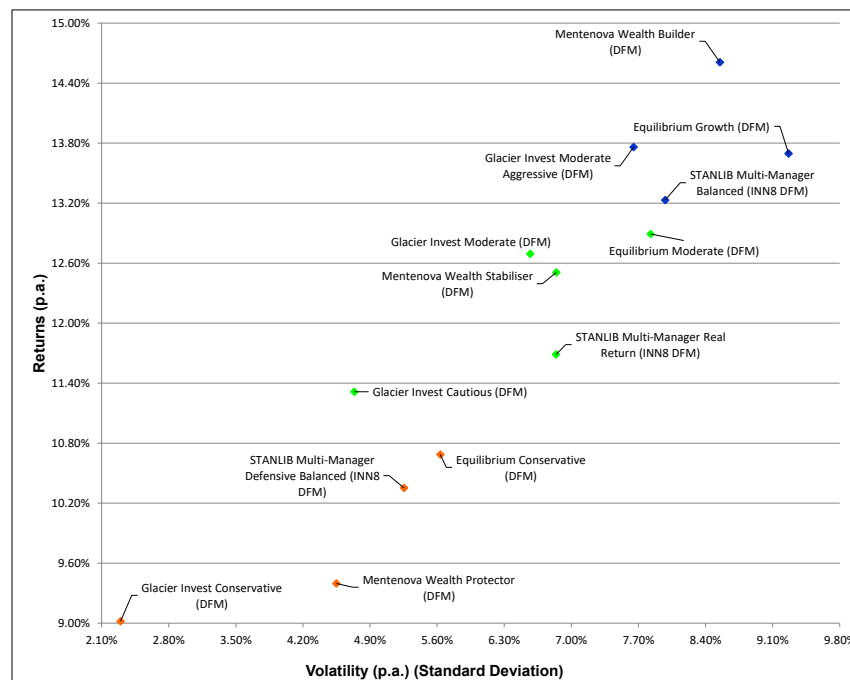

3 years ended 30 April 2025

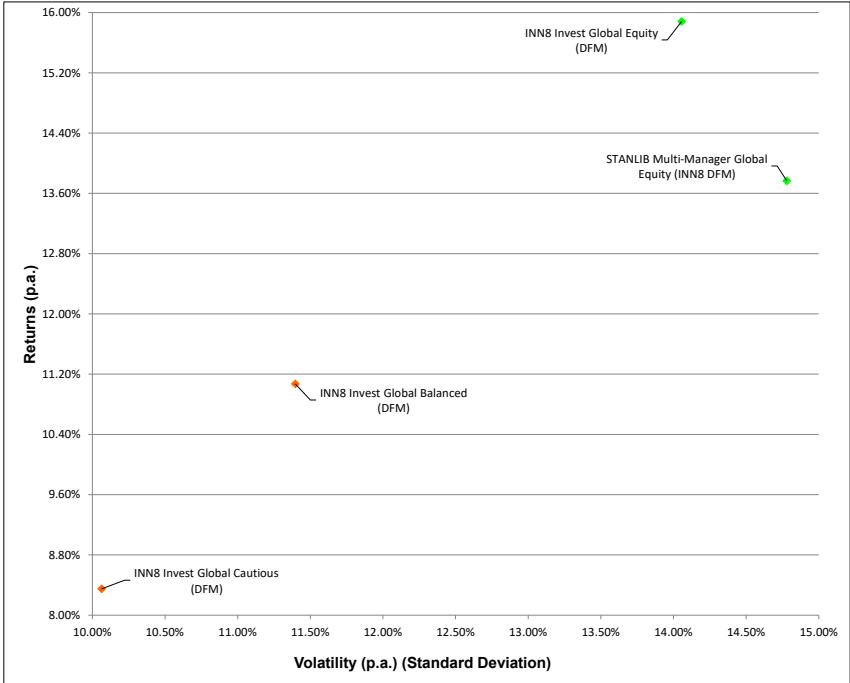


Risk vs Return
5 years ended 30 April 2025



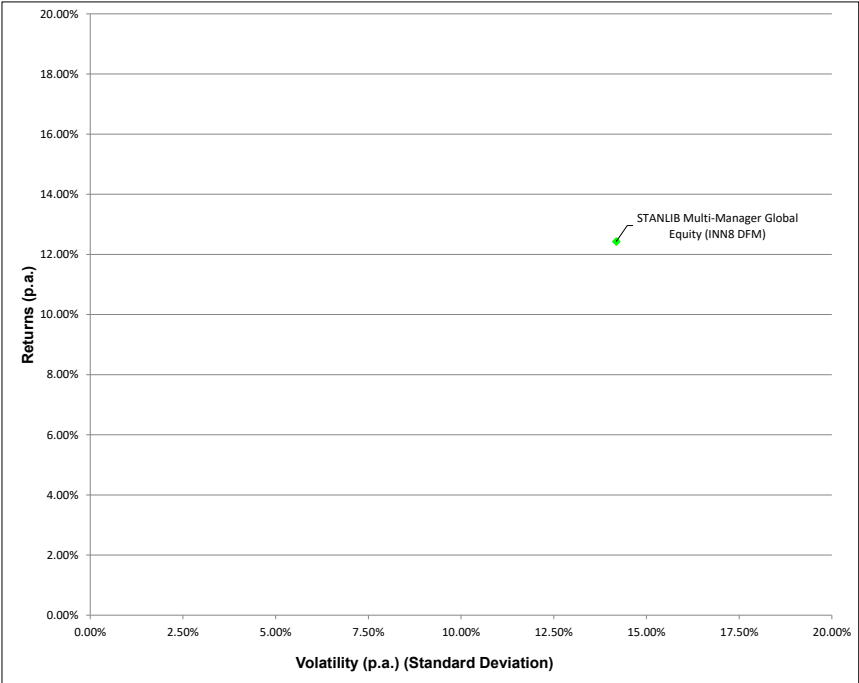

3 years ended 30 April 2025



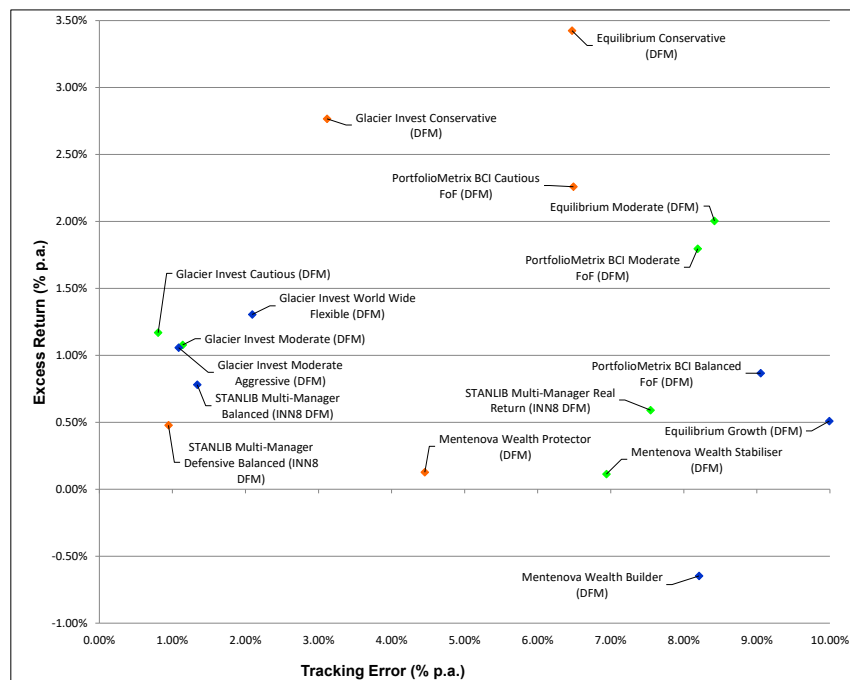

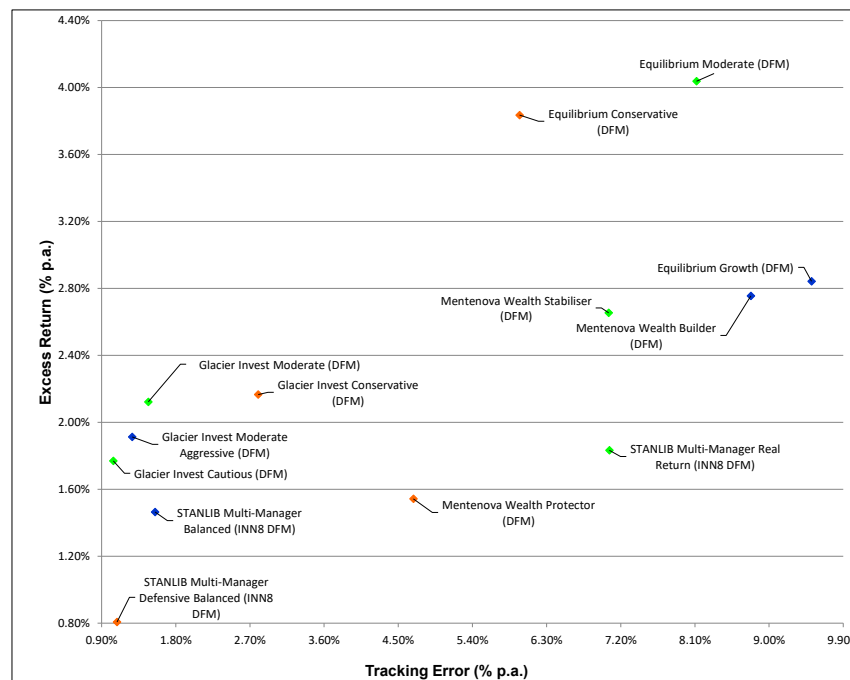


DFM MANAGER WATCH™ SURVEY - MULTI-ASSET SA INCLUDING GLOBAL

3 years ended 30 April 2025

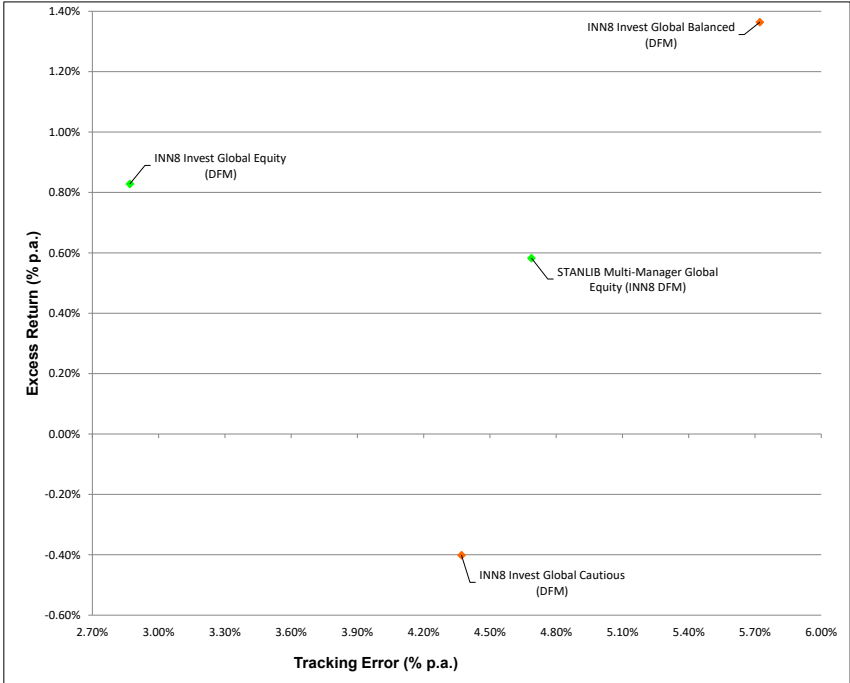


Excess Return vs Tracking Error
5 years ended 30 April 2025



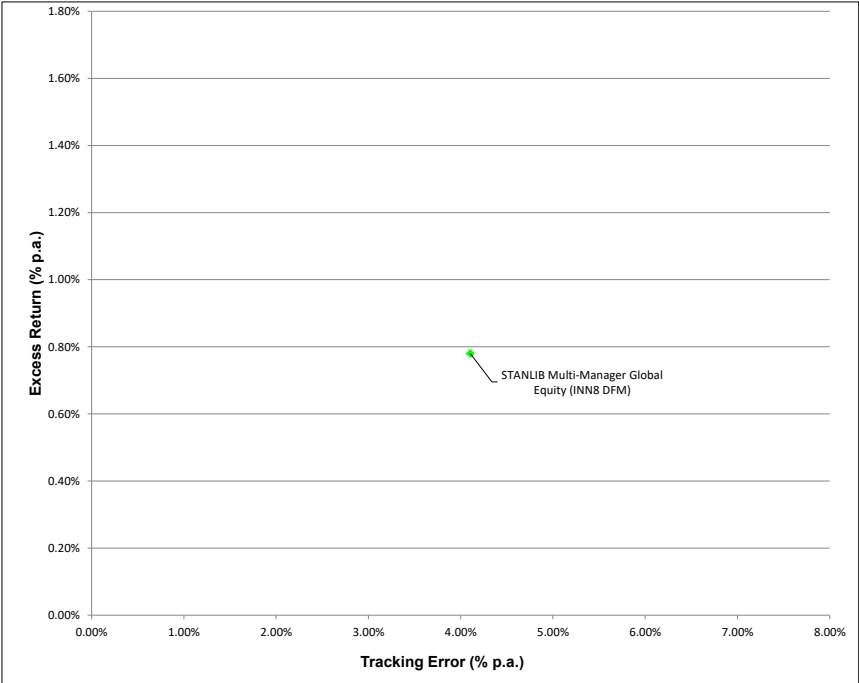
