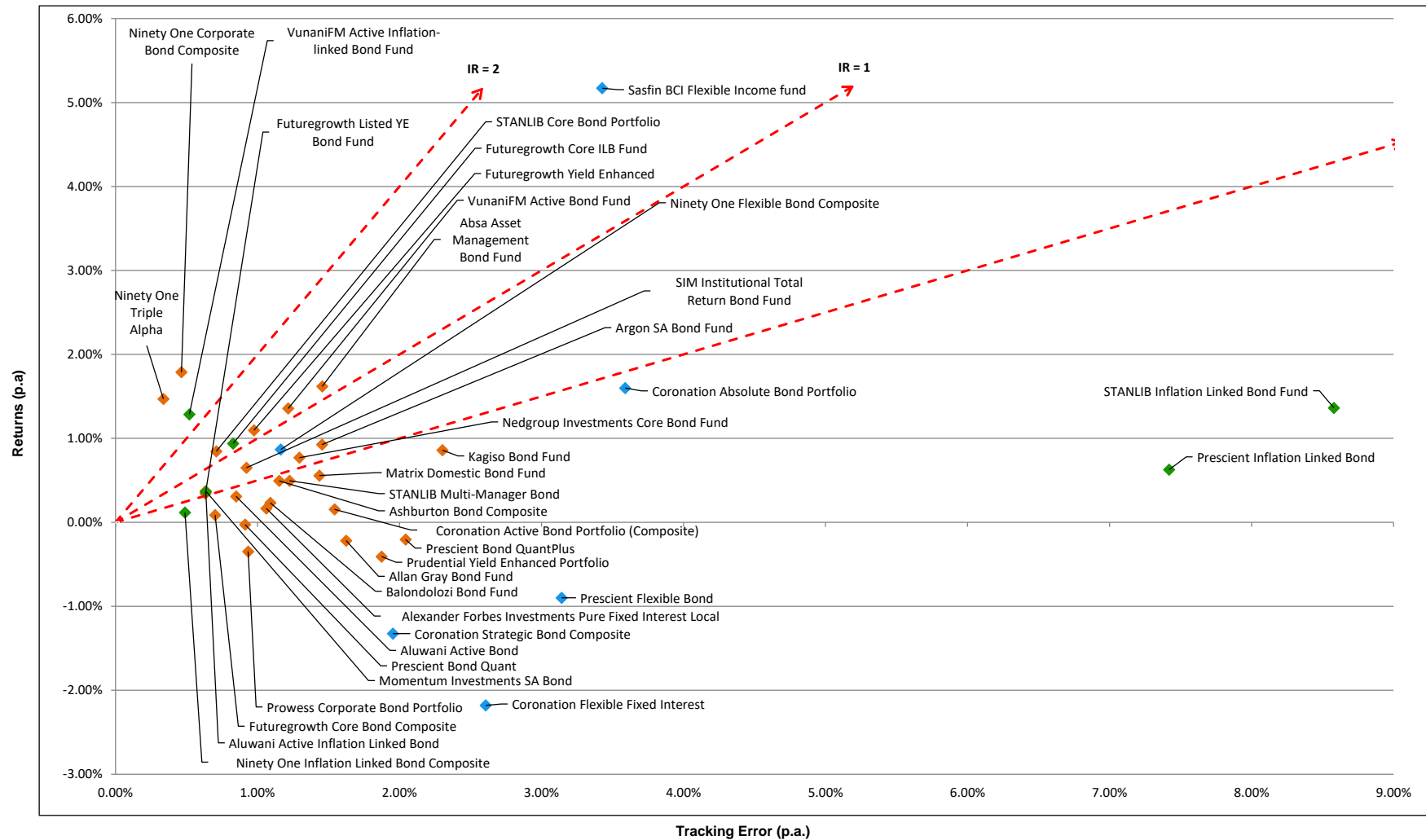

Active return vs Tracking Error scatterplot – SA Bond Managers

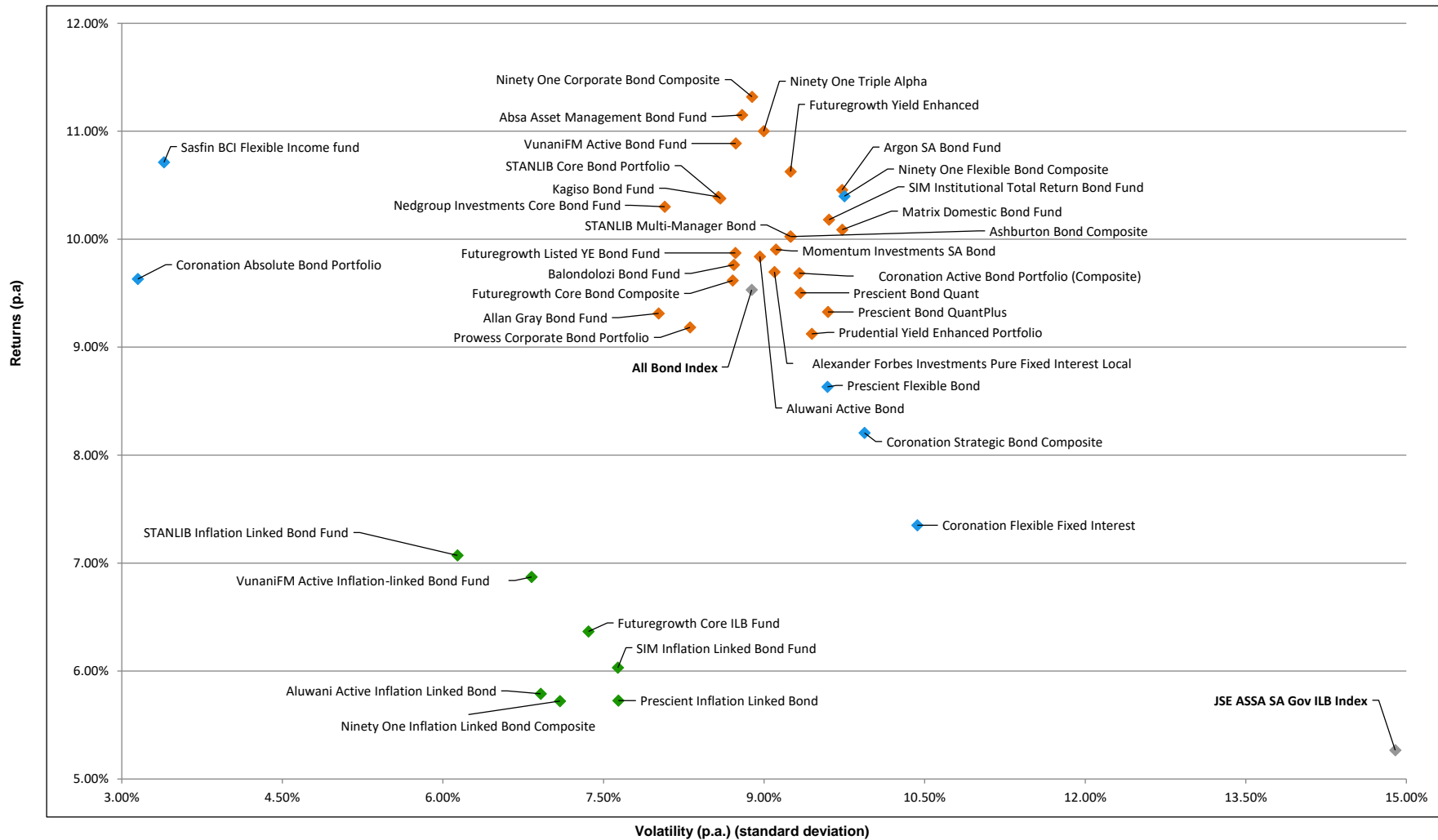
