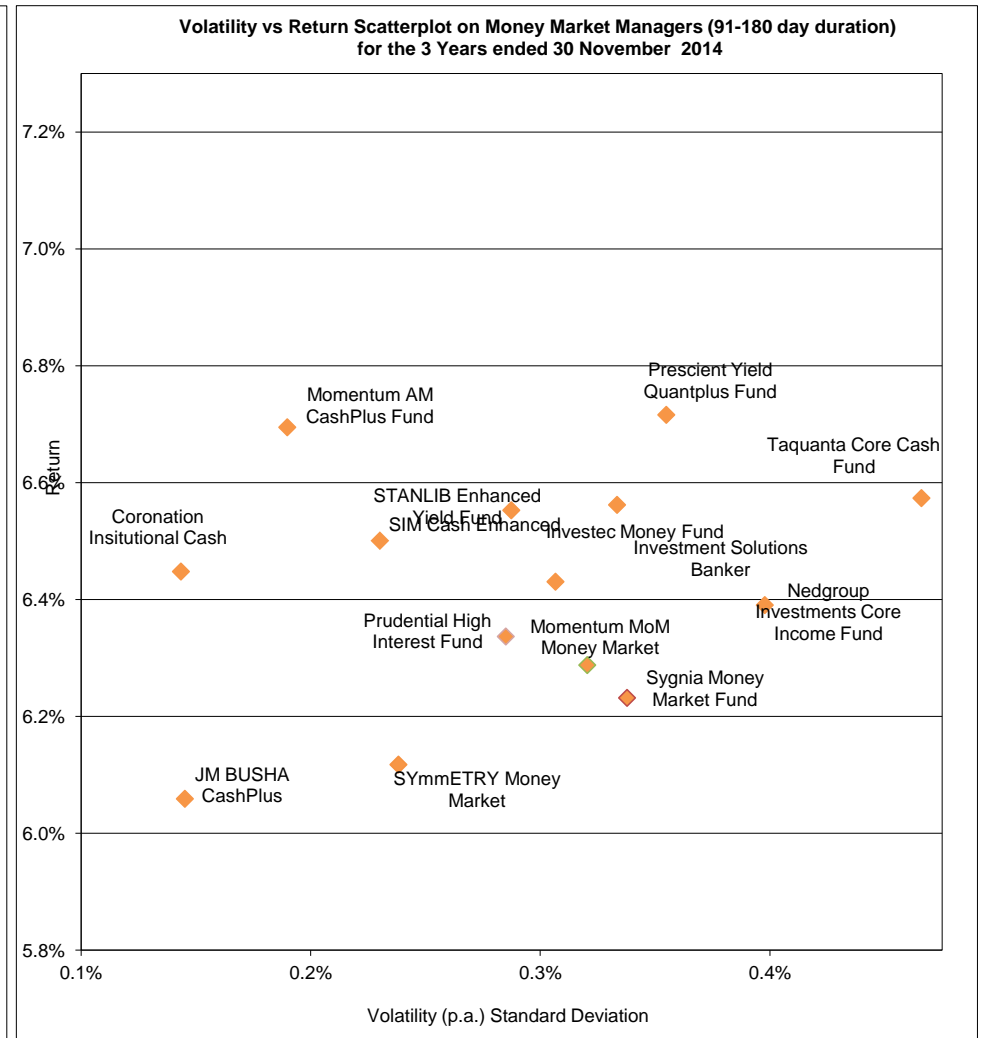
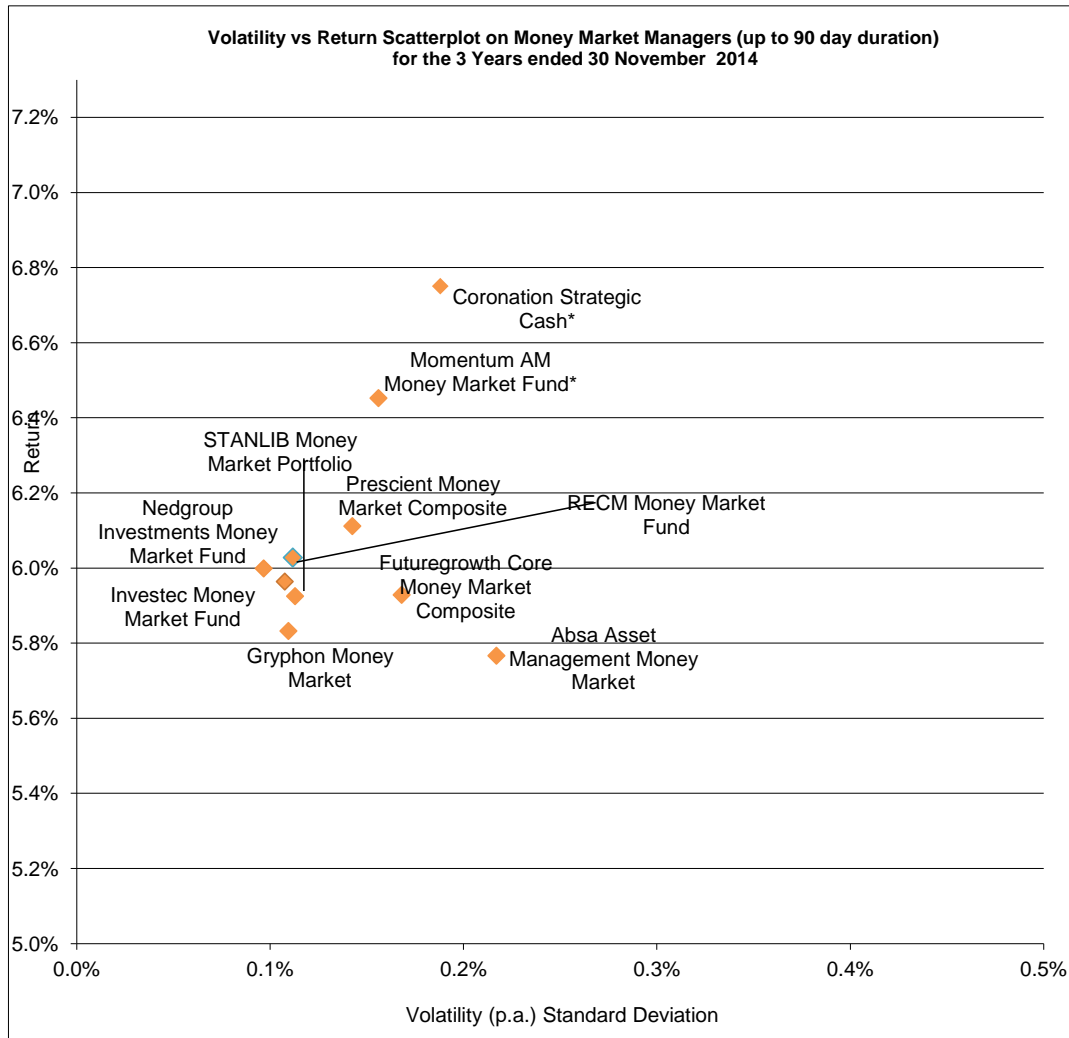

### Statistical Definitions :
