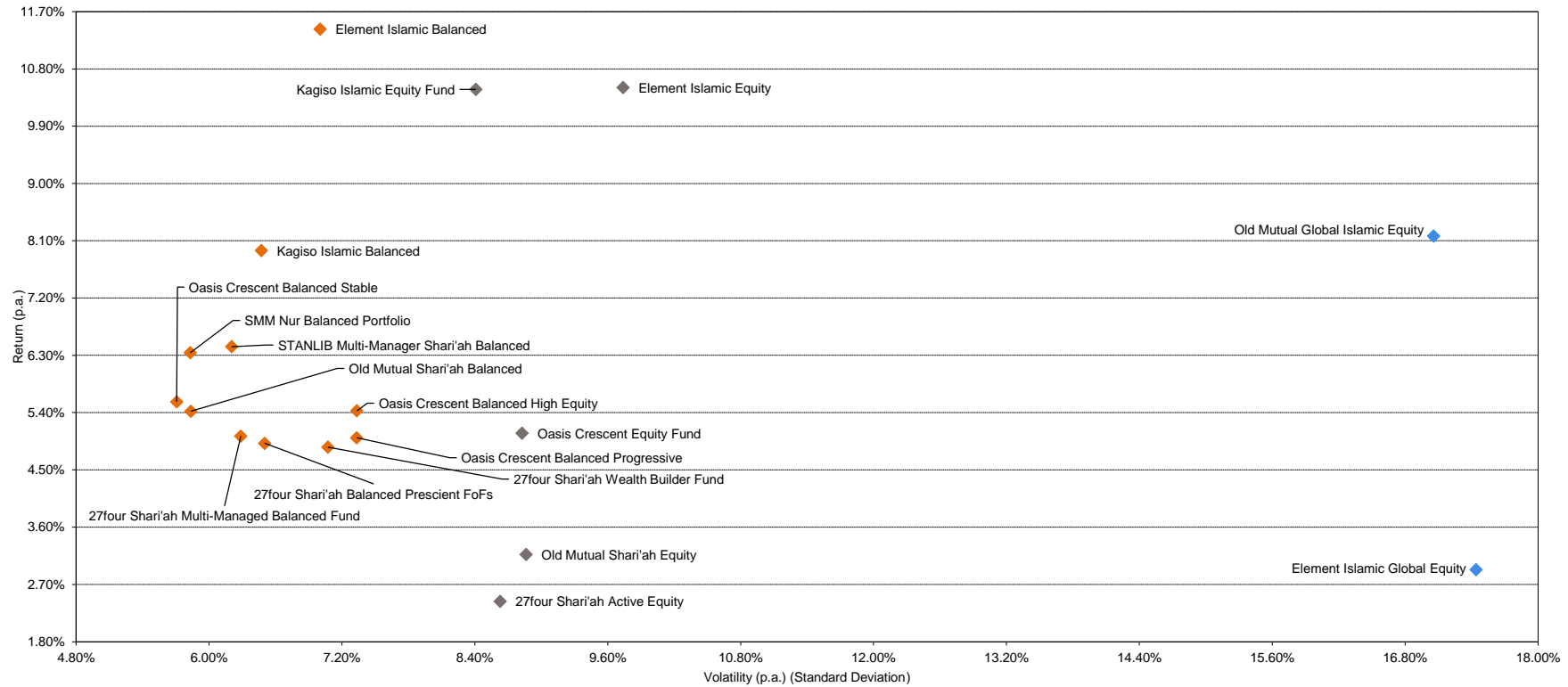

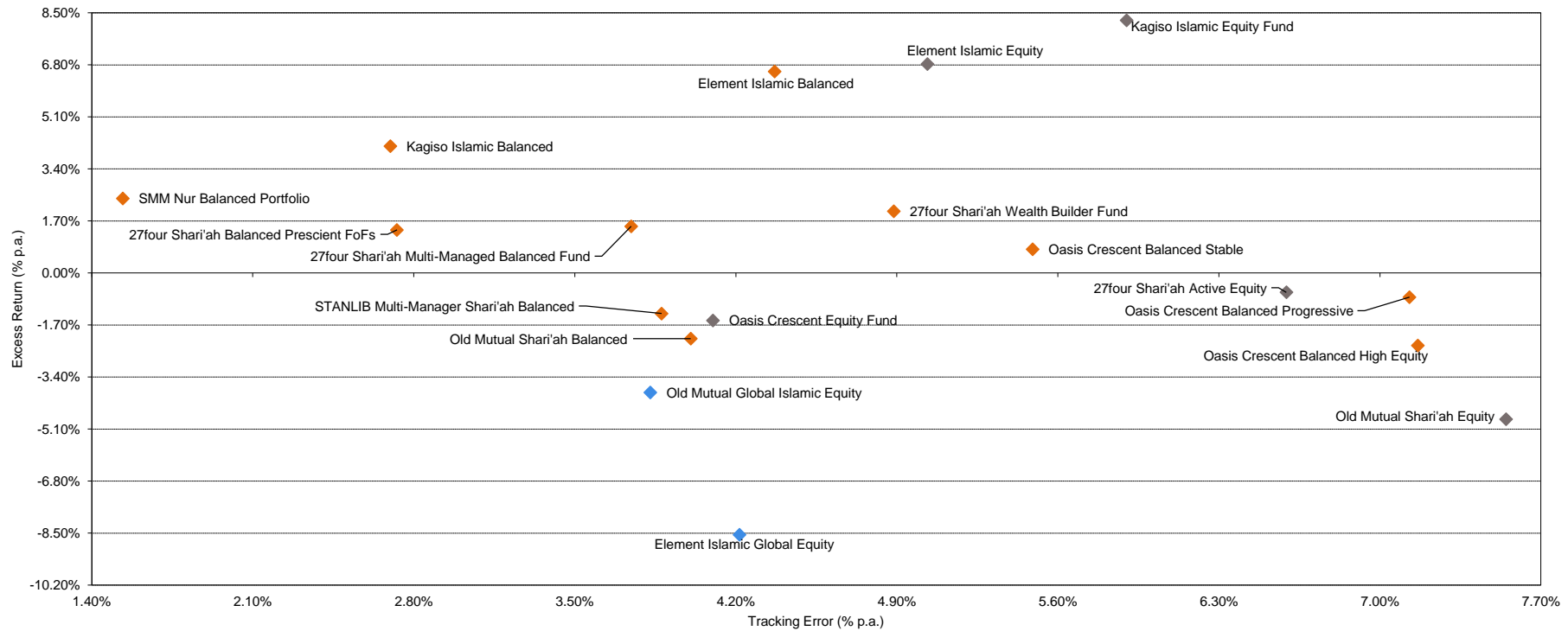

- * The fund manager conducts a purification process on the non-permissible income generated. The non-permissible income is usually donated to charity.
