






Risk vs Return
5 years ended 31 May 2025




RETAIL BOND SURVEY - SA FLEXIBLE/ INCOME BONDS

3 years ended 31 May 2025




Risk vs Return
5 years ended 31 May 2025




RETAIL BOND SURVEY - SA INCLUDING GLOBAL FLEXIBLE/ INCOME BONDS

3 years ended 31 May 2025




Risk vs Return
5 years ended 31 May 2025




RETAIL BOND SURVEY - SA SPECIALIST BONDS

3 years ended 31 May 2025




Excess Return vs Tracking Error
5 years ended 31 May 2025




RETAIL BOND SURVEY - SA FLEXIBLE/ INCOME BONDS

3 years ended 31 May 2025**




**Excess Return vs Tracking Error
5 years ended 31 May 2025**




RETAIL BOND SURVEY - SA INCLUDING GLOBAL FLEXIBLE/ INCOME BONDS








Risk vs Return
10 years ended 31 May 2025




DECATHLON RETAIL BOND - SA FLEXIBLE/ INCOME BONDS

7 years ended 31 May 2025



10 years ended 31 May 2025




DECATHLON RETAIL BOND - SA INCL GLOBAL FLEXIBLE/ INCOME BONDS
