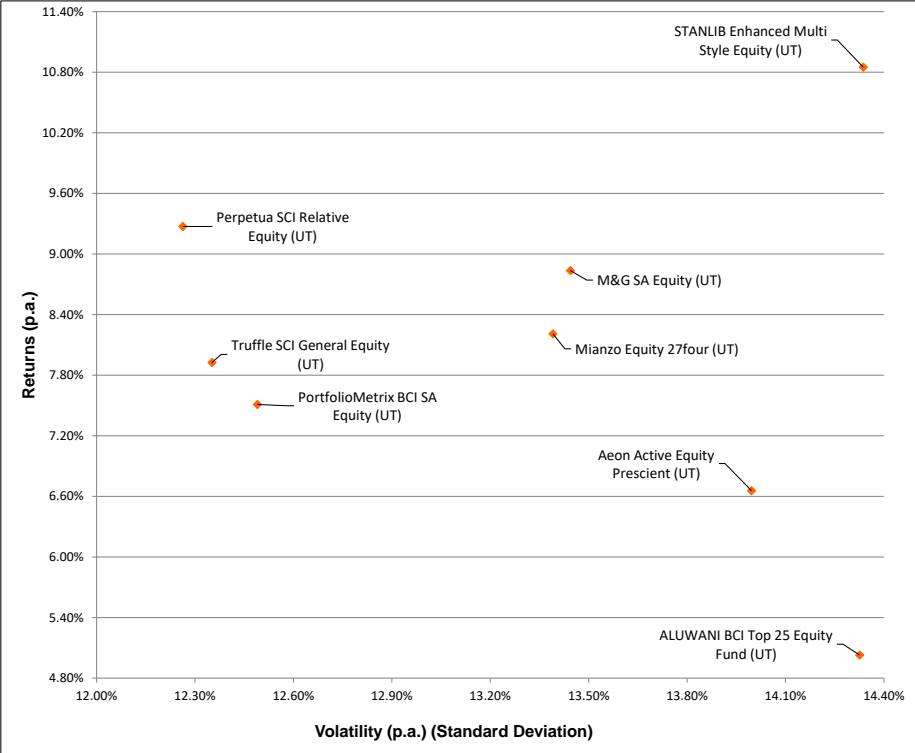

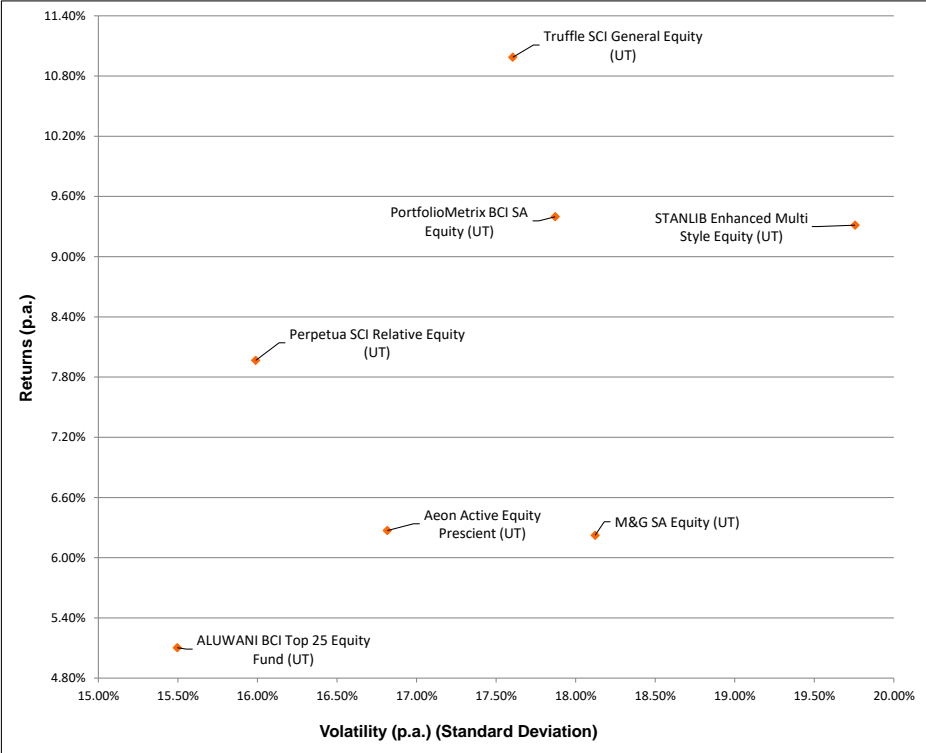

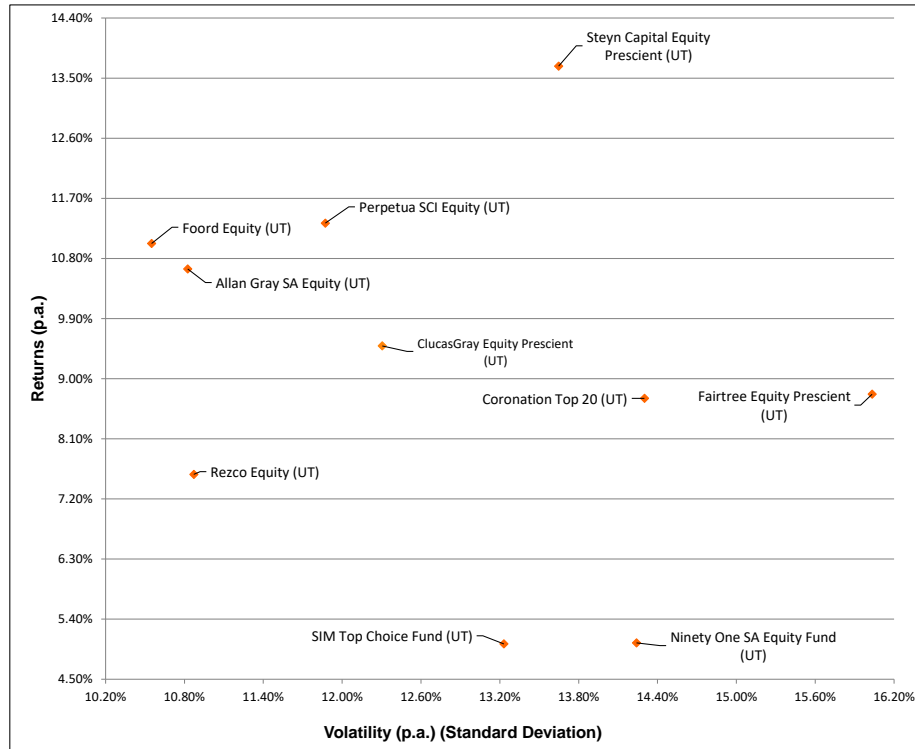


Risk vs Return
5 years ended 30 April 2024

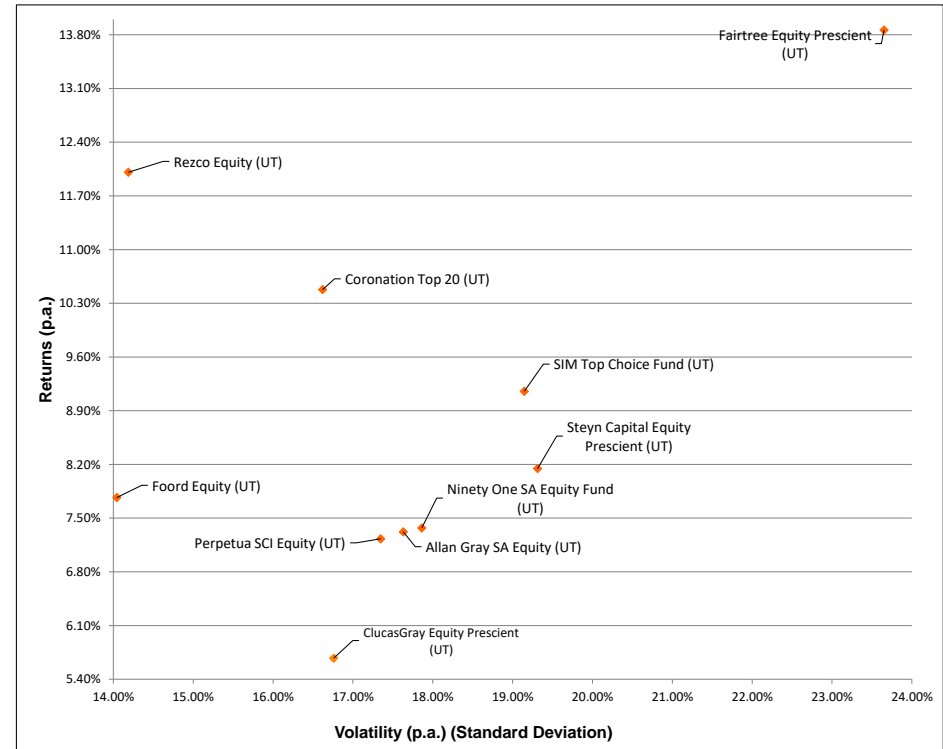


RETAIL EQUITY SURVEY - SA ONLY NON BENCHMARK COGNISANT

3 years ended 30 April 2024

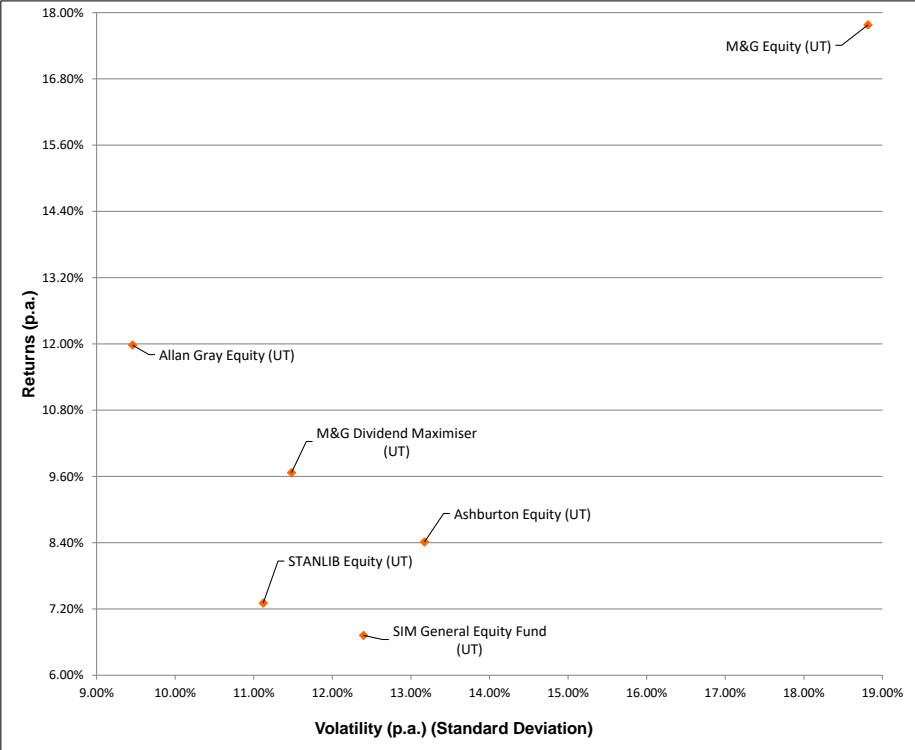


Risk vs Return
5 years ended 30 April 2024

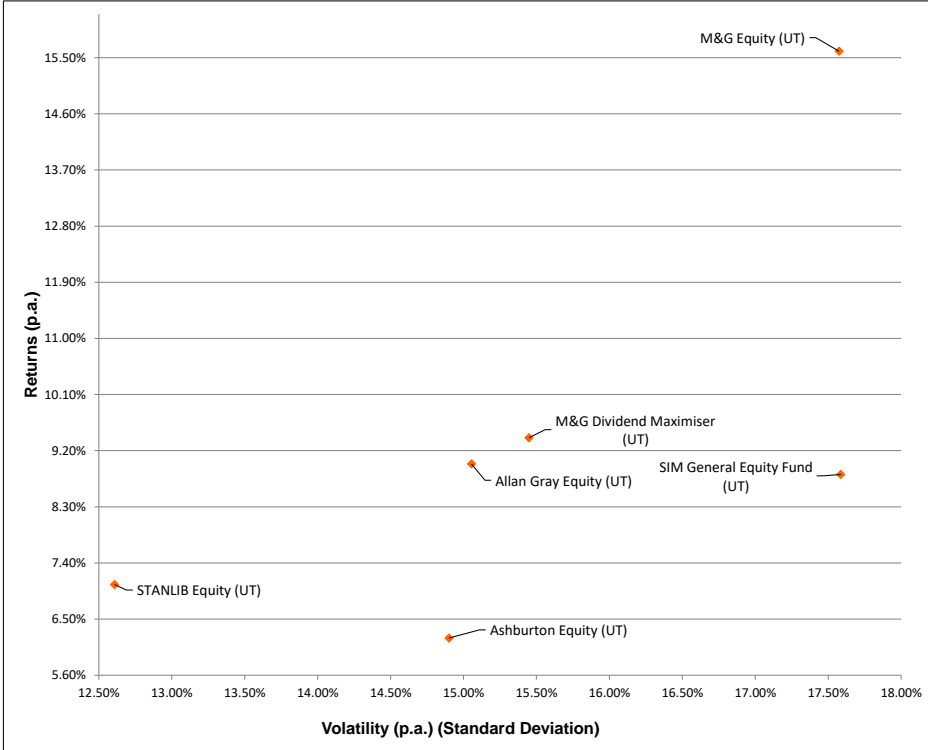


RETAIL EQUITY SURVEY - SA INCL GLOBAL BENCHMARK COGNISANT

3 years ended 30 April 2024

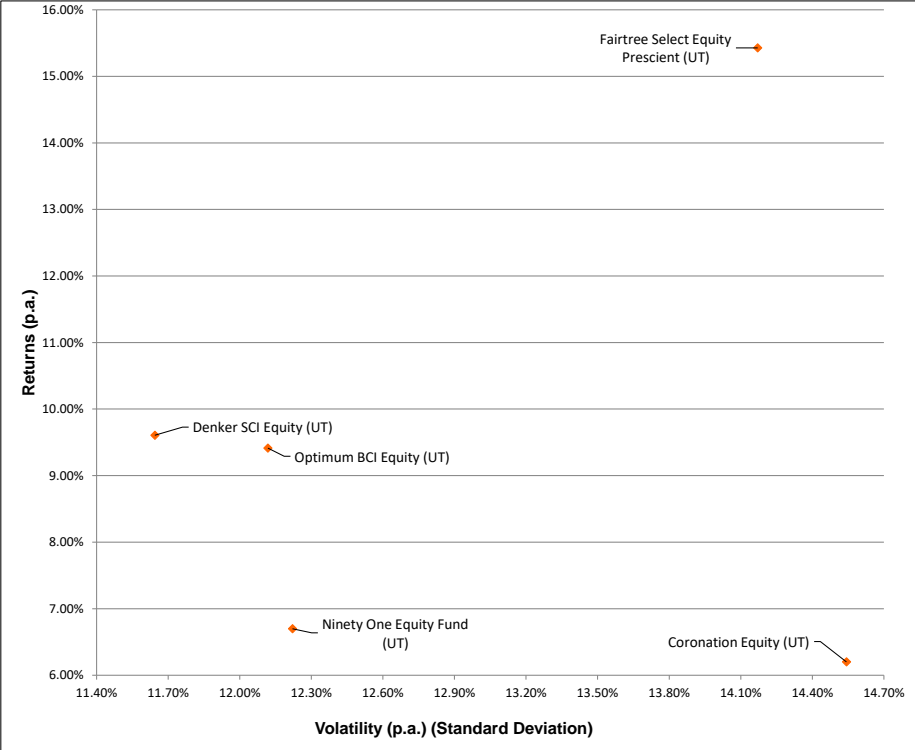


Risk vs Return
5 years ended 30 April 2024

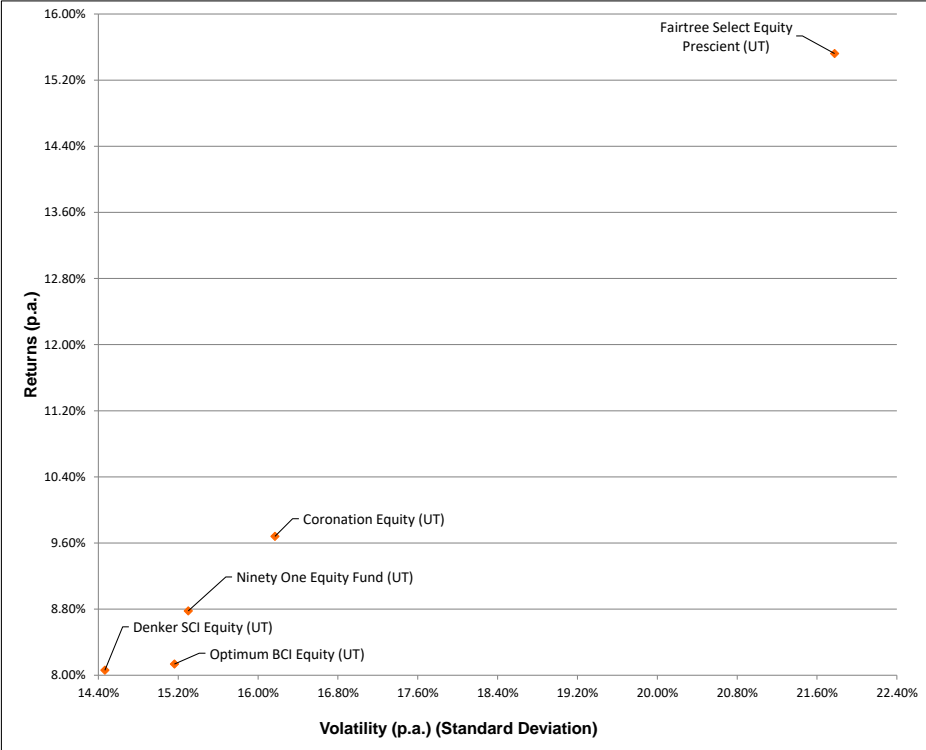


RETAIL EQUITY SURVEY - SA INCL GLOBAL NON BENCHMARK COGNISANT

3 years ended 30 April 2024

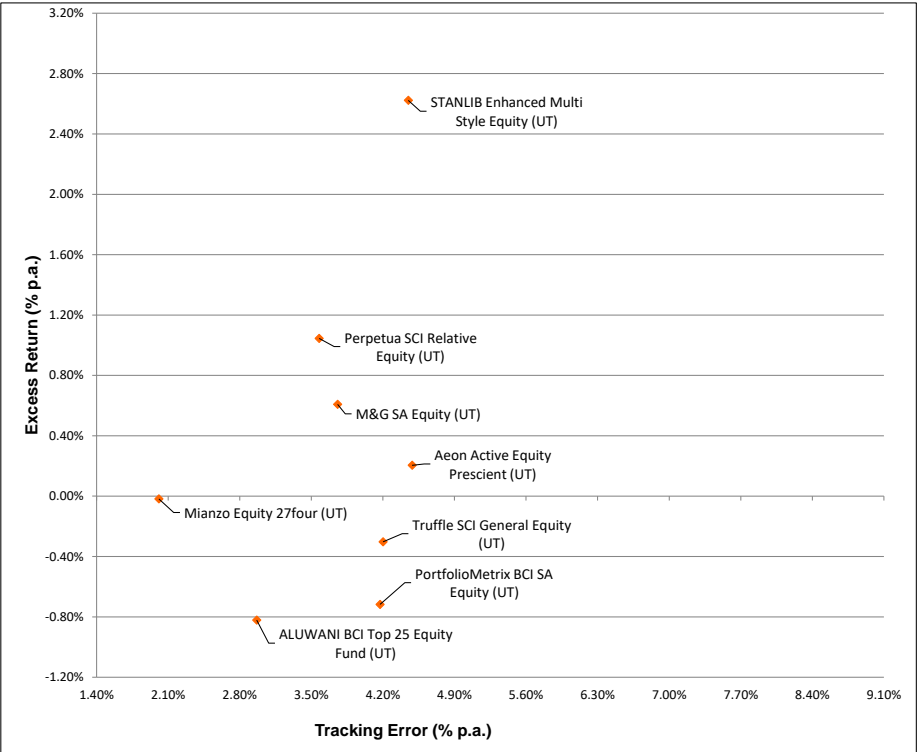


Risk vs Return
5 years ended 30 April 2024

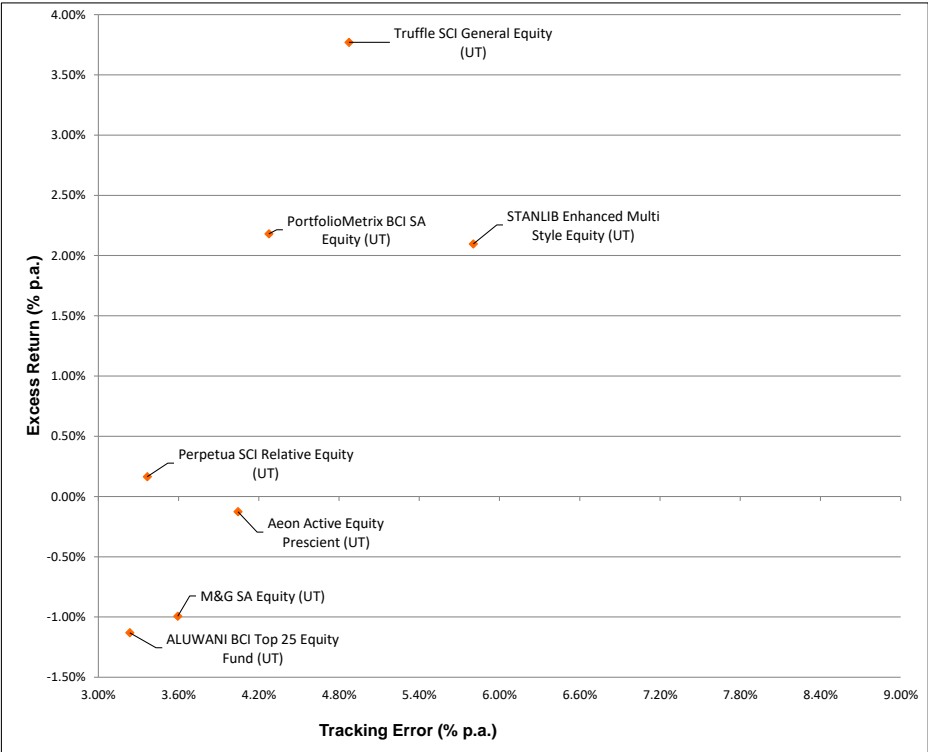


RETAIL EQUITY SURVEY - SA ONLY BENCHMARK COGNISANT

3 years ended 30 April 2024

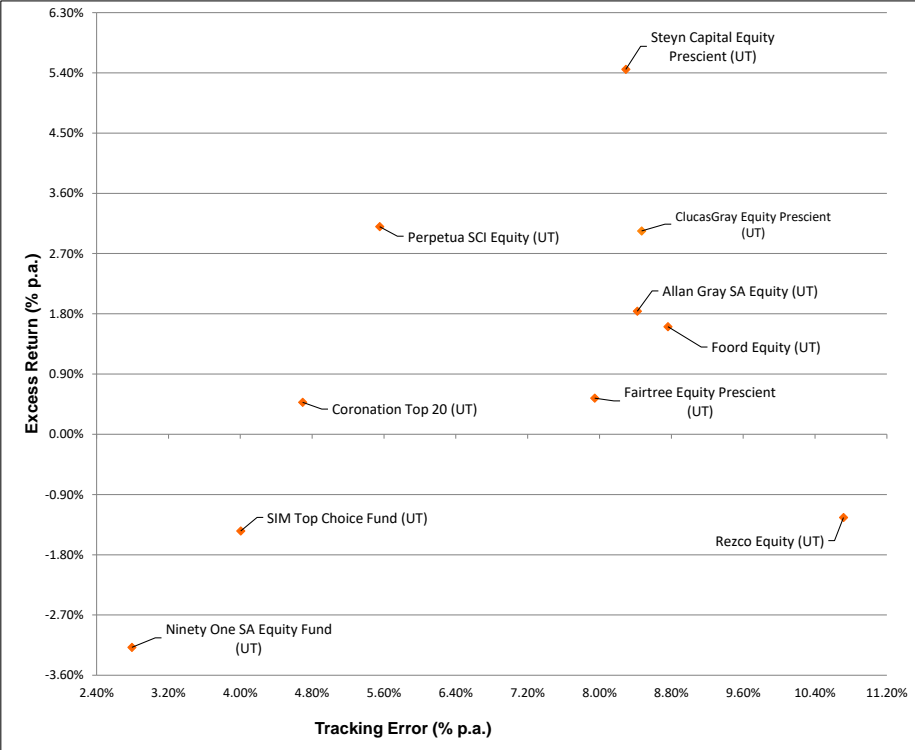


Excess Return vs Tracking Error
5 years ended 30 April 2024

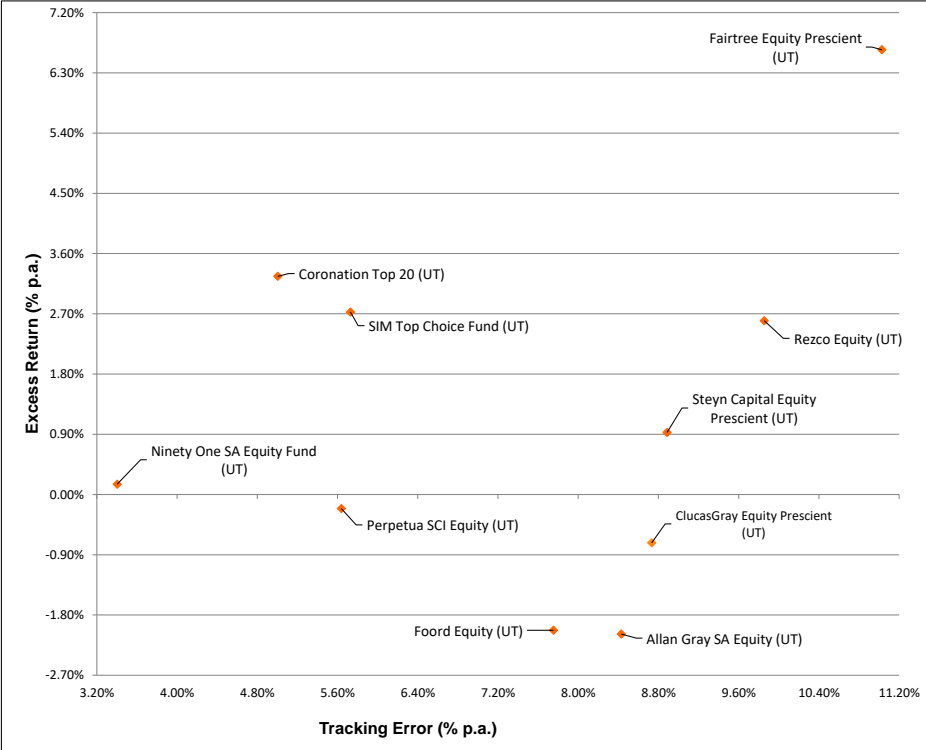


RETAIL EQUITY SURVEY - SA ONLY NON BENCHMARK COGNISANT

3 years ended 30 April 2024

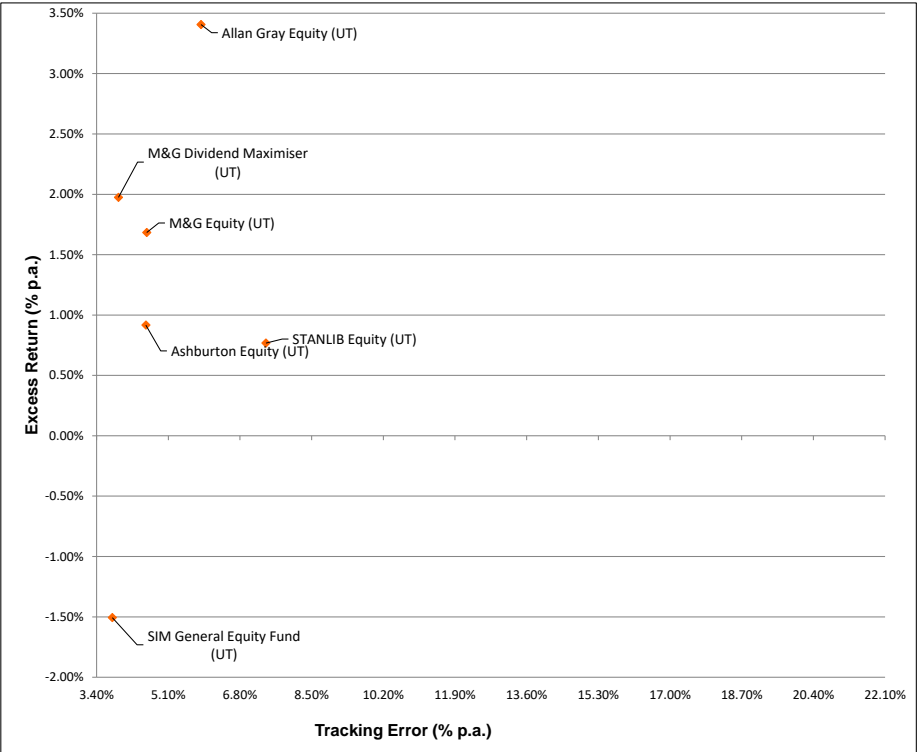


Excess Return vs Tracking Error
5 years ended 30 April 2024

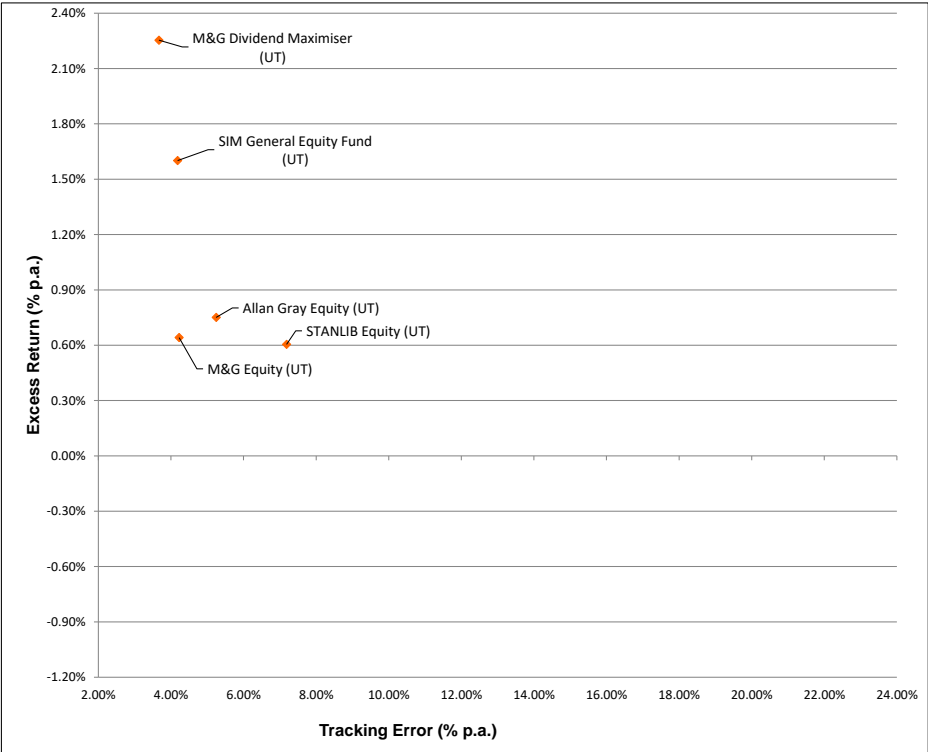


RETAIL EQUITY SURVEY - SA INCL GLOBAL BENCHMARK COGNISANT

3 years ended 30 April 2024

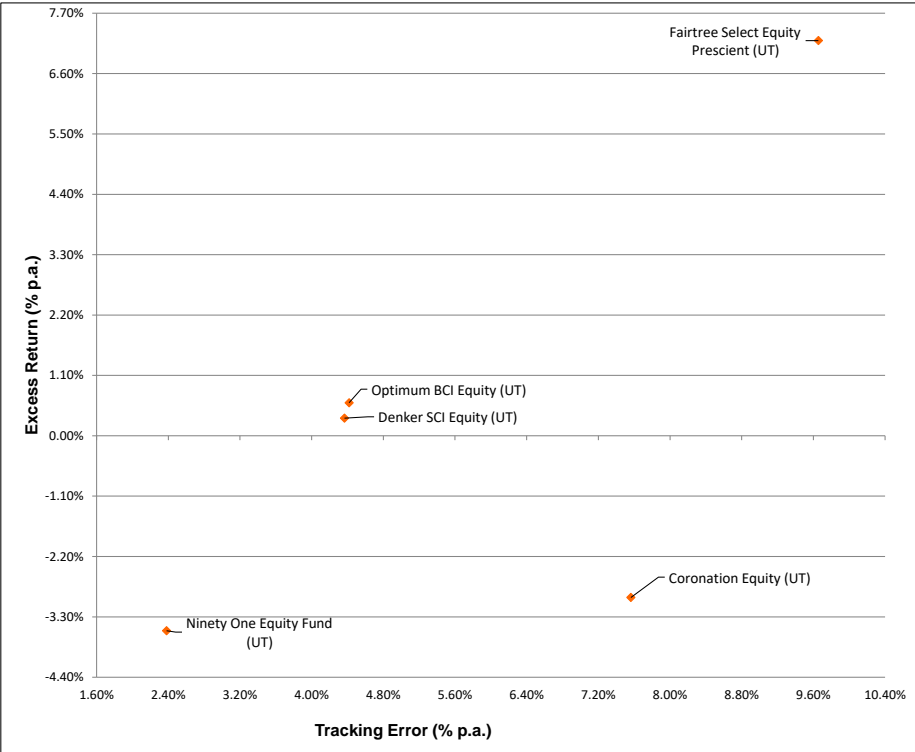


Excess Return vs Tracking Error
5 years ended 30 April 2024

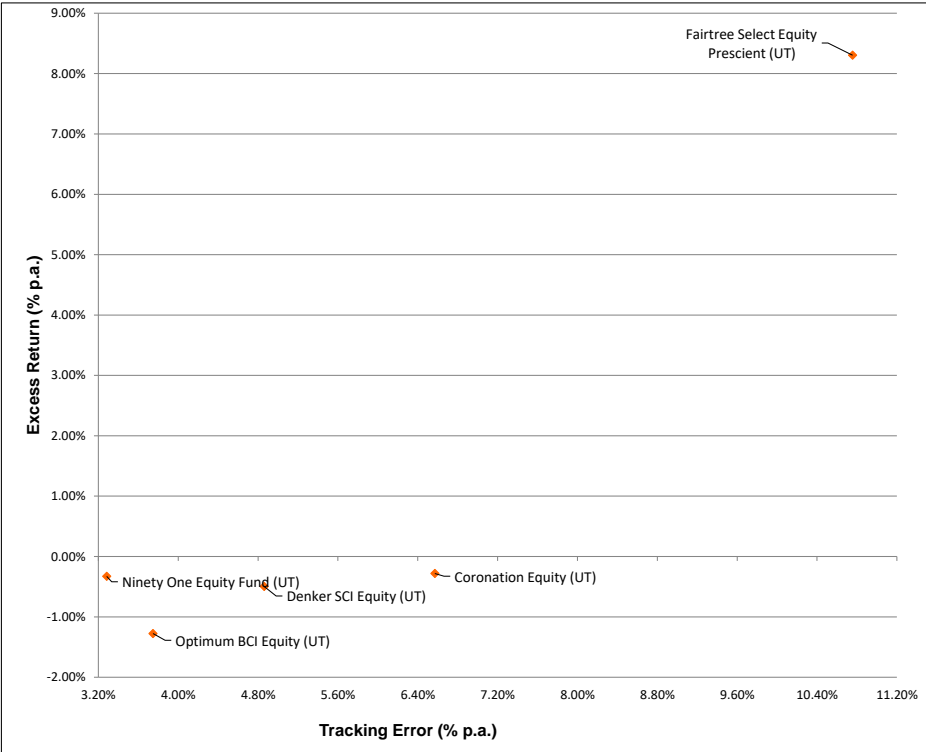

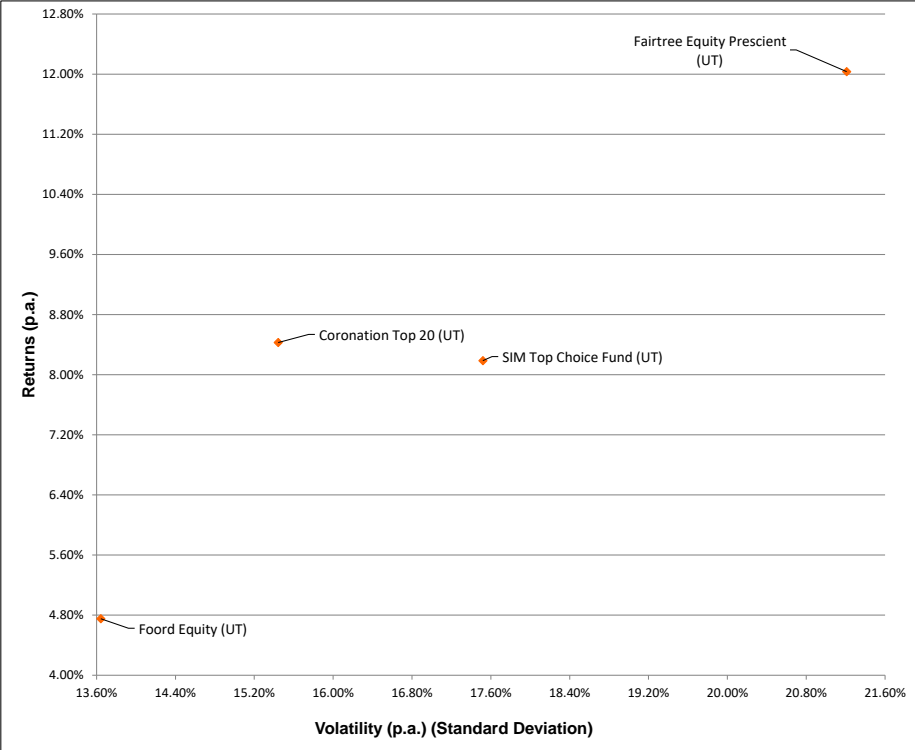


Risk vs Return
10 years ended 30 April 2024

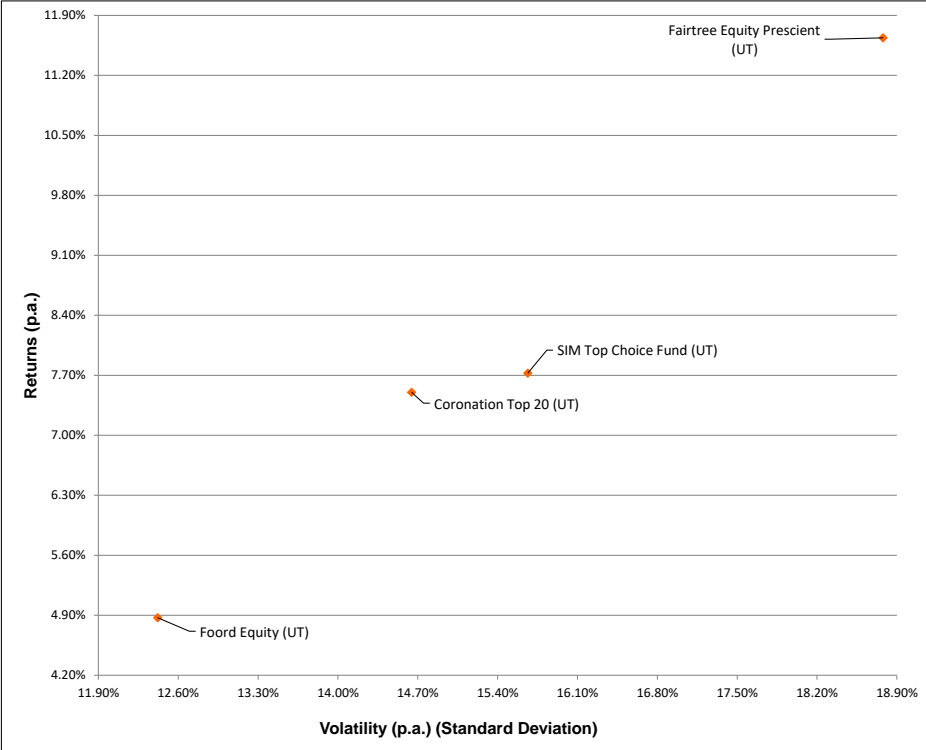


DECATHLON RETAIL EQUITY - SA ONLY NON BENCHMARK COGNISANT

7 years ended 30 April 2024

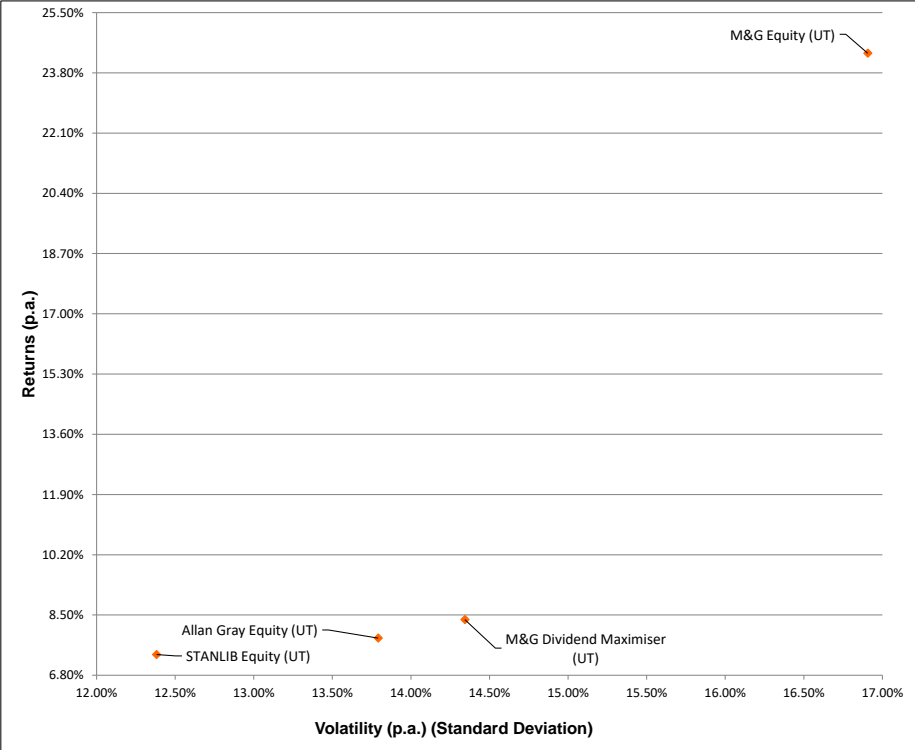


Risk vs Return
10 years ended 30 April 2024

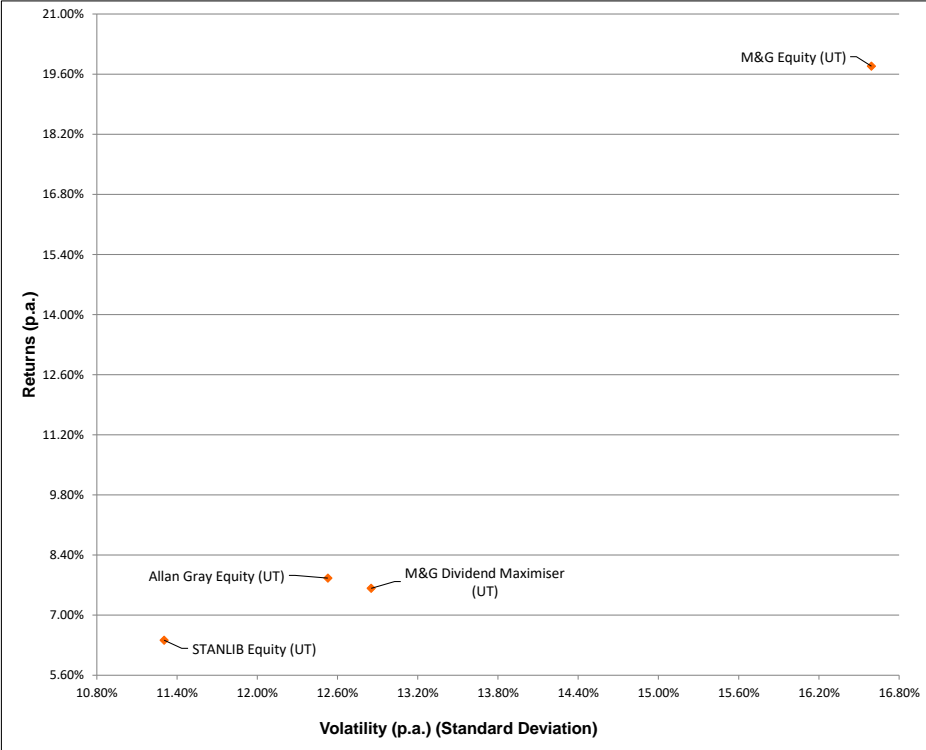


DECATHLON RETAIL EQUITY - SA INCL GLOBAL BENCHMARK COGNISANT

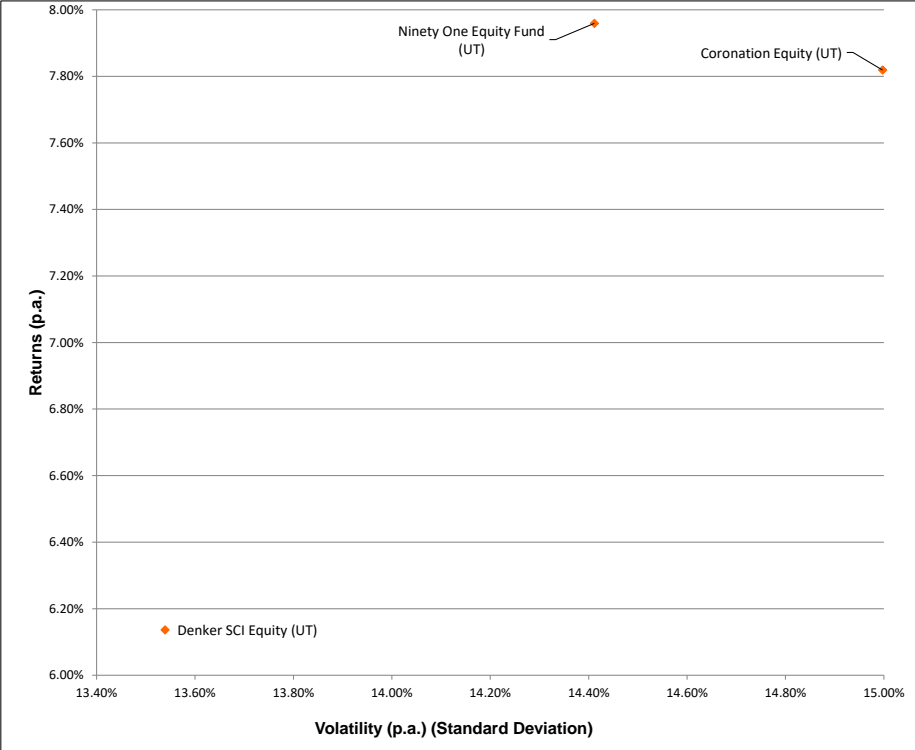


Risk vs Return
10 years ended 30 April 2024

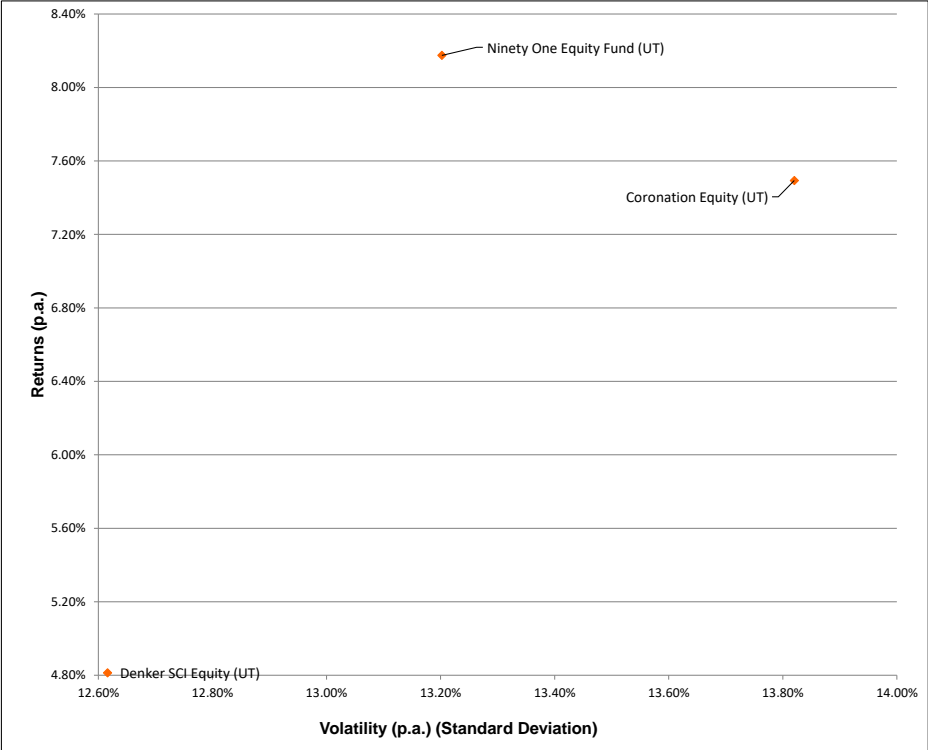


DECATHLON RETAIL EQUITY - SA INCL GLOBAL NON BENCHMARK COGNISANT
