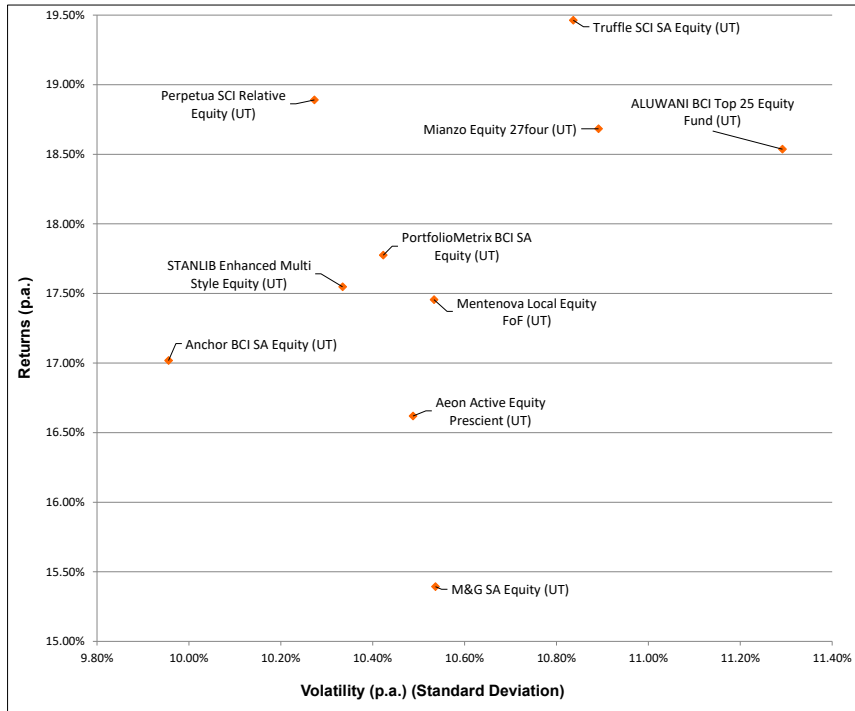

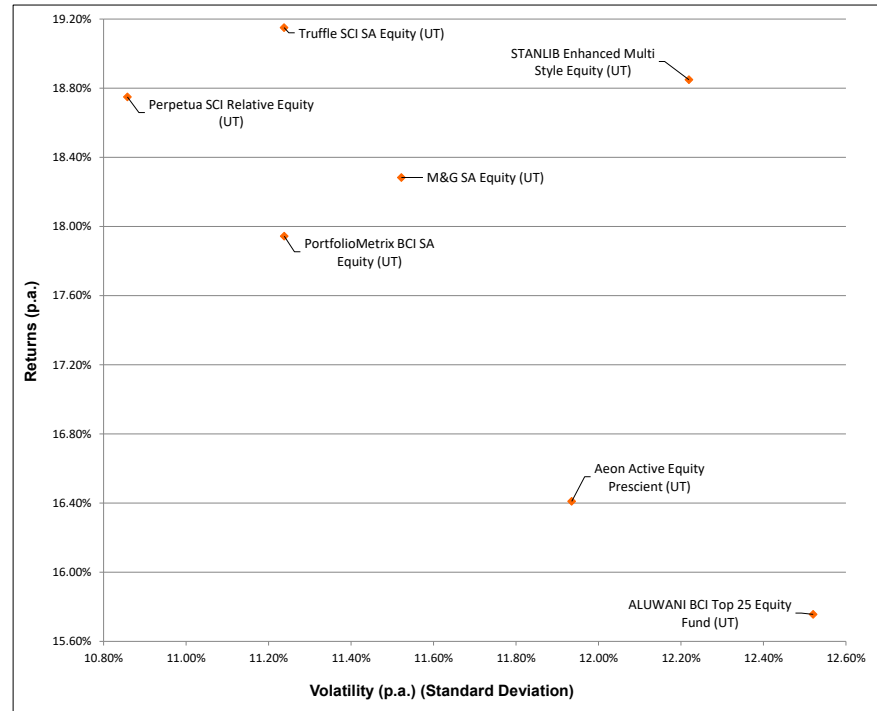

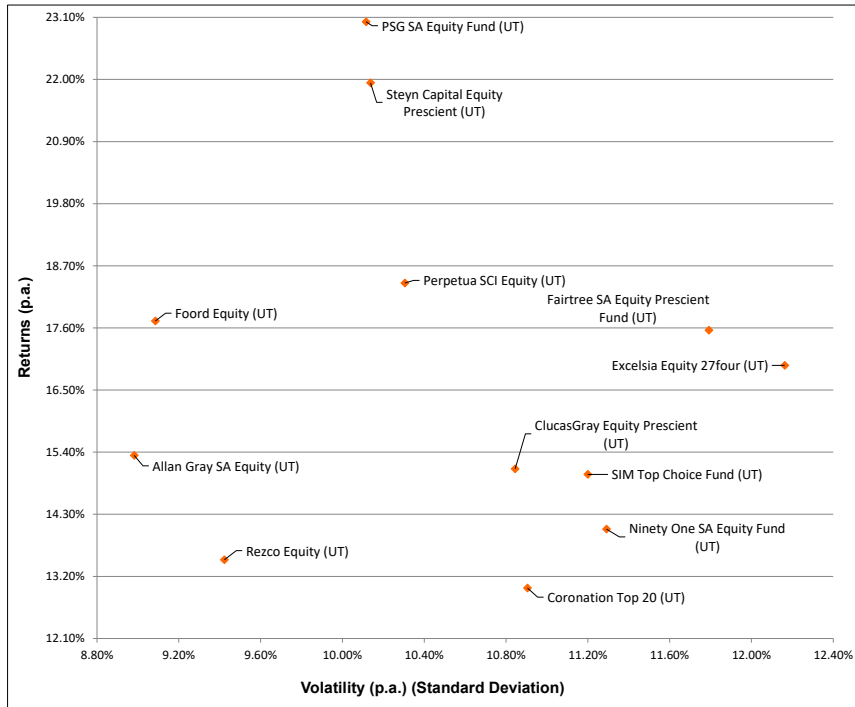


Risk vs Return
5 years ended 31 January 2026

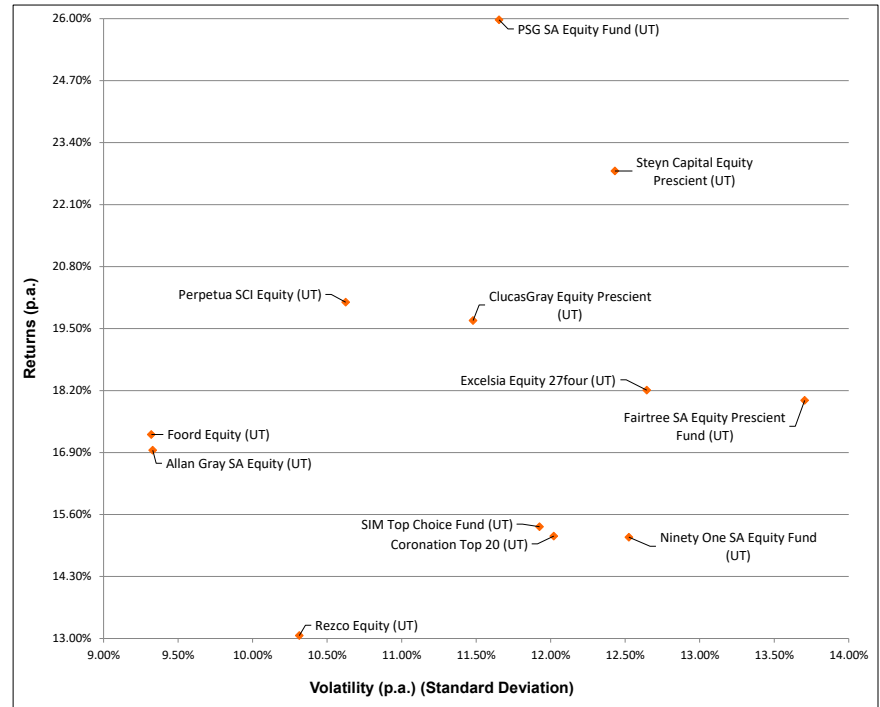


RETAIL EQUITY SURVEY - SA ONLY NON BENCHMARK COGNISANT

3 years ended 31 January 2026

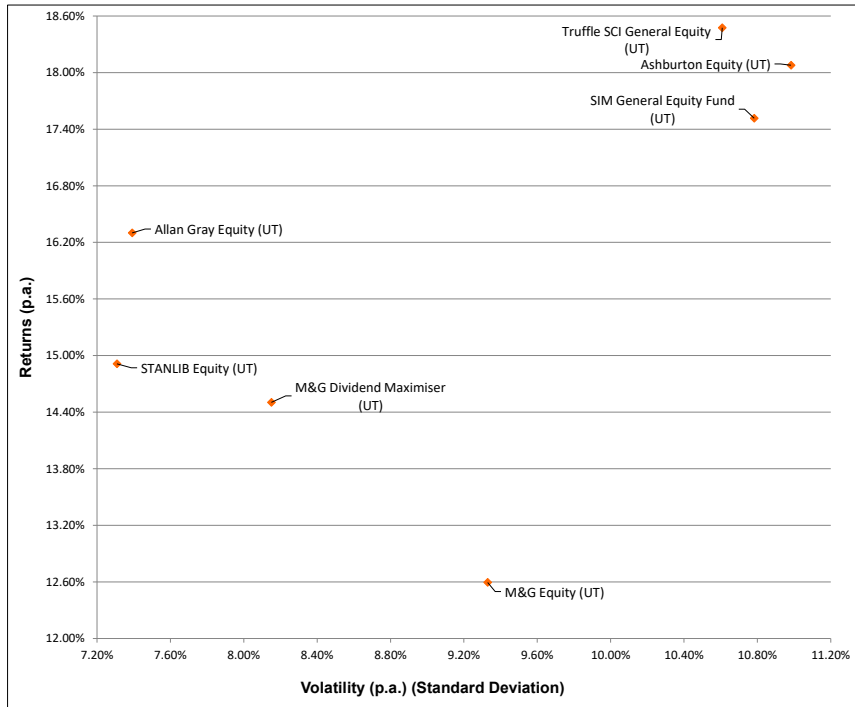


Risk vs Return
5 years ended 31 January 2026

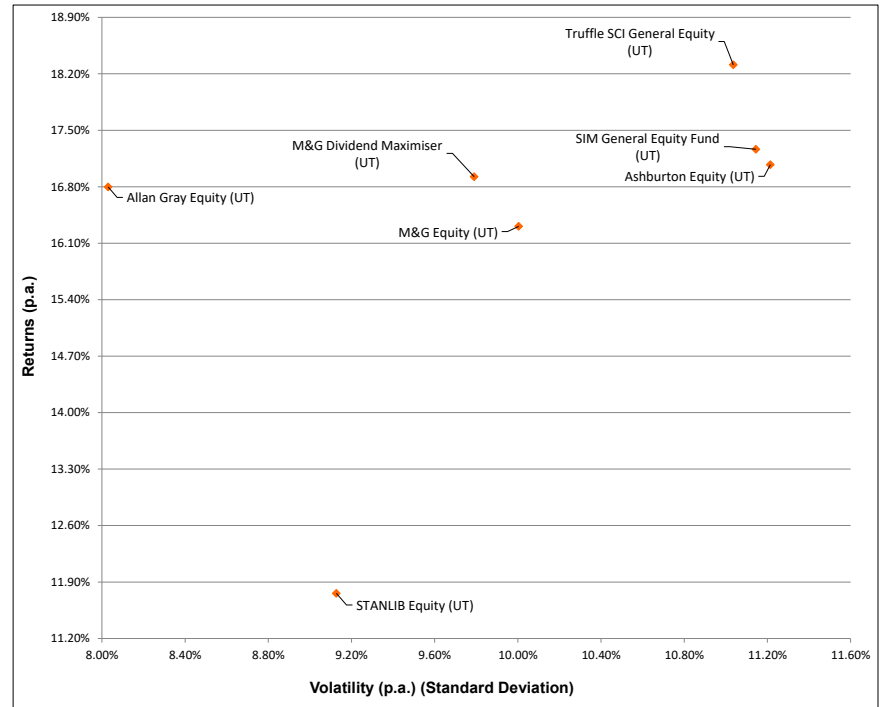


RETAIL EQUITY SURVEY - SA INCL GLOBAL BENCHMARK COGNISANT

3 years ended 31 January 2026

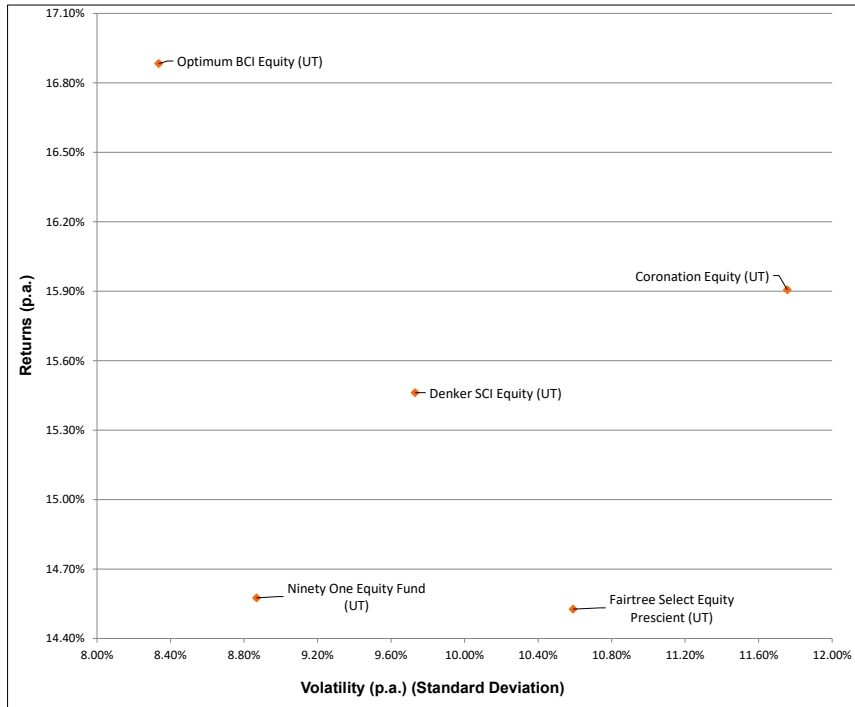


Risk vs Return
5 years ended 31 January 2026

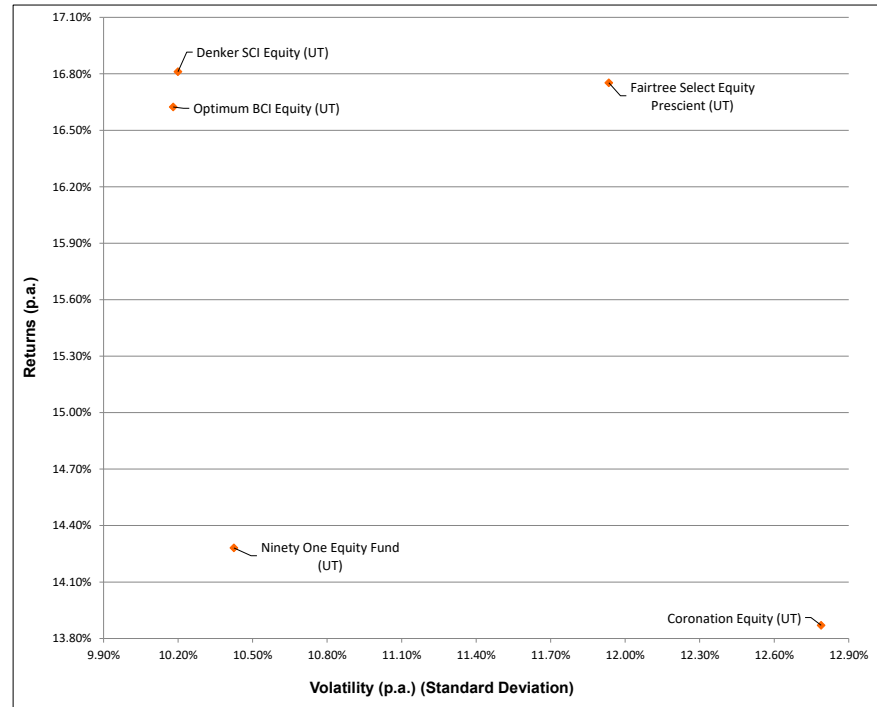


RETAIL EQUITY SURVEY - SA INCL GLOBAL NON BENCHMARK COGNISANT

3 years ended 31 January 2026

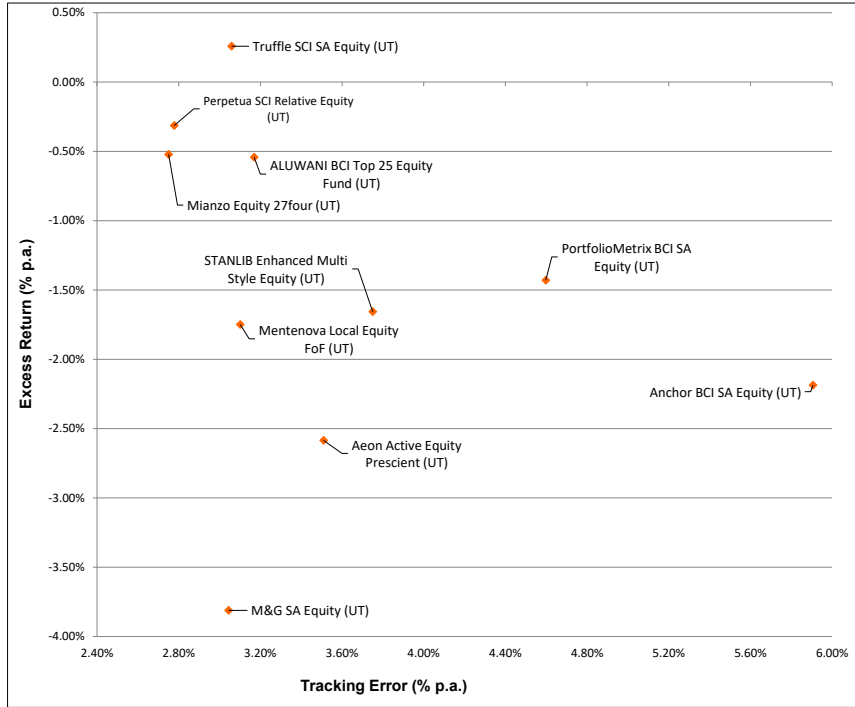

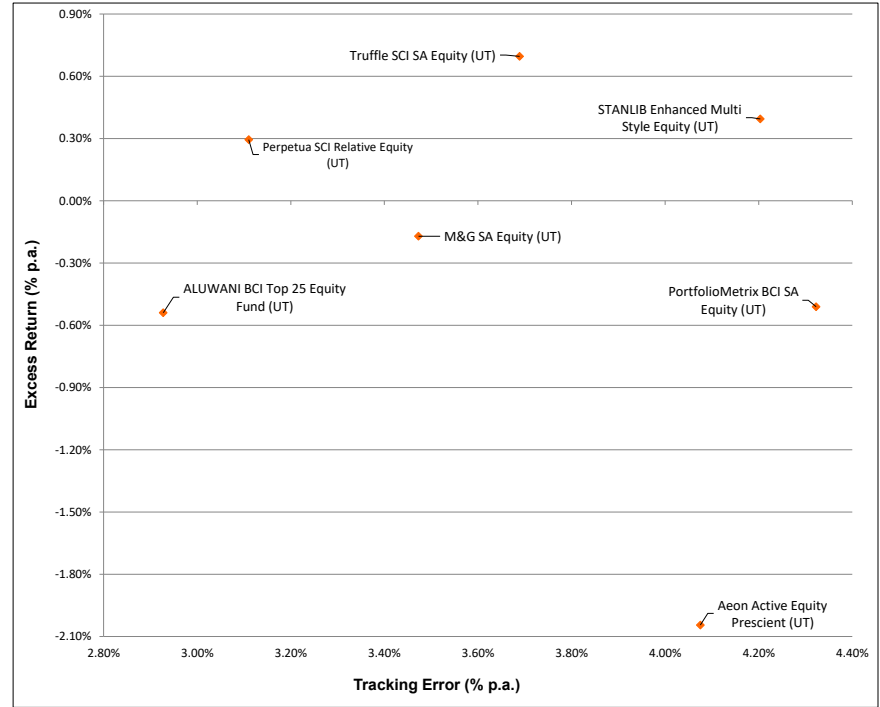


RETAIL EQUITY SURVEY - SA ONLY BENCHMARK COGNISANT

3 years ended 31 January 2026**

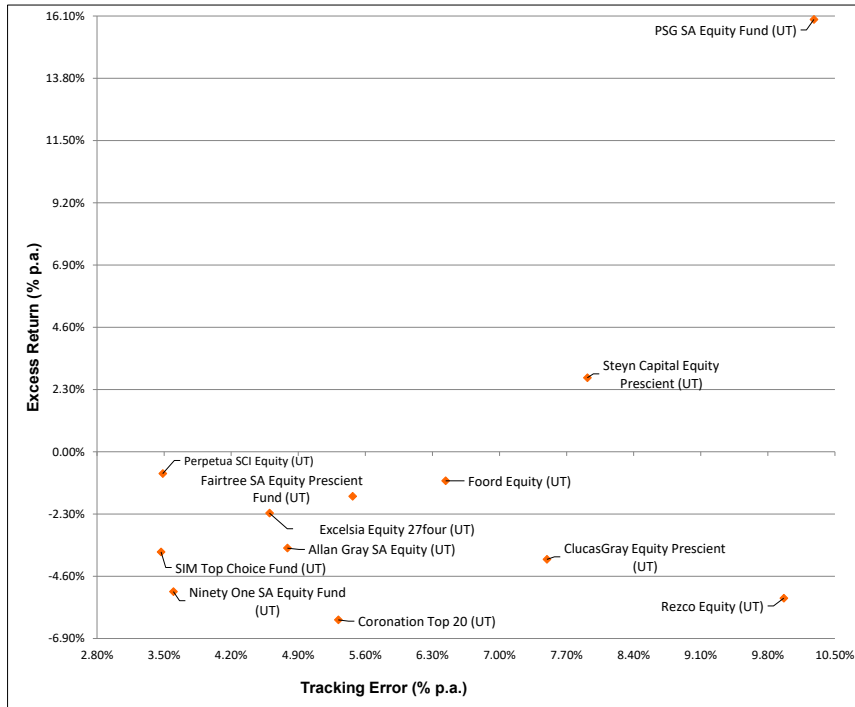


**Excess Return vs Tracking Error
5 years ended 31 January 2026**

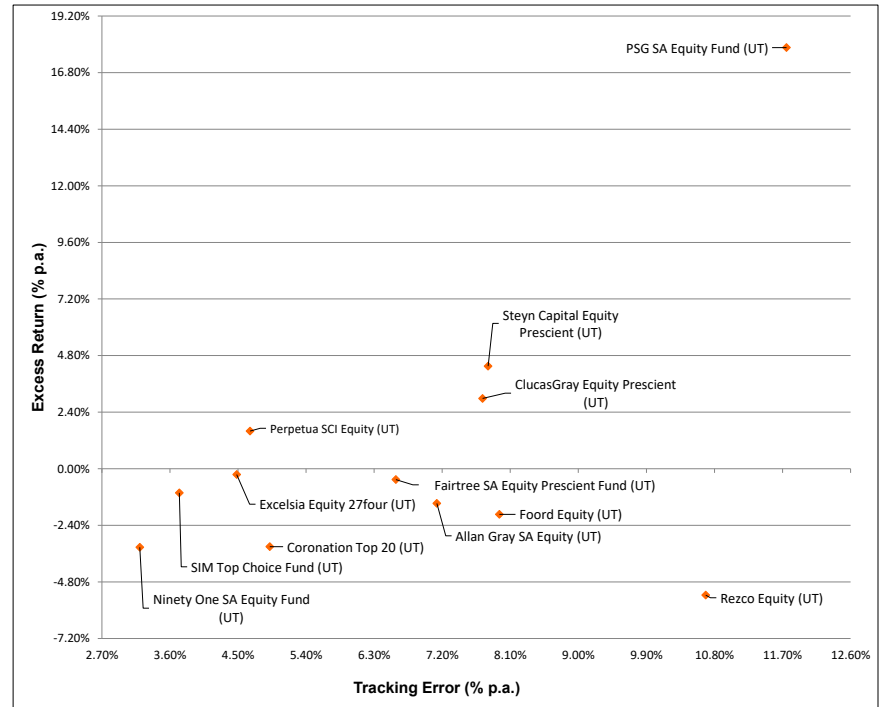


RETAIL EQUITY SURVEY - SA ONLY NON BENCHMARK COGNISANT

3 years ended 31 January 2026**

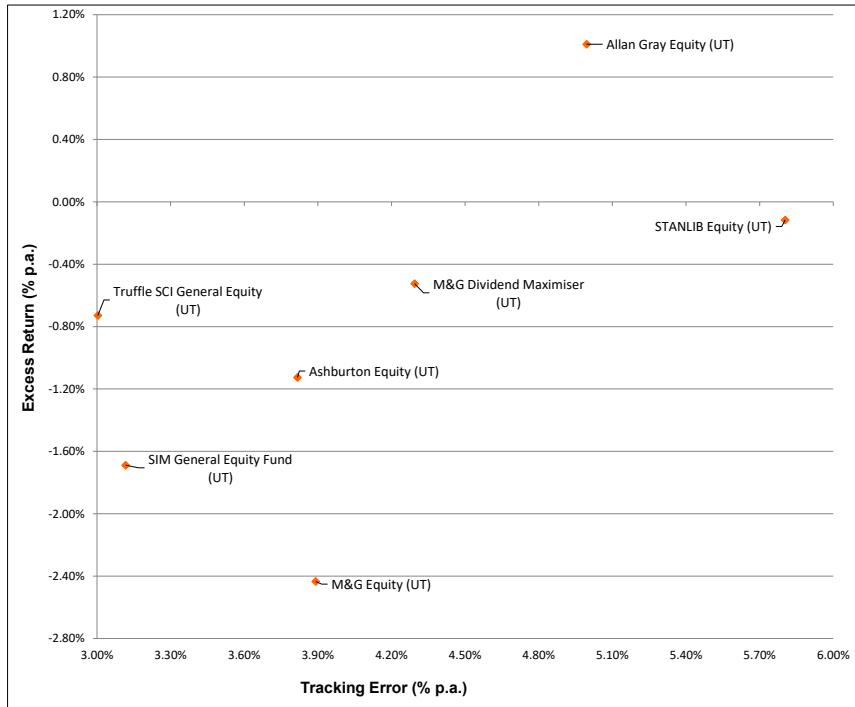


**Excess Return vs Tracking Error
5 years ended 31 January 2026**

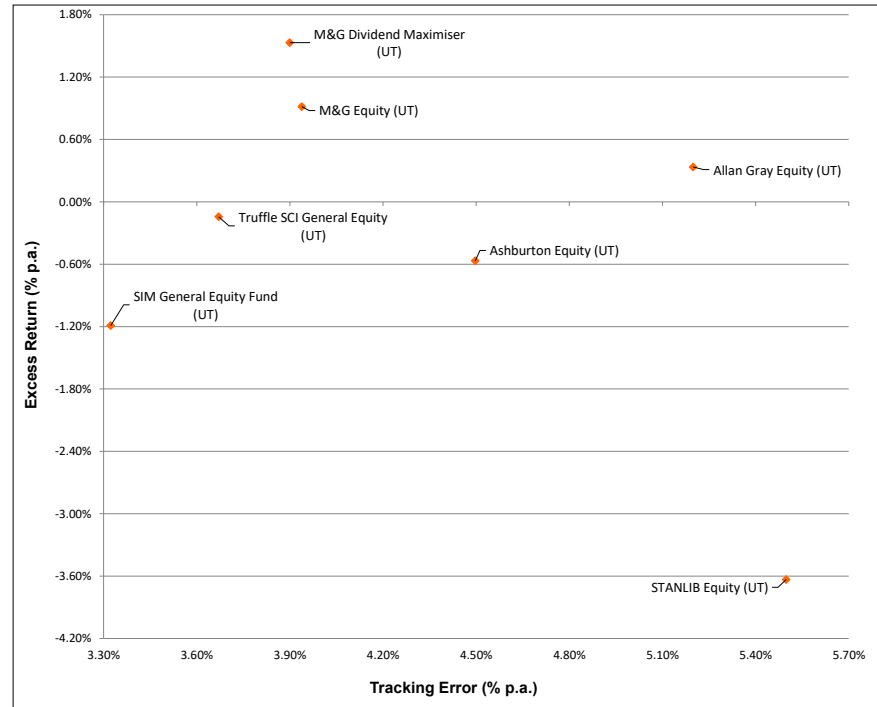


RETAIL EQUITY SURVEY - SA INCL GLOBAL BENCHMARK COGNISANT

3 years ended 31 January 2026**

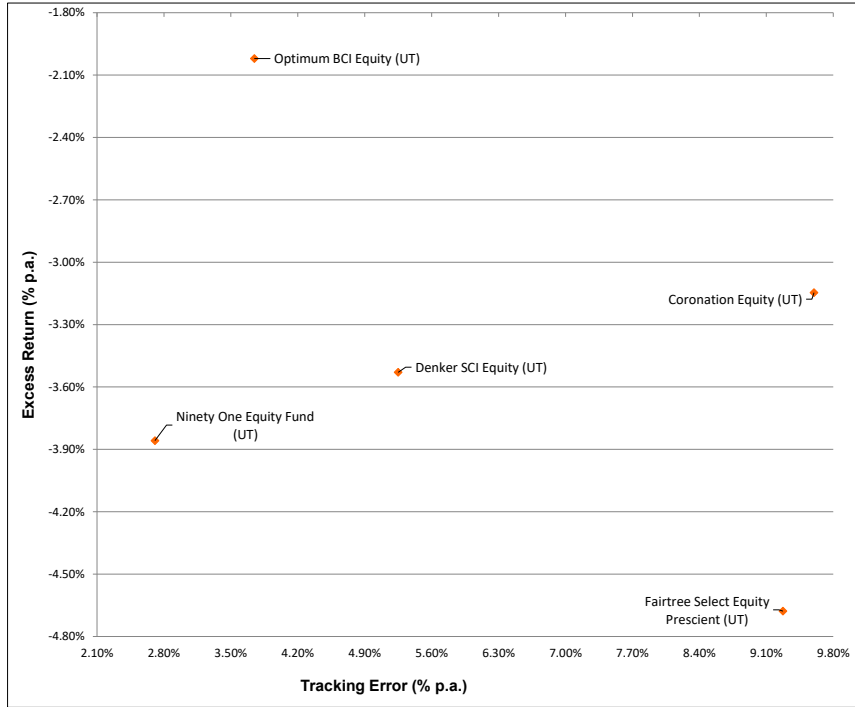


**Excess Return vs Tracking Error
5 years ended 31 January 2026**

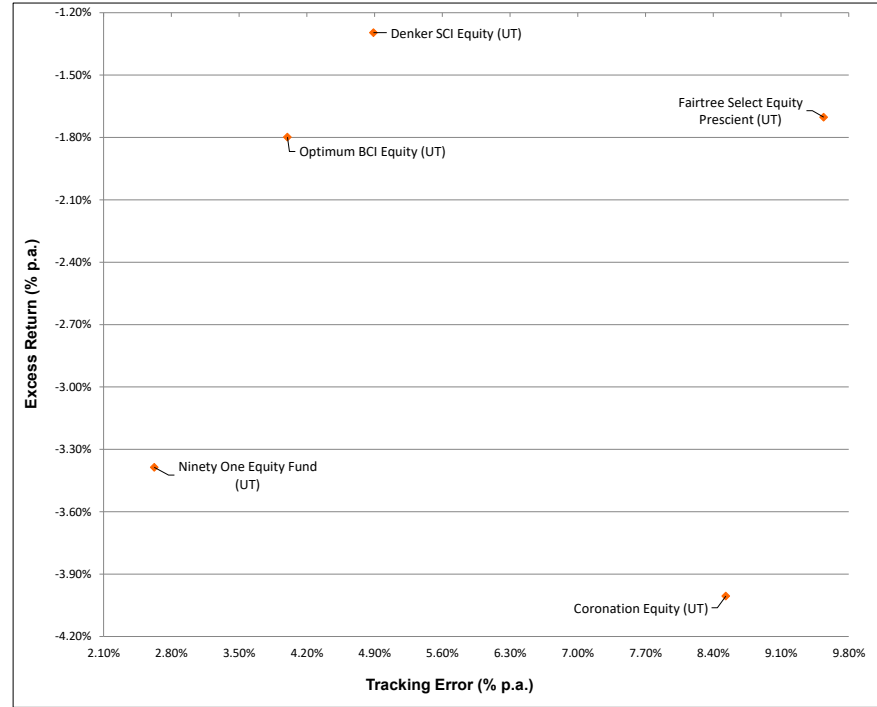

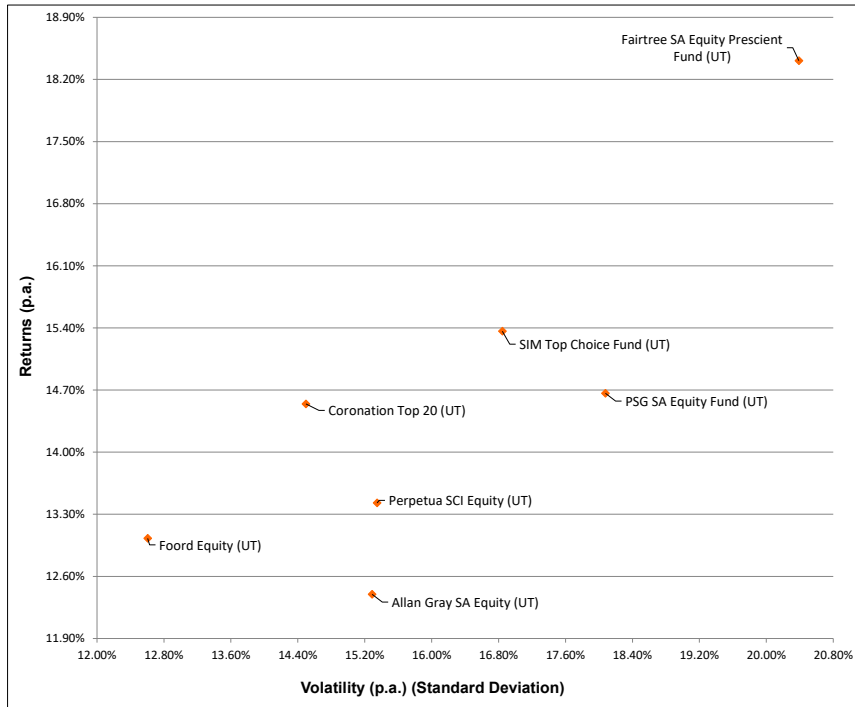


Risk vs Return
10 years ended 31 January 2026

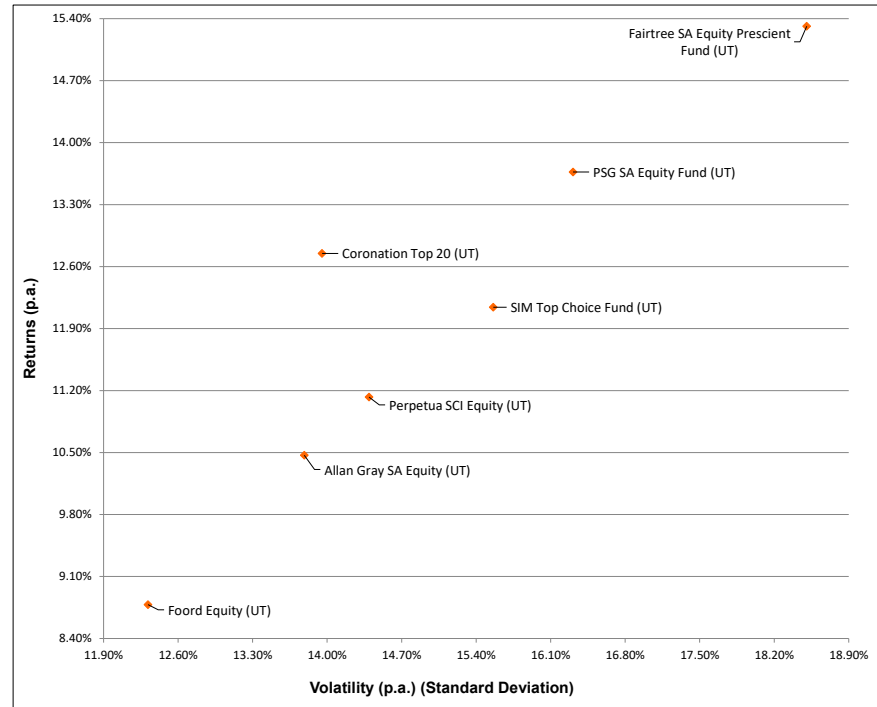


DECATHLON RETAIL EQUITY - SA ONLY NON BENCHMARK COGNISANT

7 years ended 31 January 2026

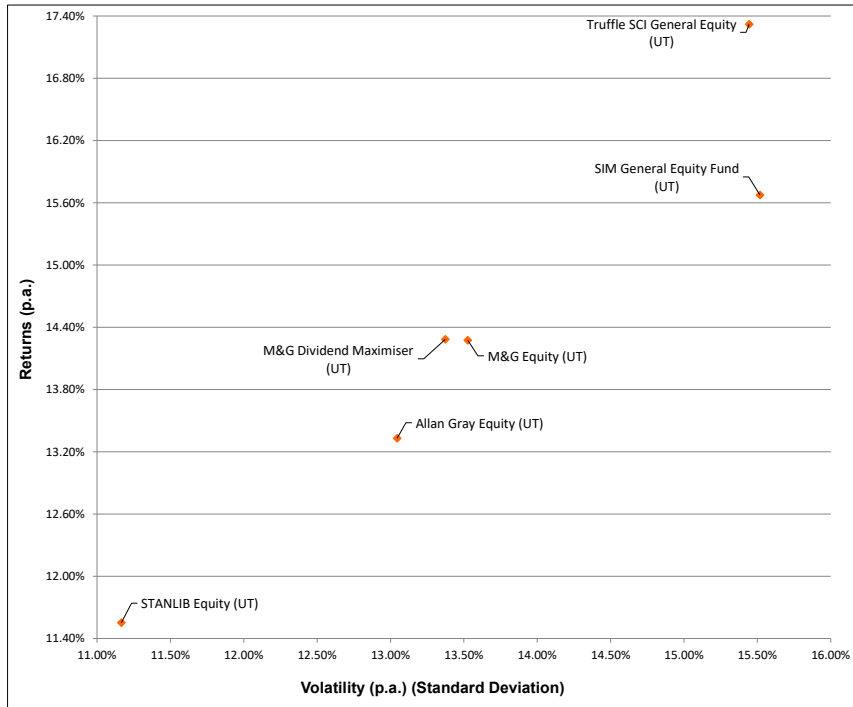

10 years ended 31 January 2026

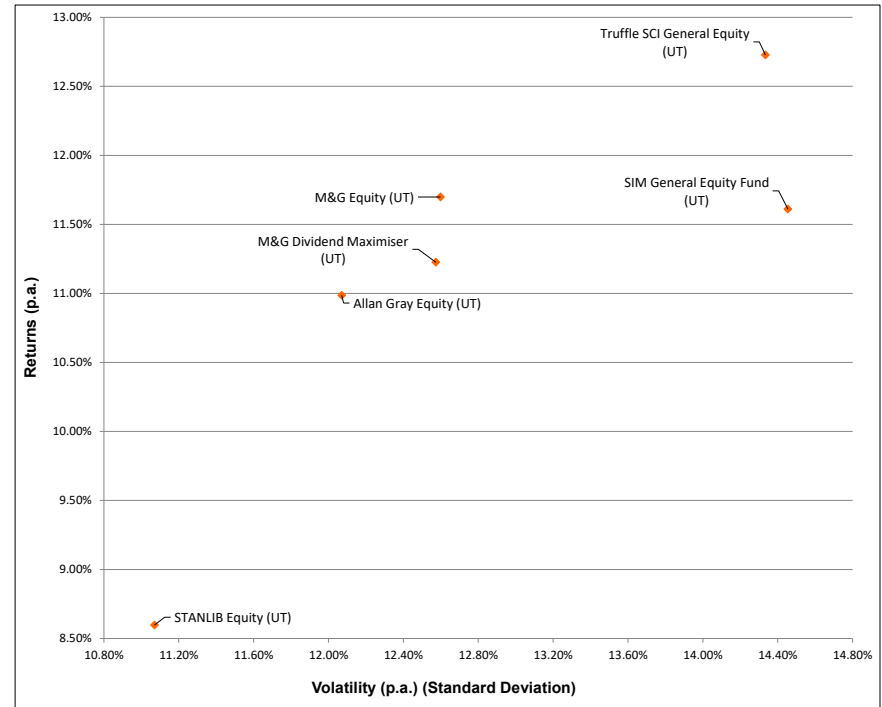


DECATHLON RETAIL EQUITY - SA INCL GLOBAL BENCHMARK COGNISANT

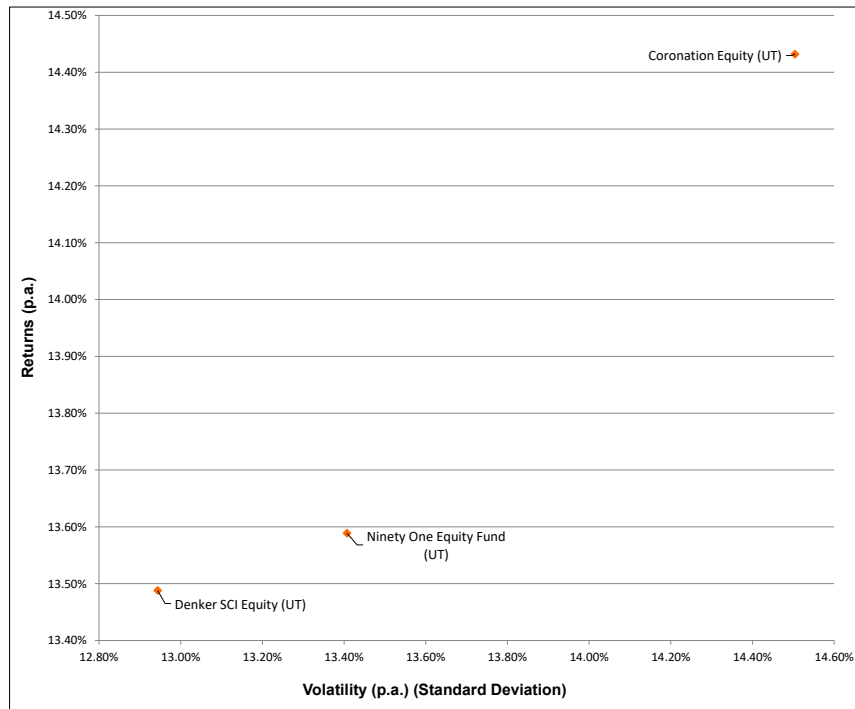

10 years ended 31 January 2026

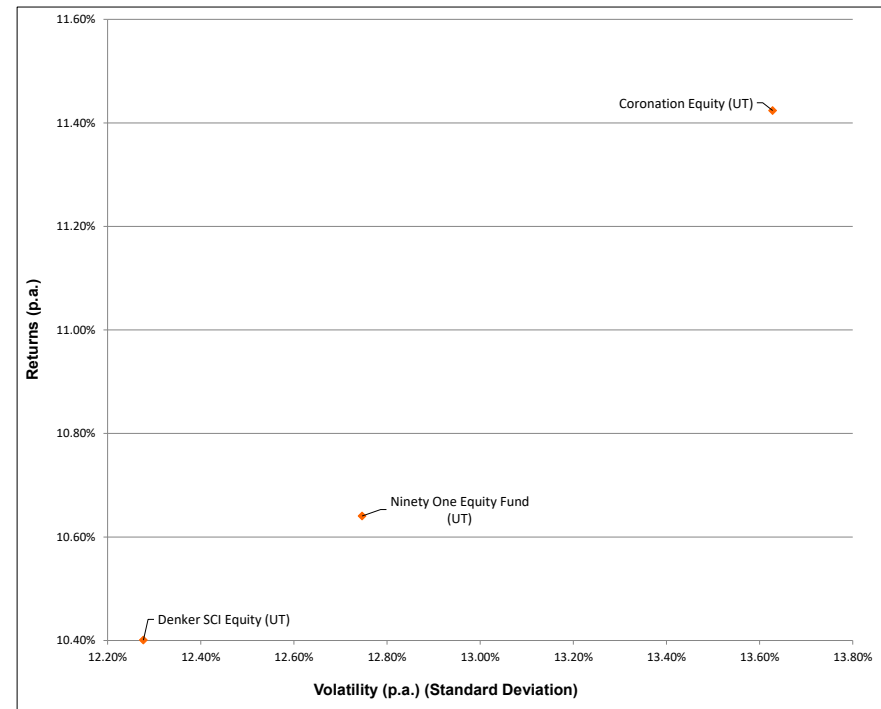


DECATHLON RETAIL EQUITY - SA INCL GLOBAL NON BENCHMARK COGNISANT
