


Risk vs Return 3 years ended 31 July 2024






Excess Return vs Tracking Error 3 years ended 31 July 2024




Risk vs Return 7 years ended 31 July 2024

## **DECATHLON RETAIL EQUITY - SA ONLY NON BENCHMARK COGNISANT**




