






Risk vs Return  
5 years ended 30 June 2024



3 years ended 30 June 2024




Risk vs Return  
5 years ended 30 June 2024




# RETAIL EQUITY SURVEY - SA INCL GLOBAL BENCHMARK COGNISANT

3 years ended 30 June 2024




Risk vs Return  
5 years ended 30 June 2024




# RETAIL EQUITY SURVEY - SA INCL GLOBAL NON BENCHMARK COGNISANT

3 years ended 30 June 2024




Risk vs Return  
5 years ended 30 June 2024




# RETAIL EQUITY SURVEY - SA ONLY BENCHMARK COGNISANT

3 years ended 30 June 2024




Excess Return vs Tracking Error  
5 years ended 30 June 2024




# RETAIL EQUITY SURVEY - SA ONLY NON BENCHMARK COGNISANT

3 years ended 30 June 2024




Excess Return vs Tracking Error  
5 years ended 30 June 2024



3 years ended 30 June 2024




Excess Return vs Tracking Error






Risk vs Return  
10 years ended 30 June 2024




# DECATHLON RETAIL EQUITY - SA ONLY NON BENCHMARK COGNISANT

7 years ended 30 June 2024



10 years ended 30 June 2024




# DECATHLON RETAIL EQUITY - SA INCL GLOBAL BENCHMARK COGNISANT

**7 years ended 30 June 2024**




**Risk vs Return**  
**10 years ended 30 June 2024**


