



3 years ended 31 December 2024




Risk vs Return
5 years ended 31 December 2024



3 years ended 31 December 2024




Risk vs Return
5 years ended 31 December 2024




RETAIL MONEY MARKET SURVEY - UP TO 90 DAYS

3 years ended 31 December 2024




Excess Return vs Tracking Error
5 years ended 31 December 2024







7 years ended 31 December 2024




Risk vs Return
10 years ended 31 December 2024




DECATHLON RETAIL MONEY MARKET - 91 TO 180 DAYS
