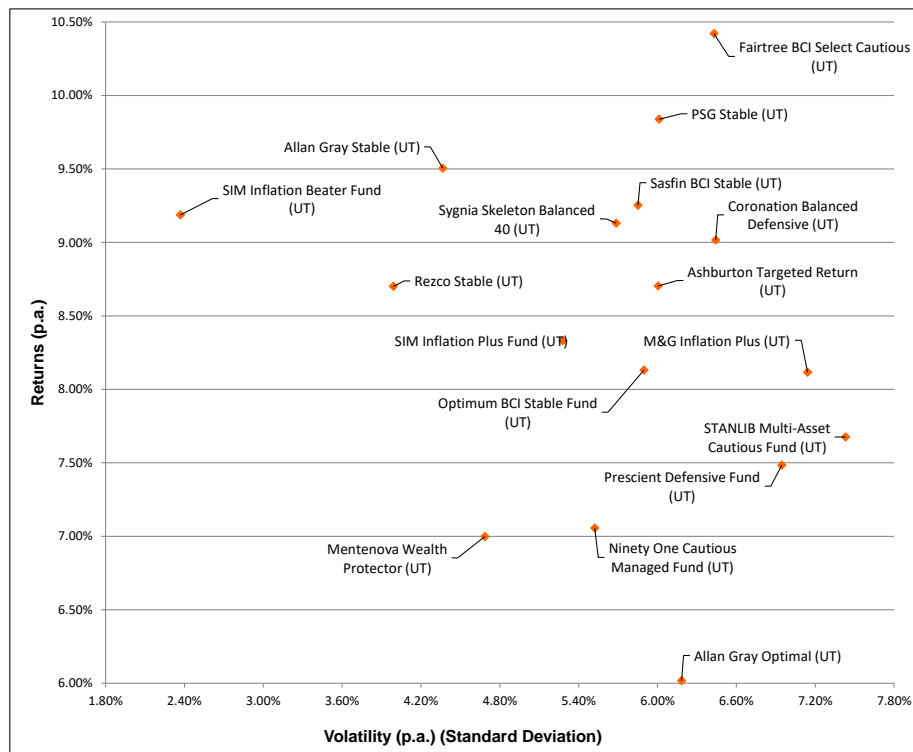

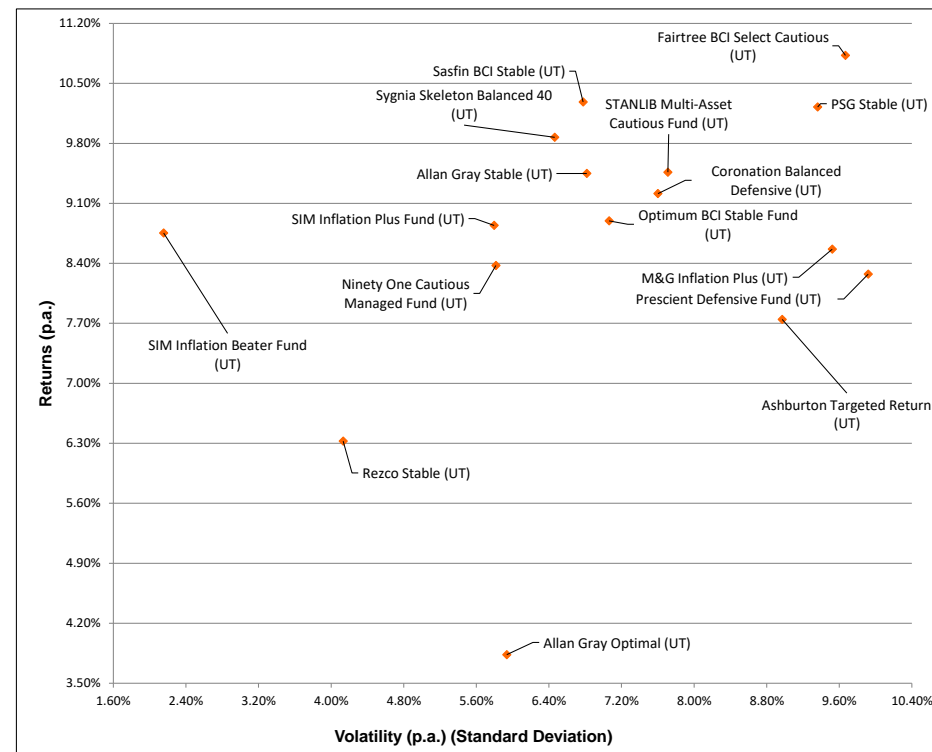

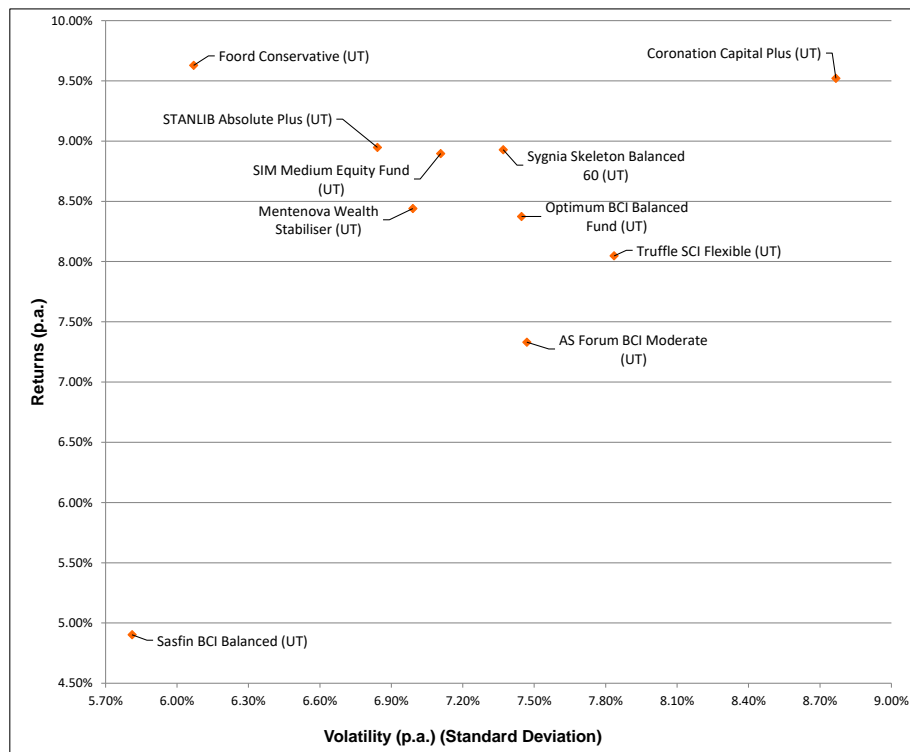


Risk vs Return
5 years ended 31 December 2024

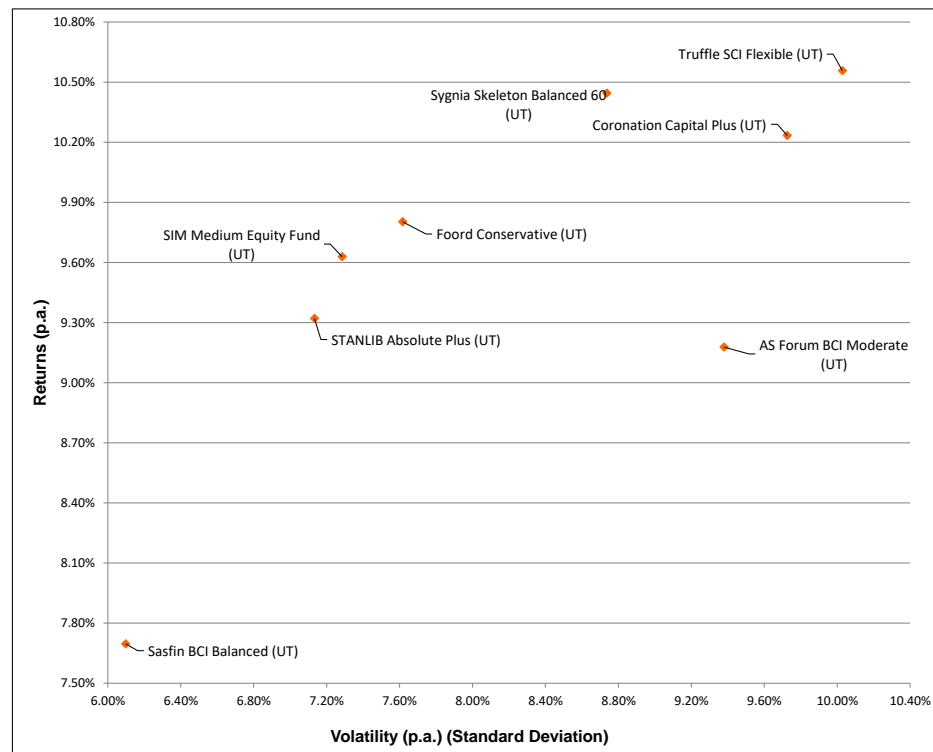

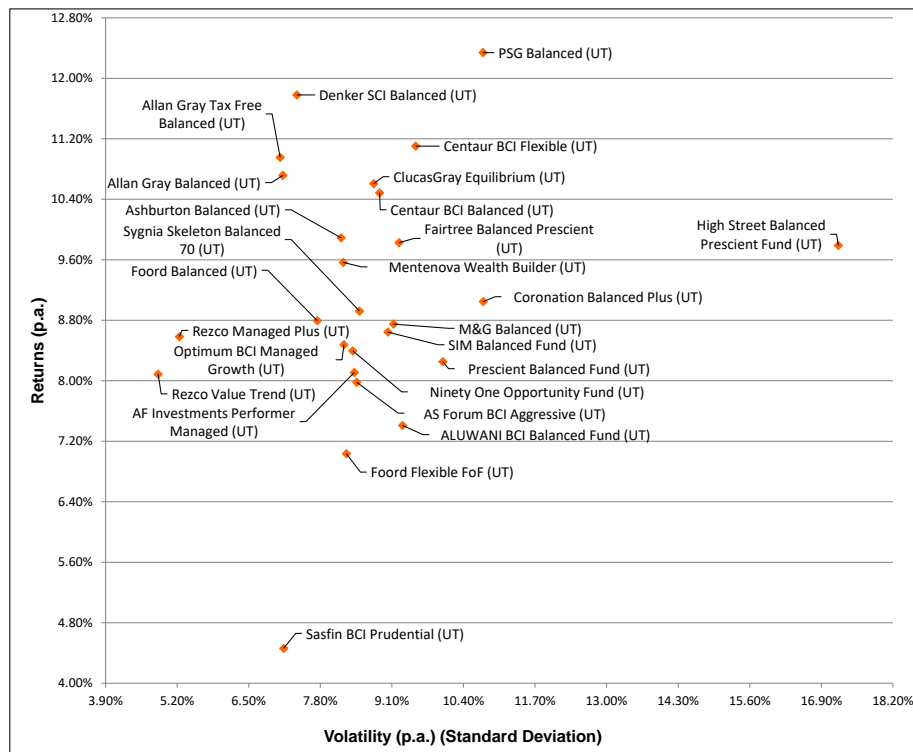


Risk vs Return

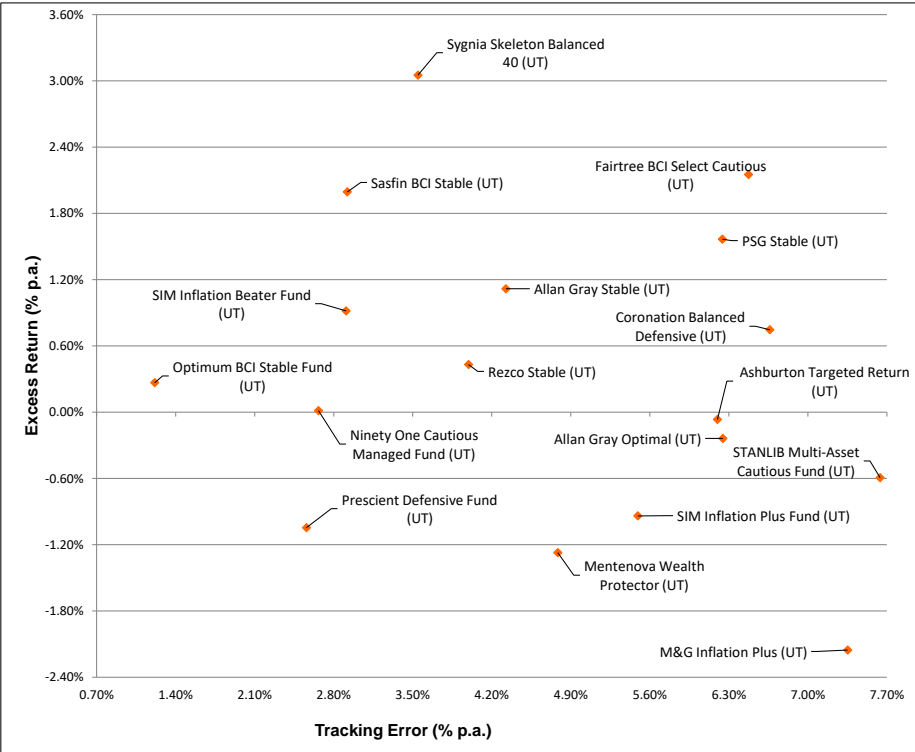


Risk vs Return

3 years ended 31 December 2024

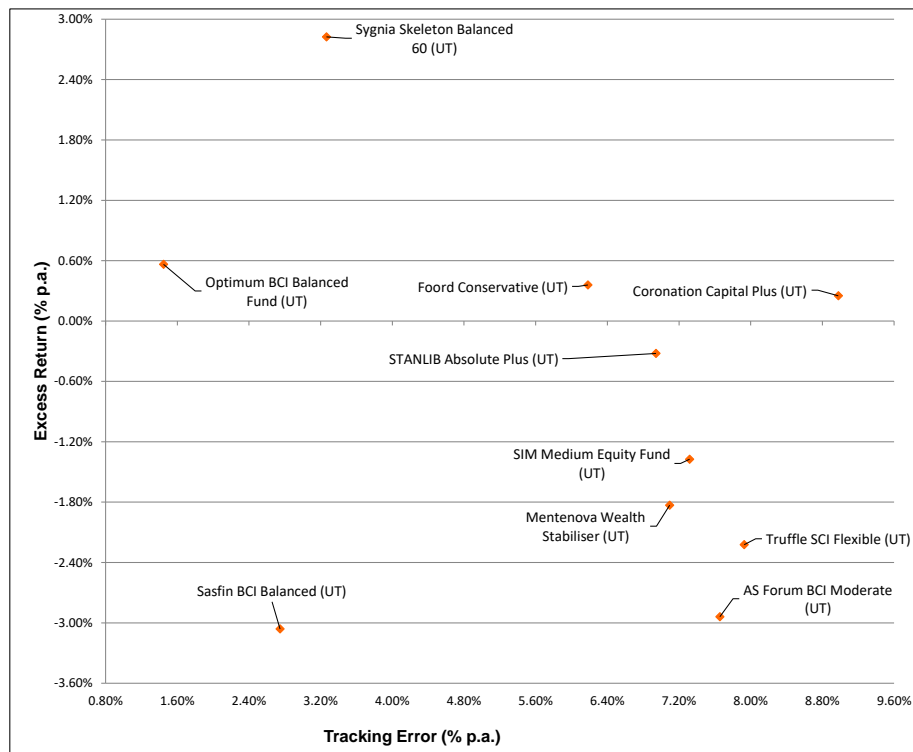


Excess Return vs Tracking Error
5 years ended 31 December 2024

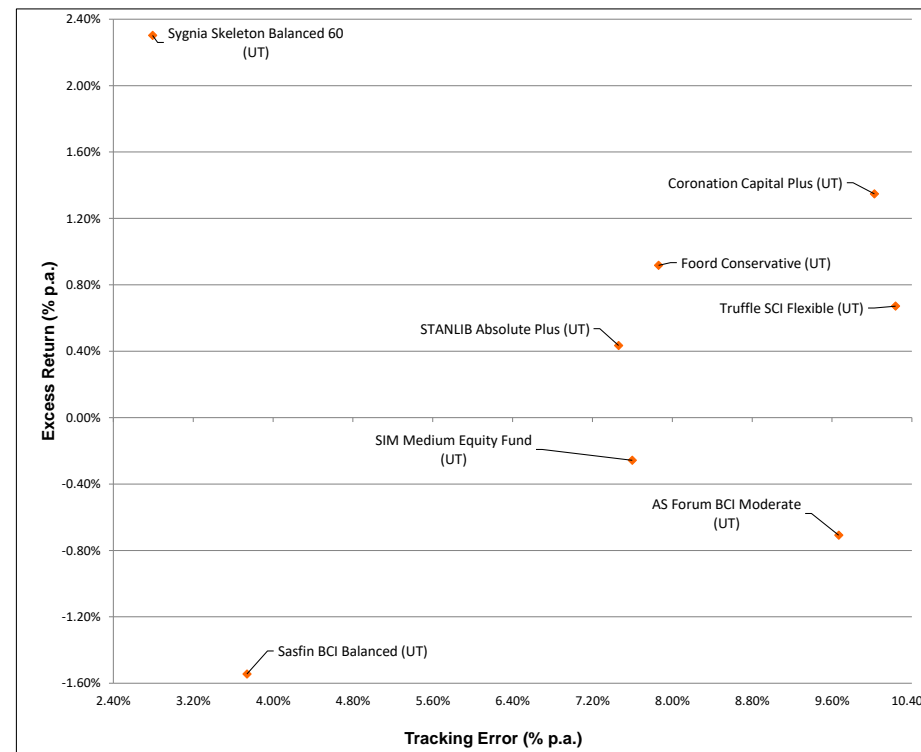

3 years ended 31 December 2024

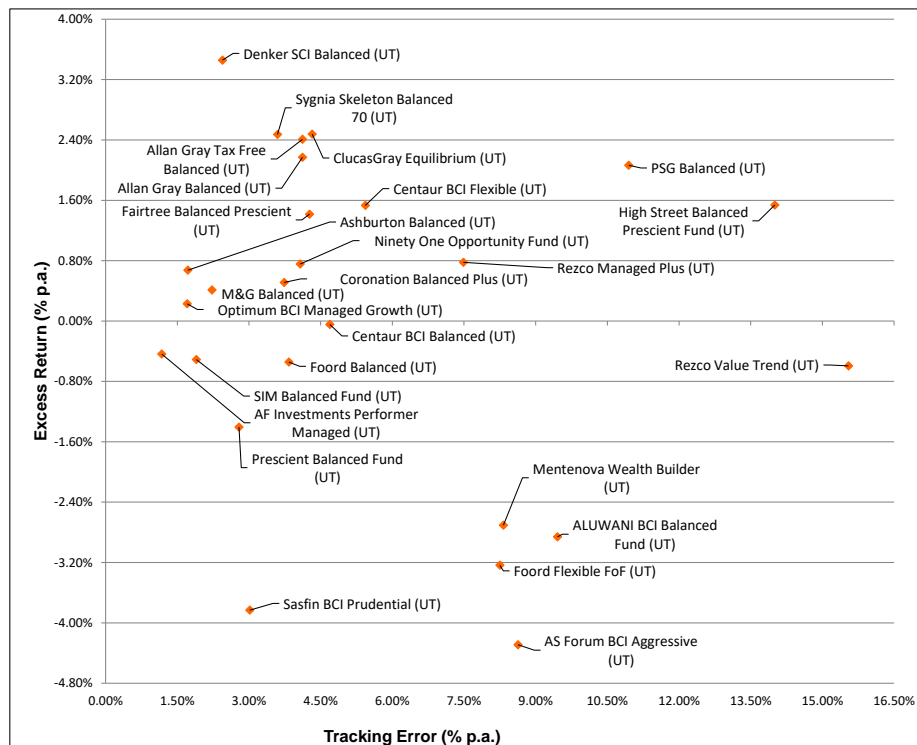


Excess Return vs Tracking Error
5 years ended 31 December 2024

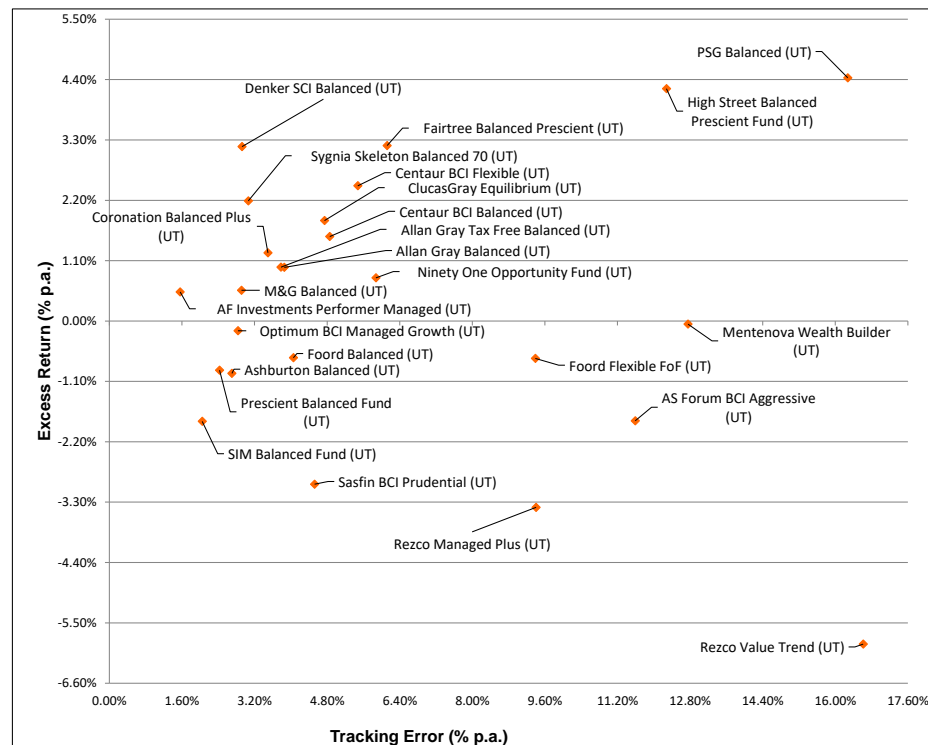

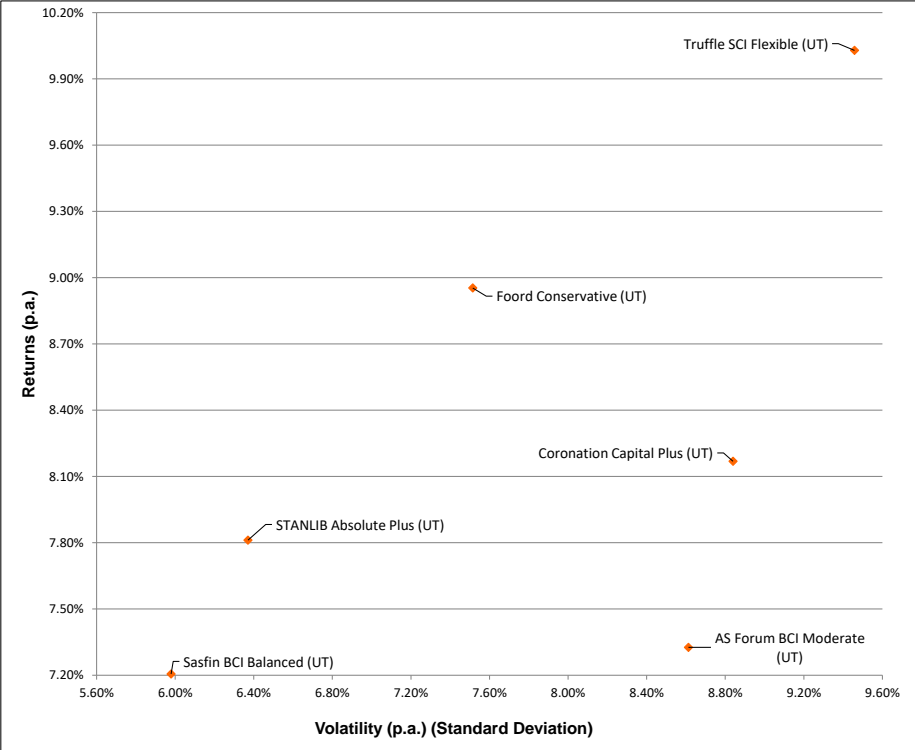


Risk vs Return
10 years ended 31 December 2024

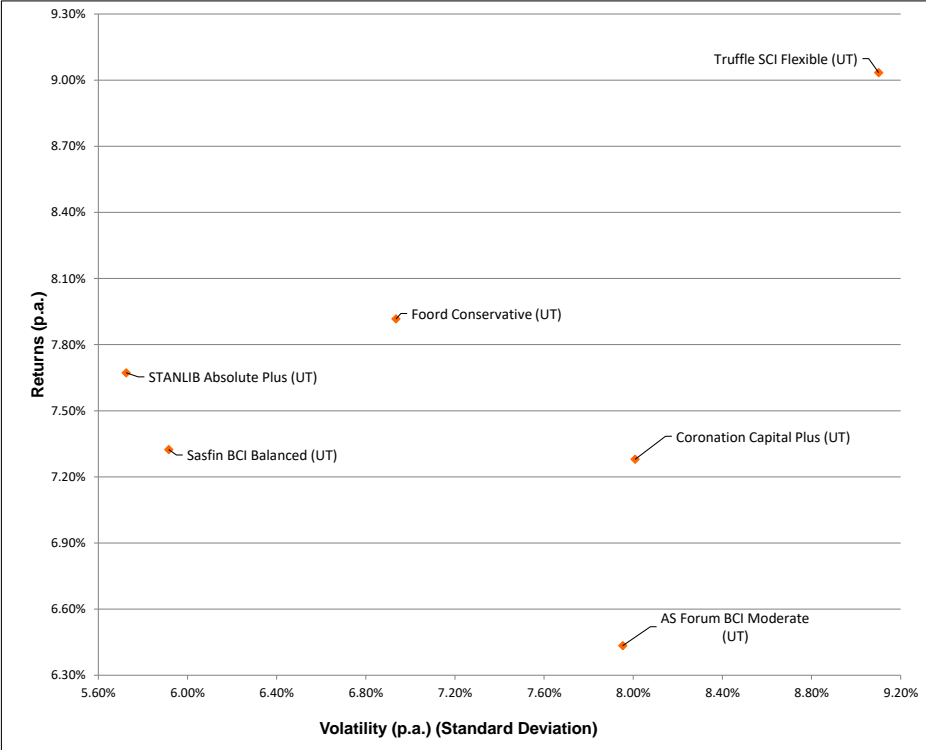


DECATHLON RETAIL S.A. INCLUDING GLOBAL - MEDIUM EQUITY

7 years ended 31 December 2024

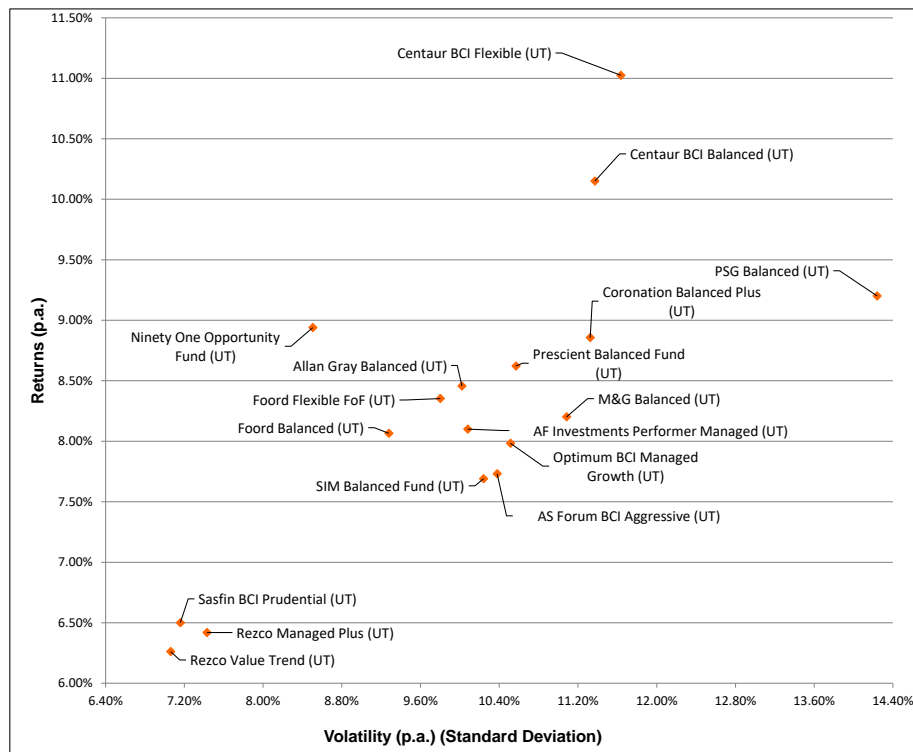


Risk vs Return
10 years ended 31 December 2024

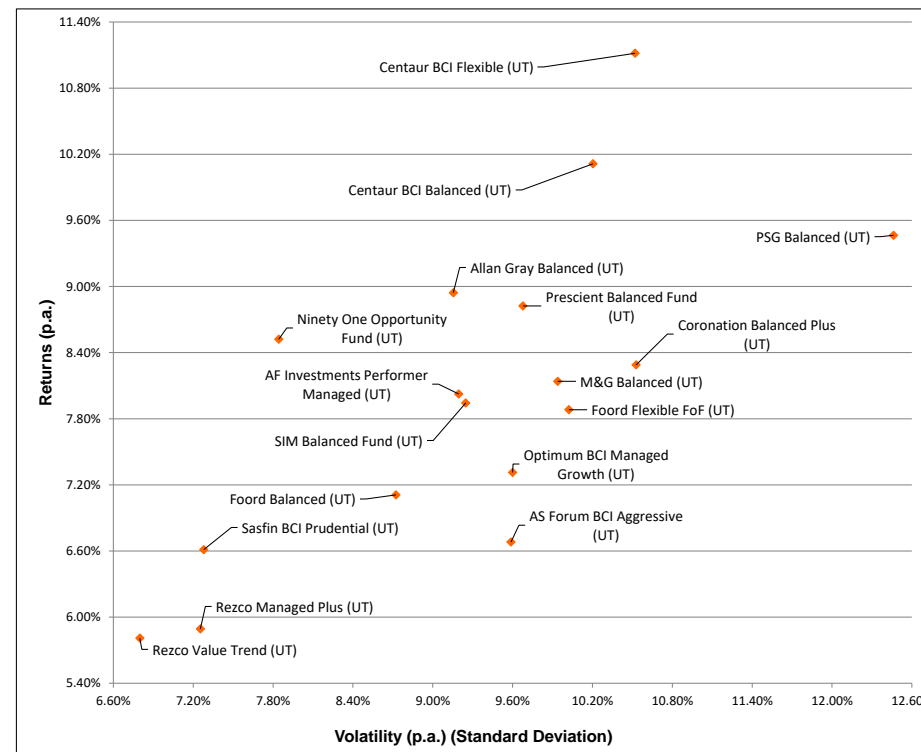


DECATHLON RETAIL S.A. INCLUDING GLOBAL - HIGH EQUITY
