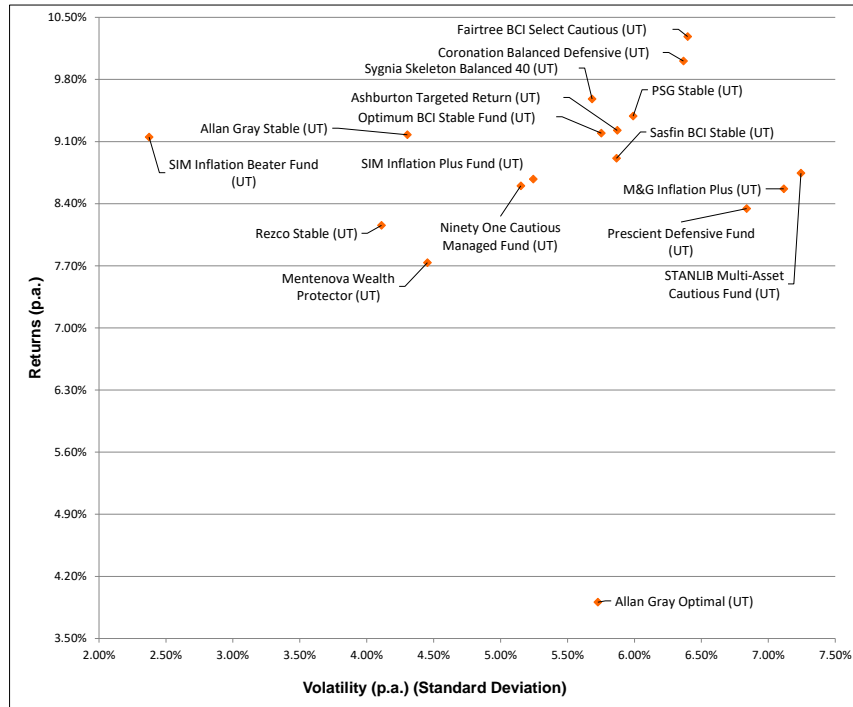

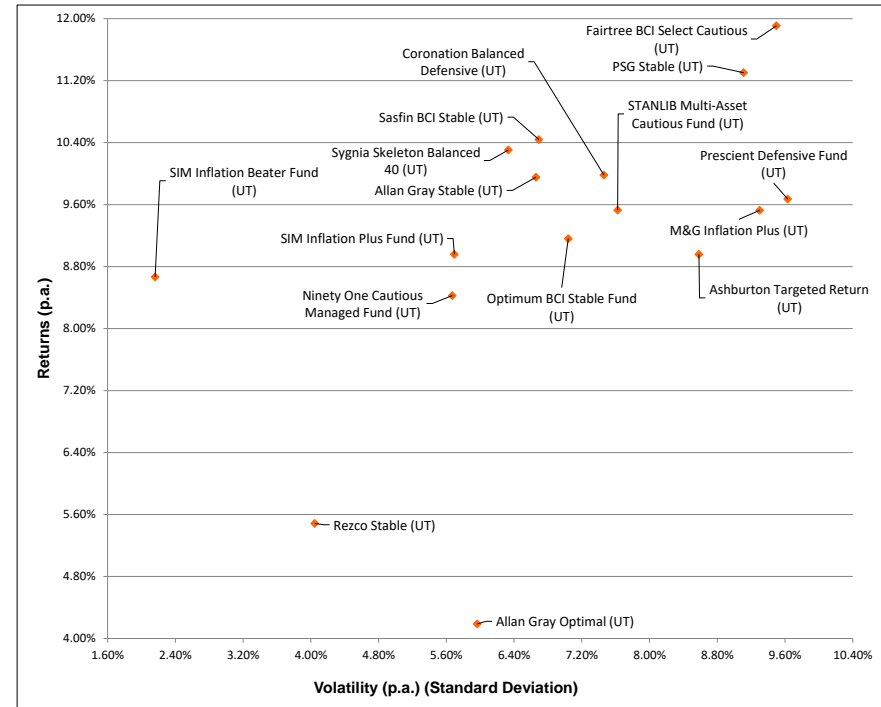

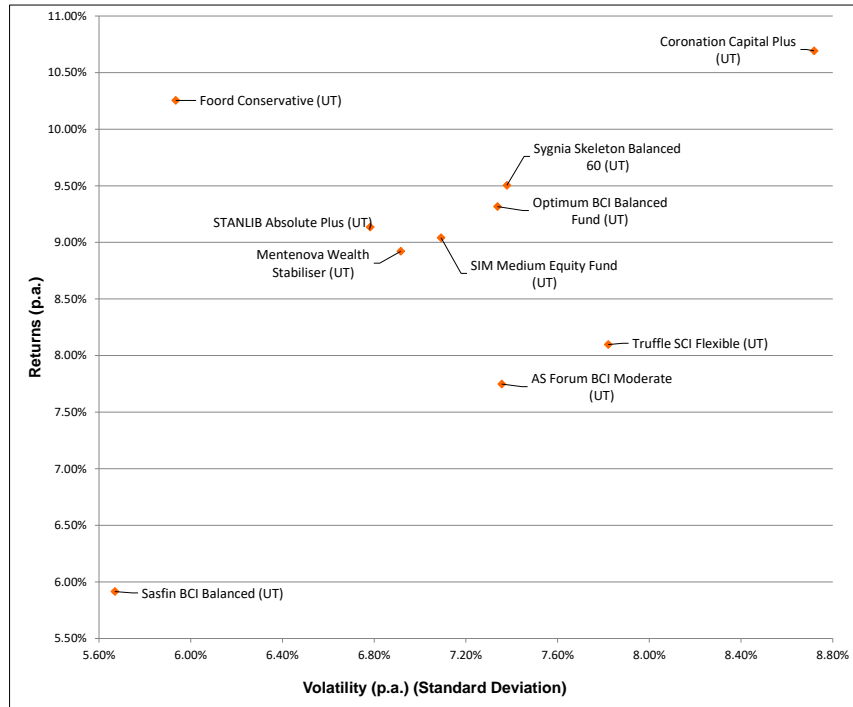


Risk vs Return
5 years ended 28 February 2025

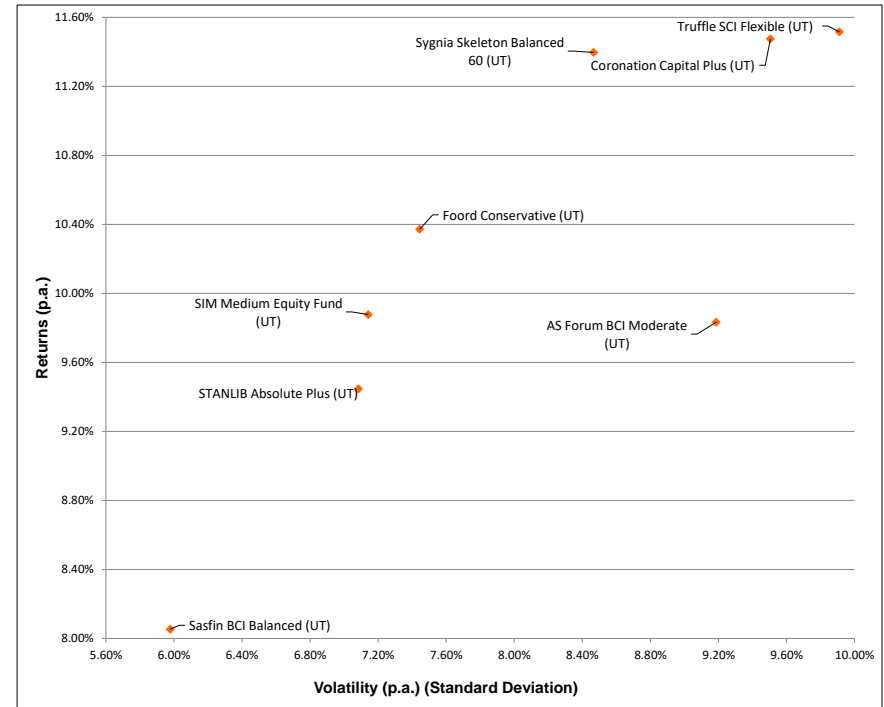

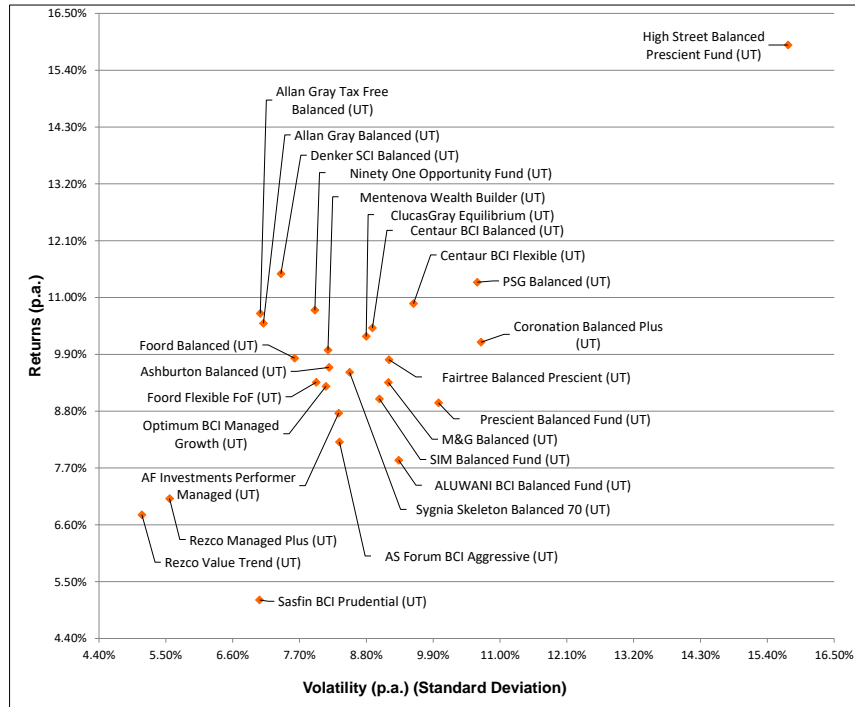

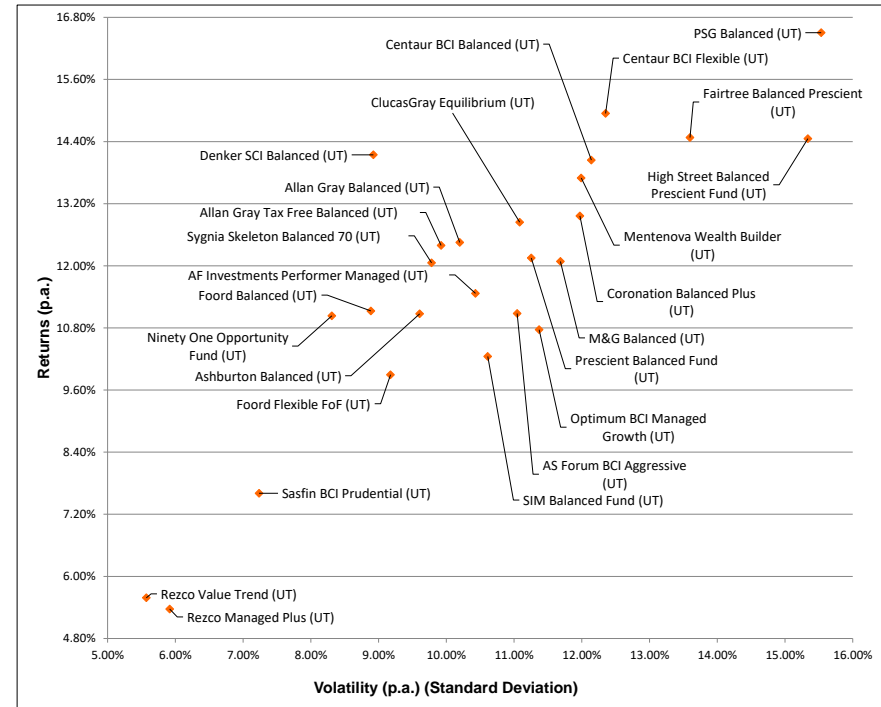


RETAIL S.A. INCLUDING GLOBAL MULTI-ASSET SURVEY - HIGH EQUITY

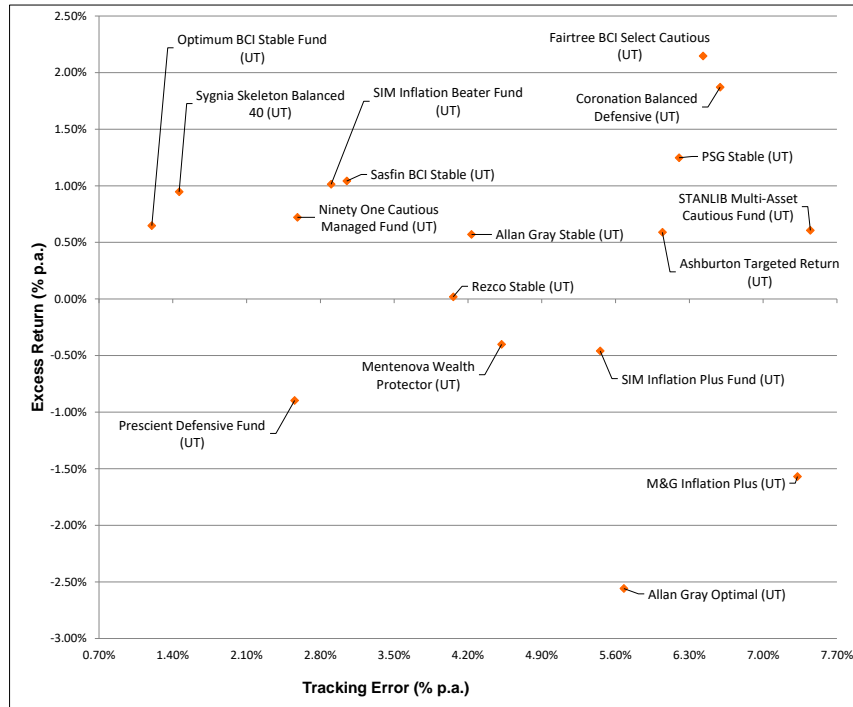

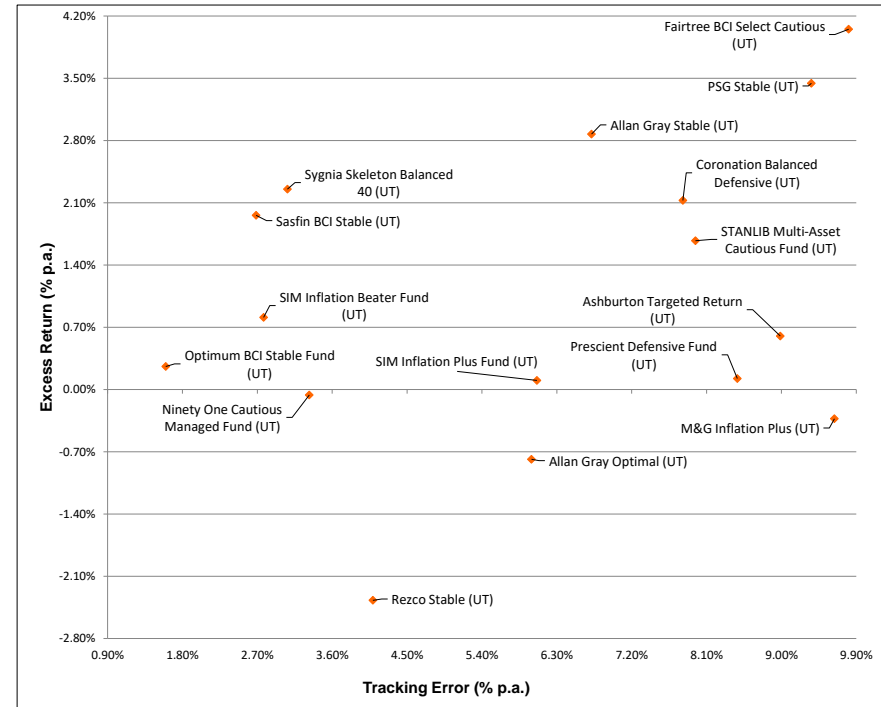


RETAIL S.A. INCLUDING GLOBAL MULTI-ASSET SURVEY - LOW EQUITY

3 years ended 28 February 2025**

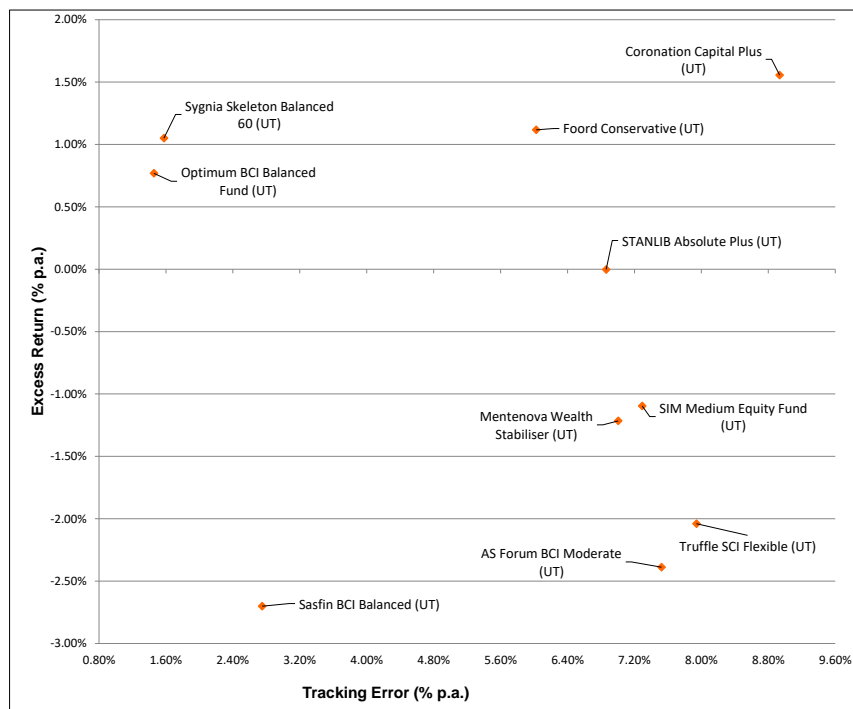


**Excess Return vs Tracking Error
5 years ended 28 February 2025**

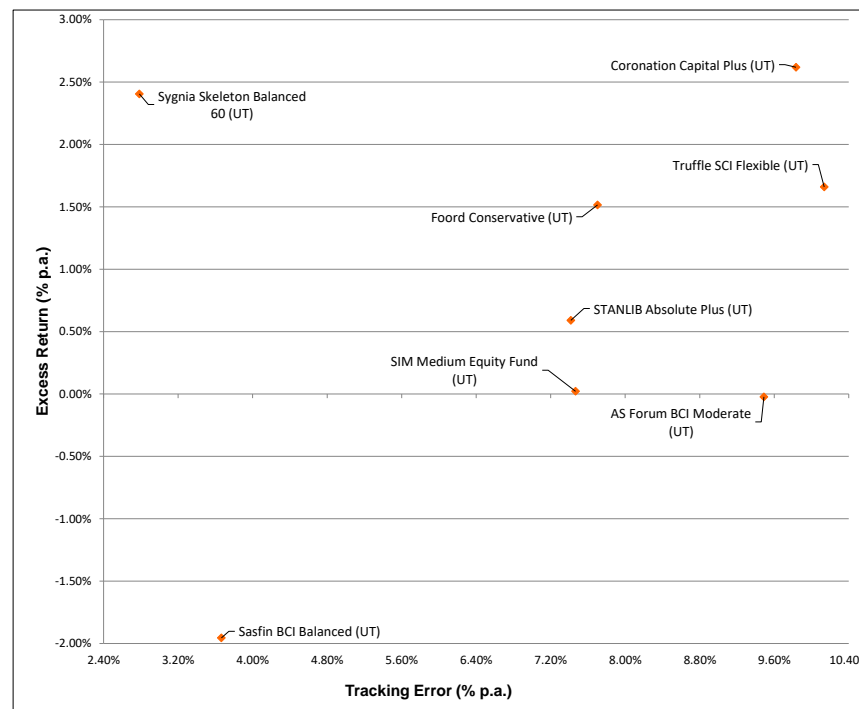

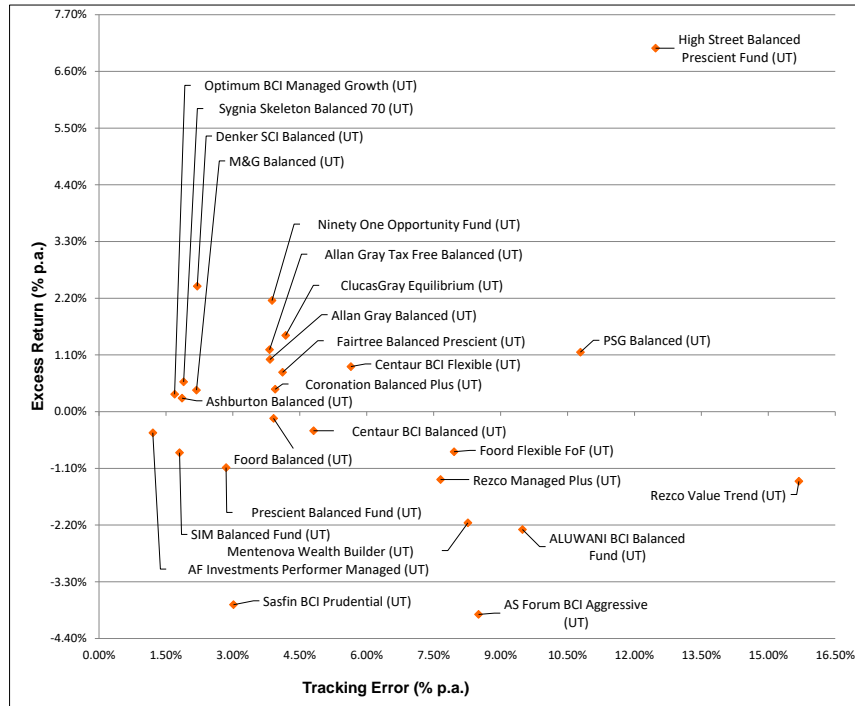

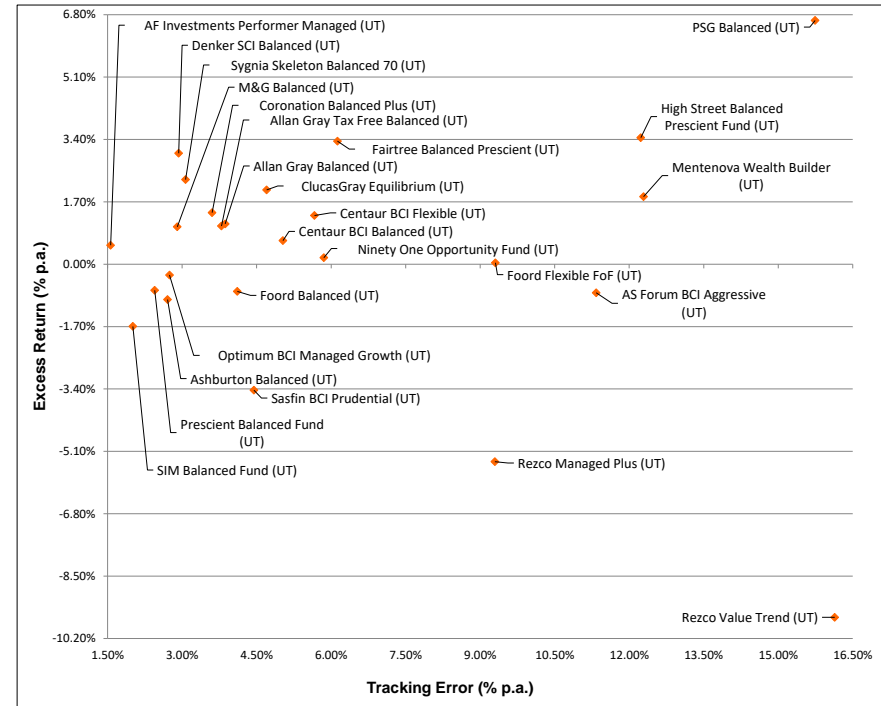

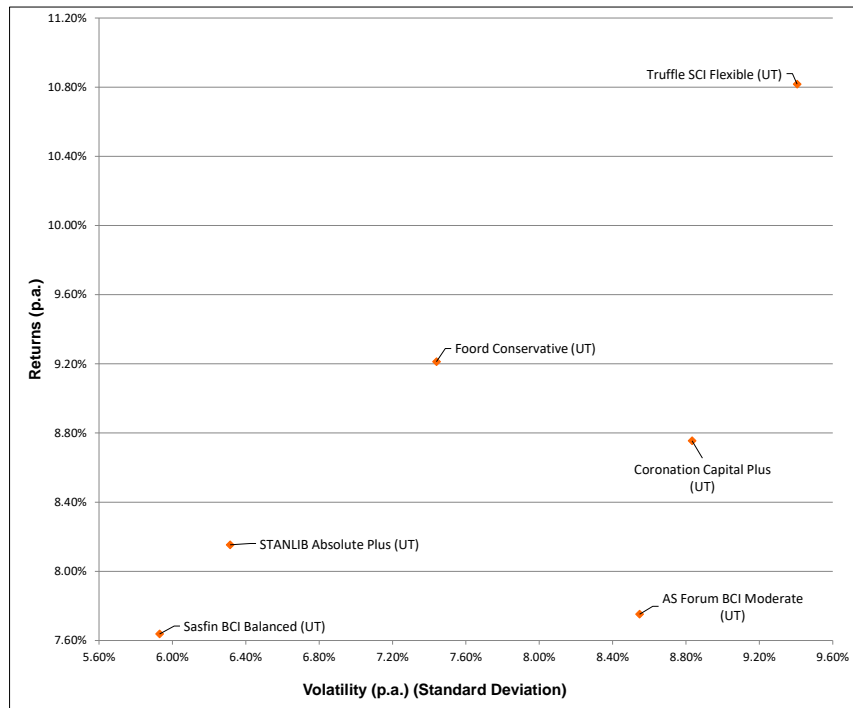


Risk vs Return
10 years ended 28 February 2025

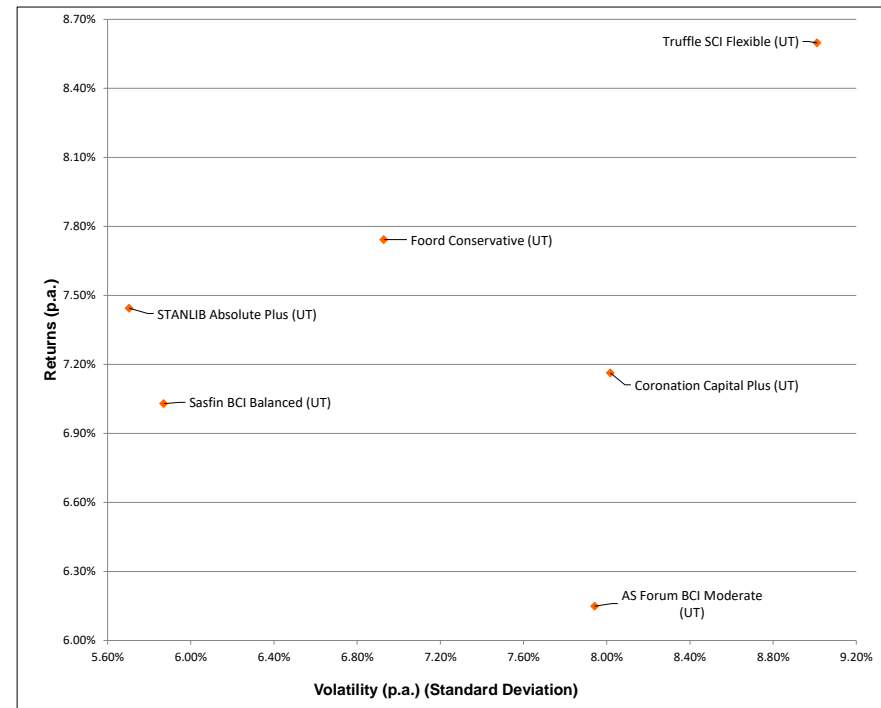

7 years ended 28 February 2025

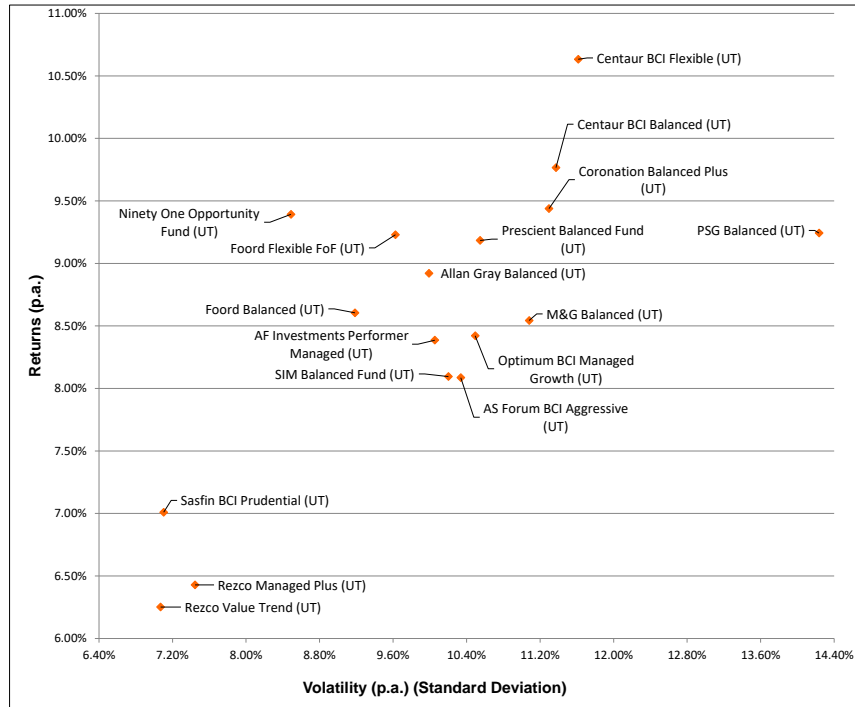

10 years ended 28 February 2025

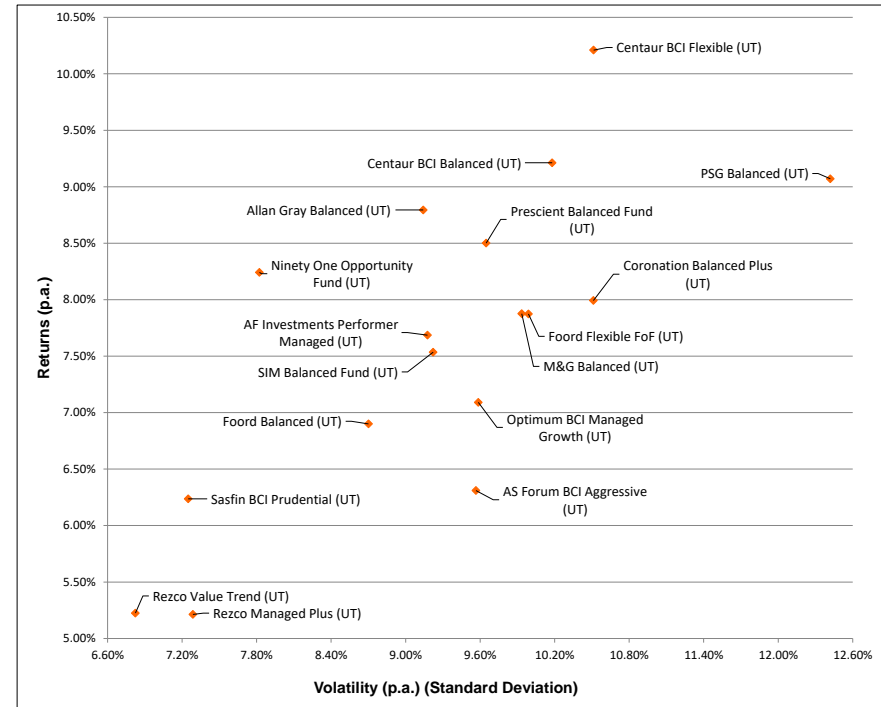


DECATHLON RETAIL S.A. INCLUDING GLOBAL - HIGH EQUITY
