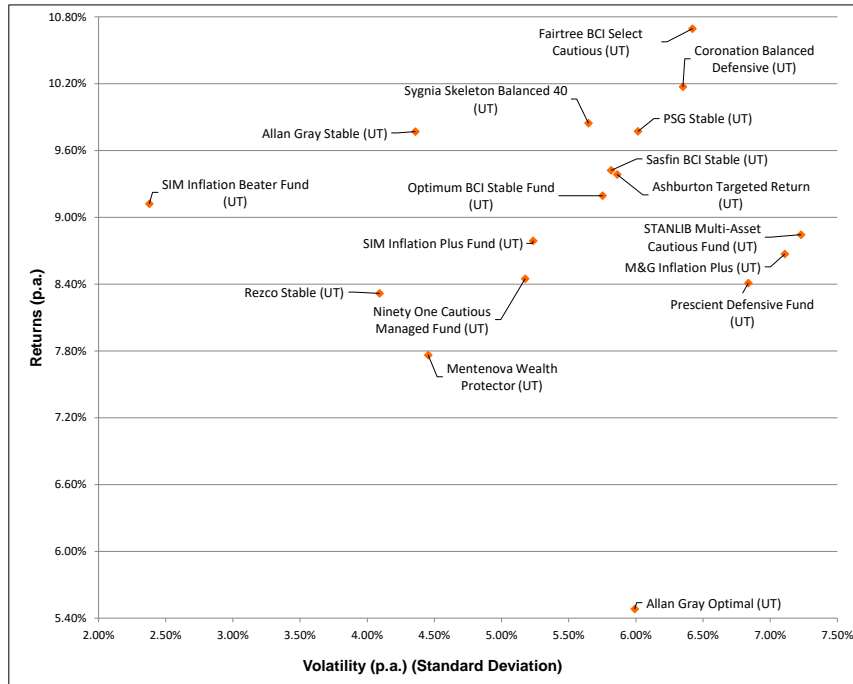

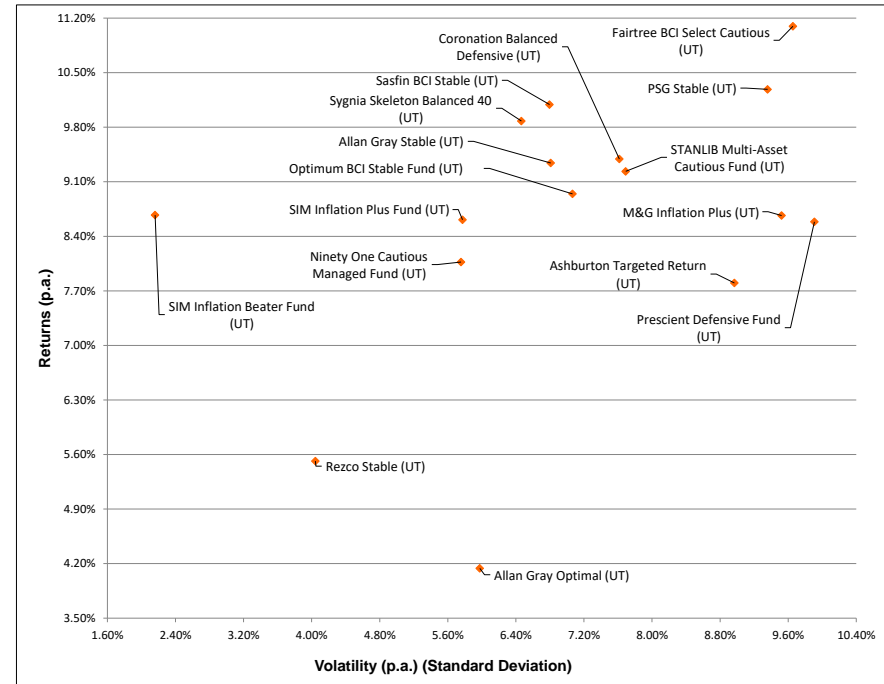

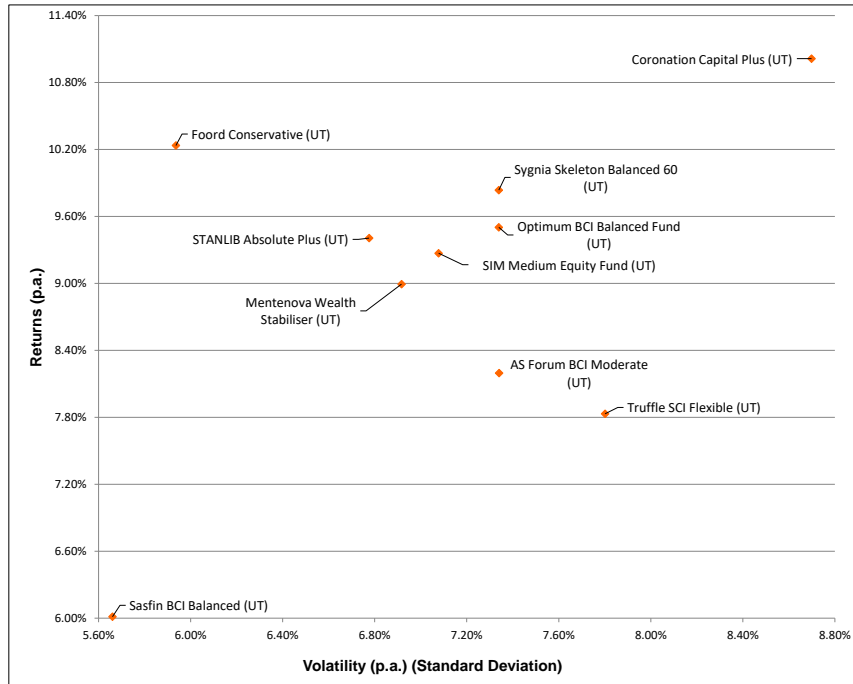


**Risk vs Return**  
5 years ended 31 January 2025

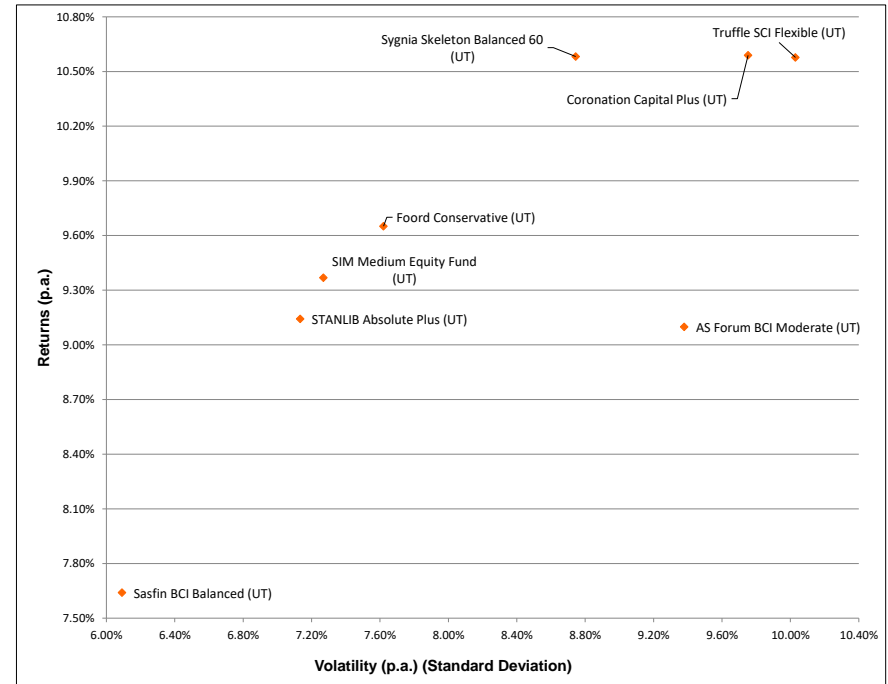

3 years ended 31 January 2025

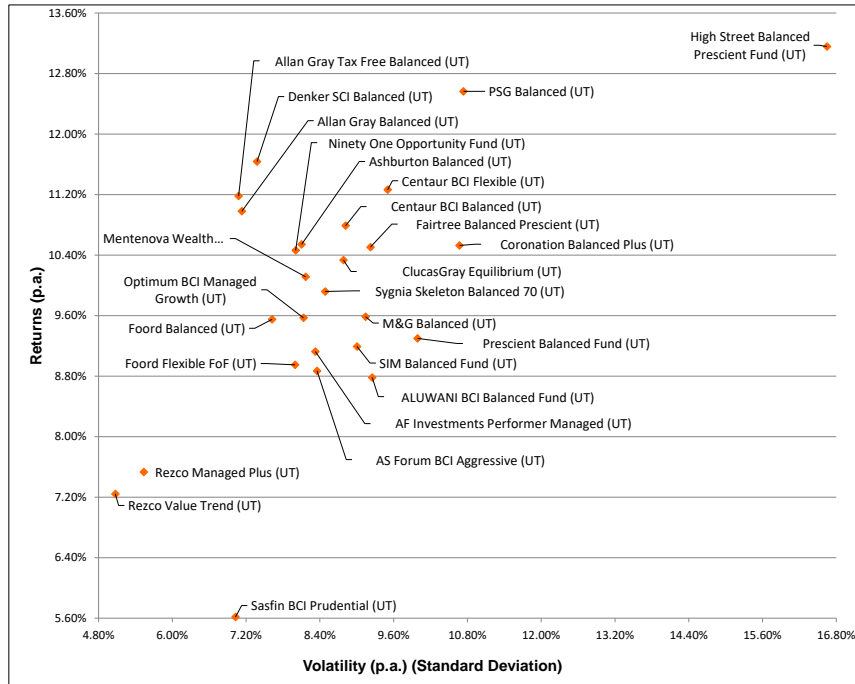

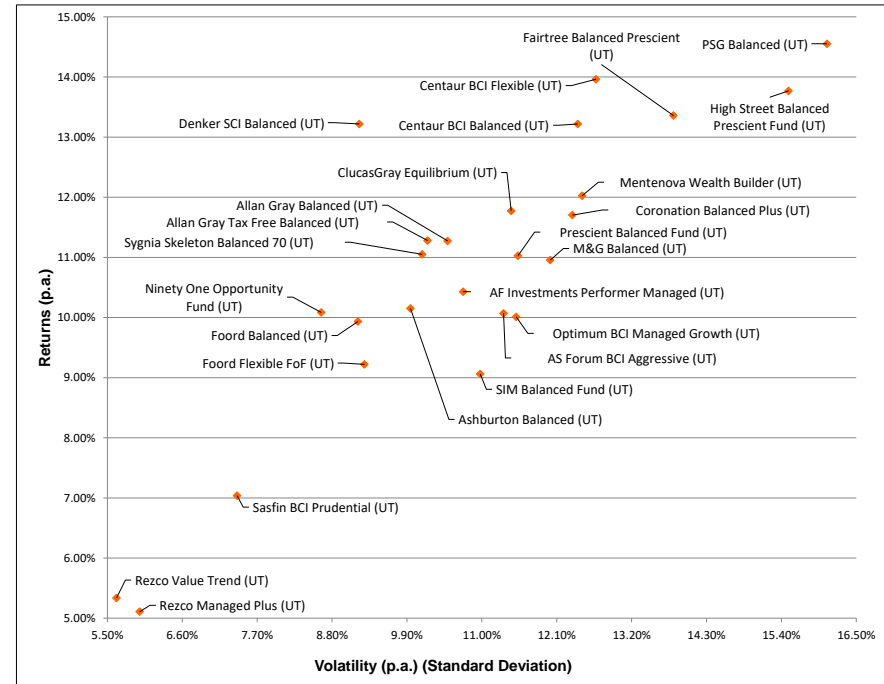

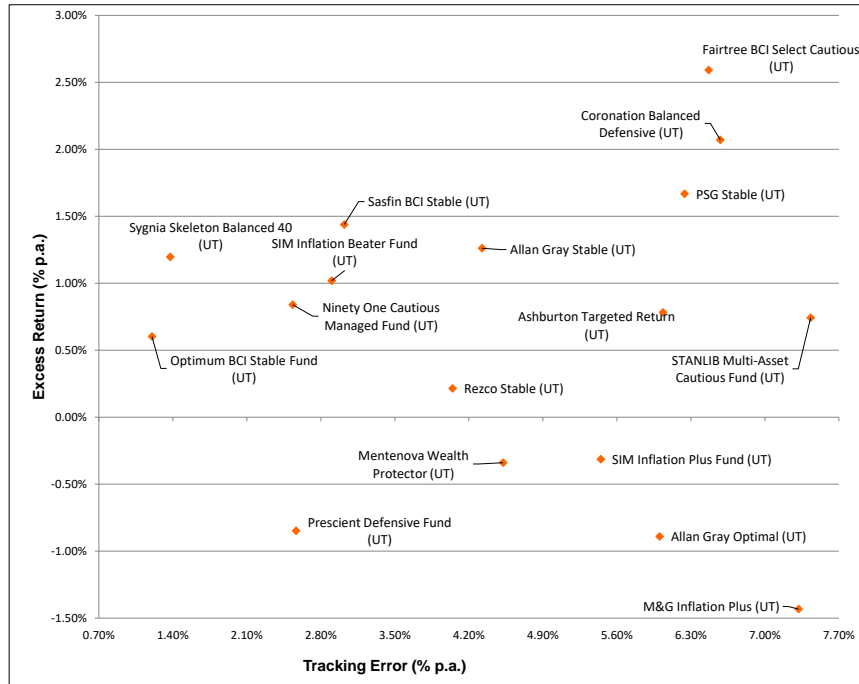

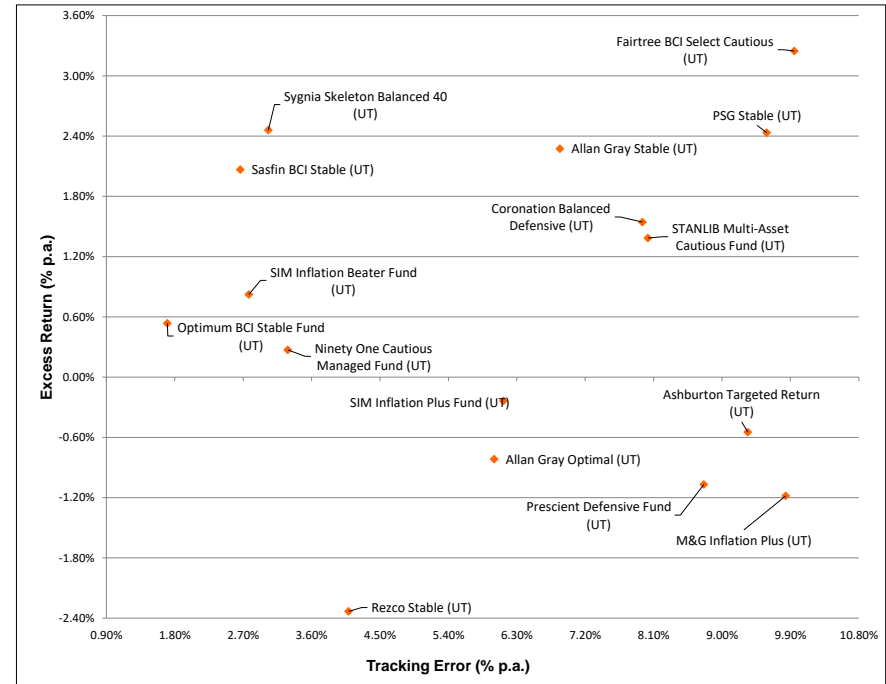

3 years ended 31 January 2025**



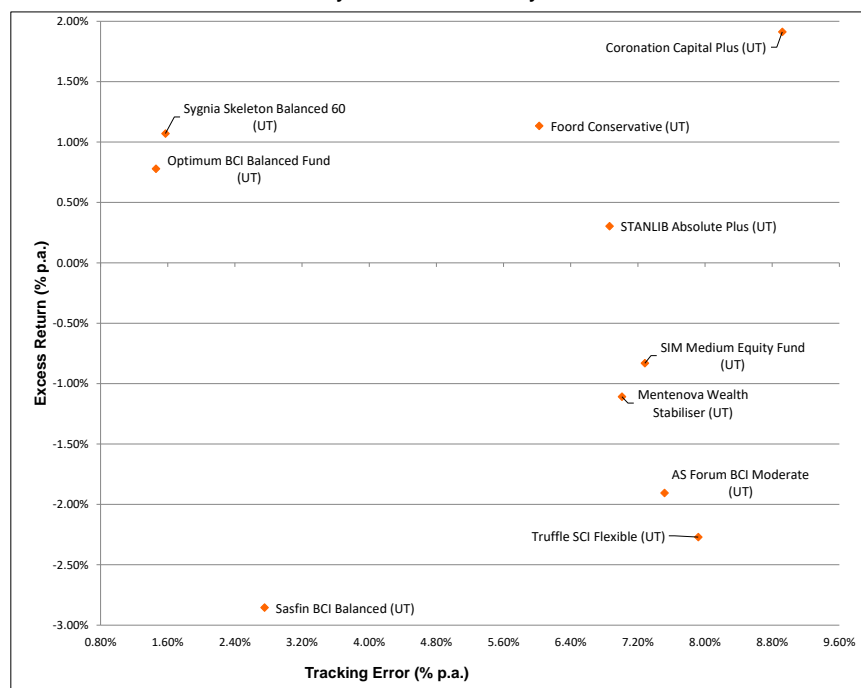
**Excess Return vs Tracking Error  
5 years ended 31 January 2025**



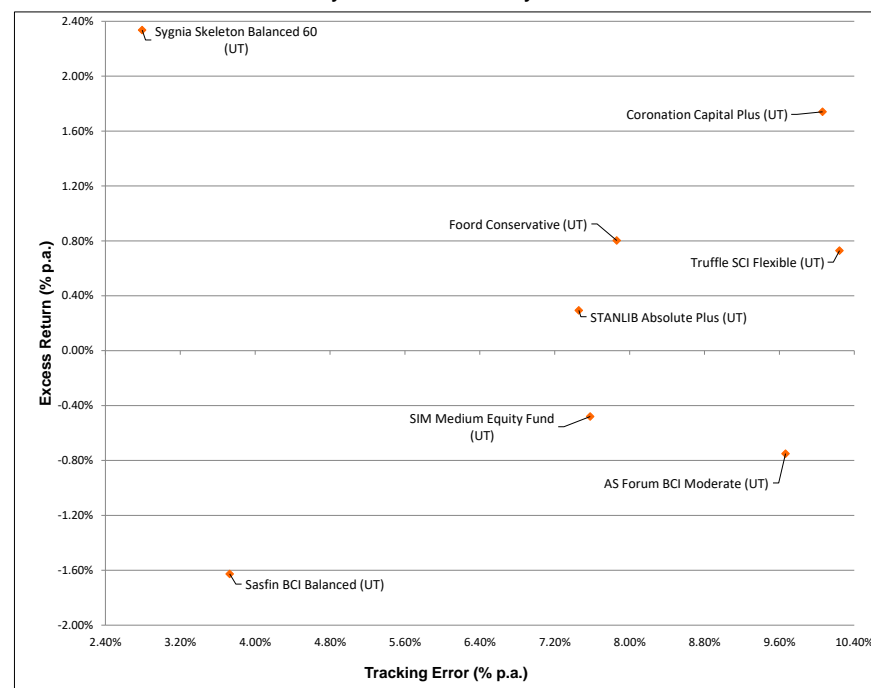

3 years ended 31 January 2025**

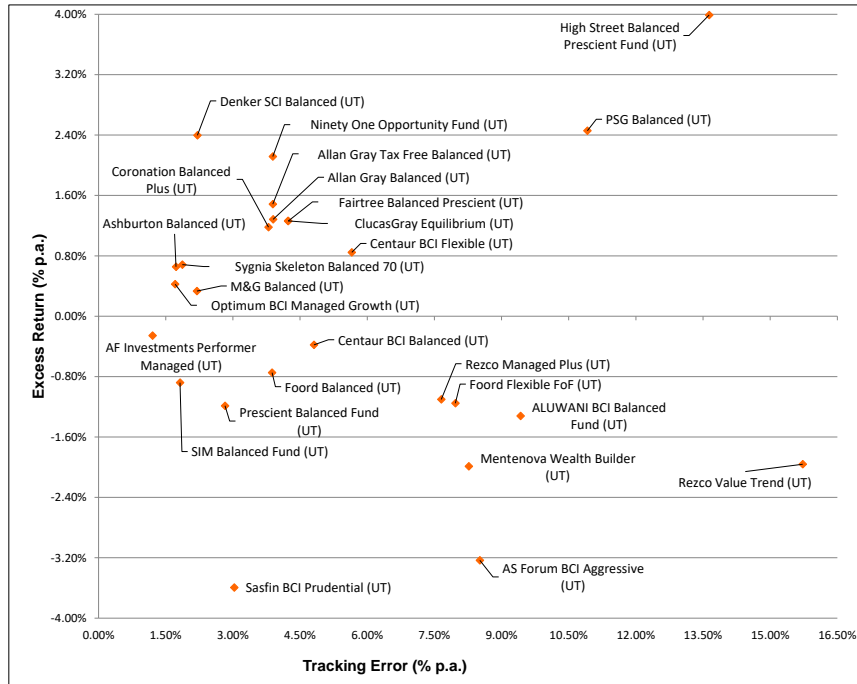


**Excess Return vs Tracking Error  
5 years ended 31 January 2025**

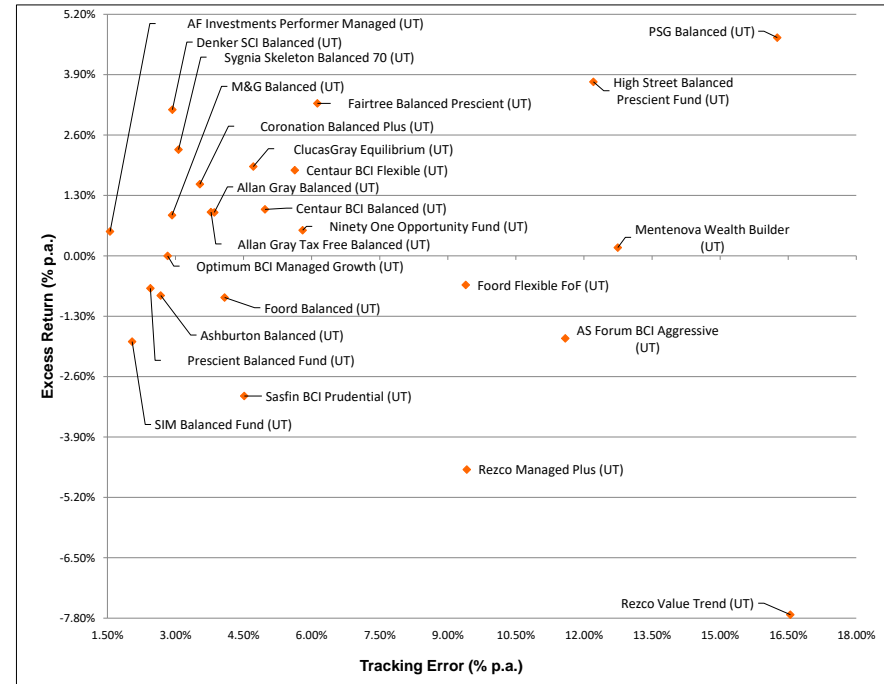

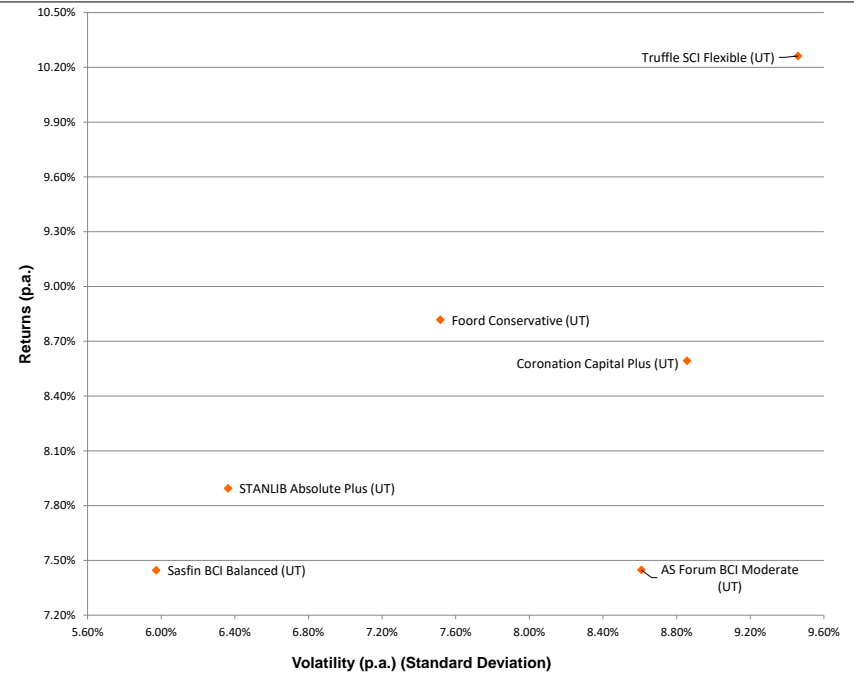
**Risk vs Return**  
10 years ended 31 January 2025



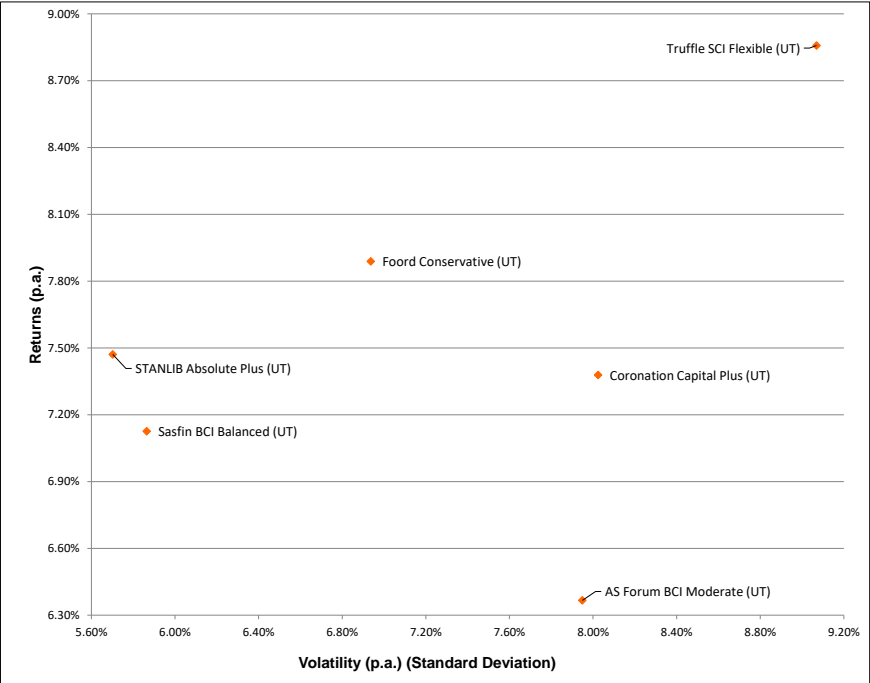

7 years ended 31 January 2025

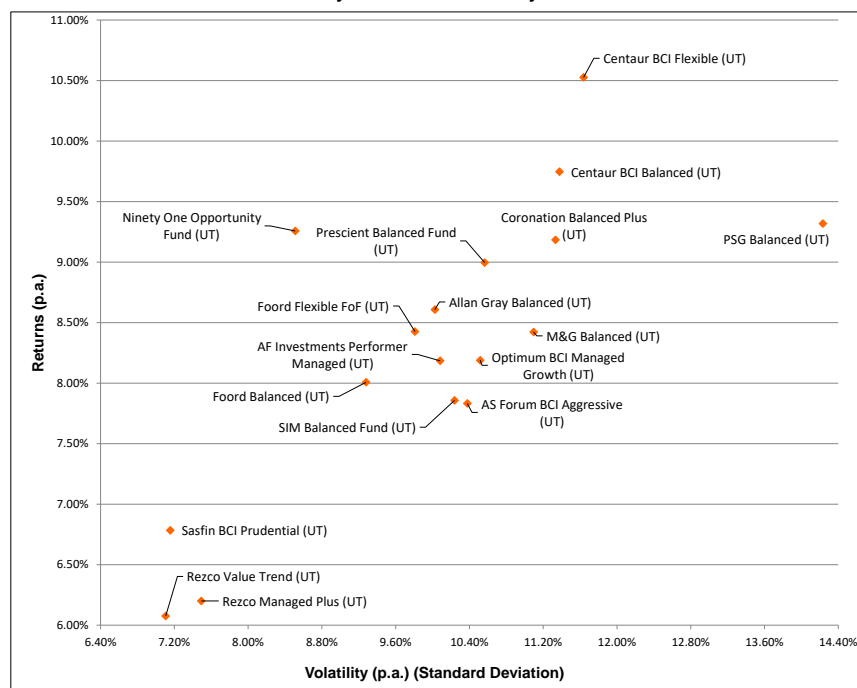

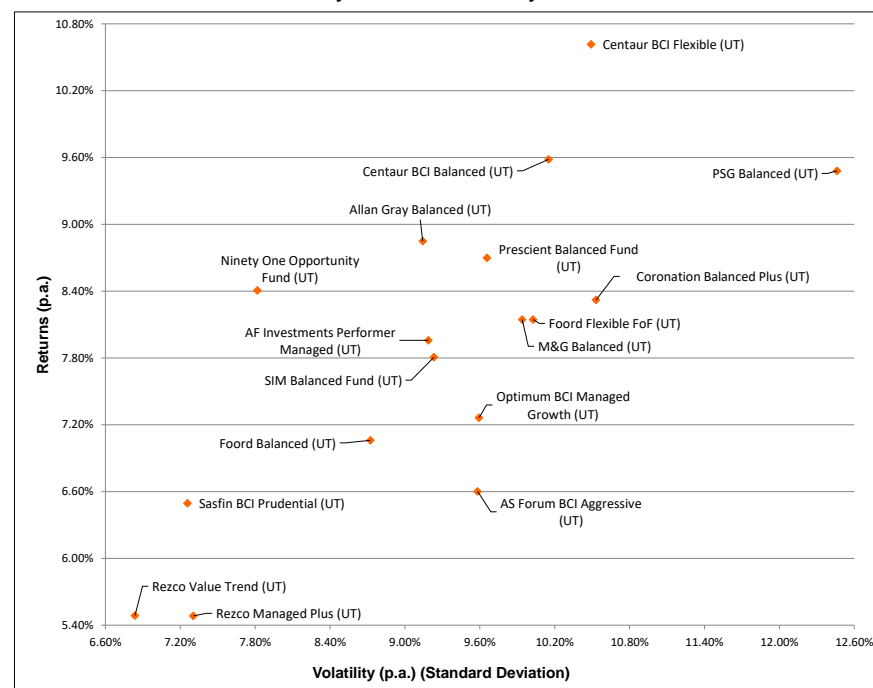
