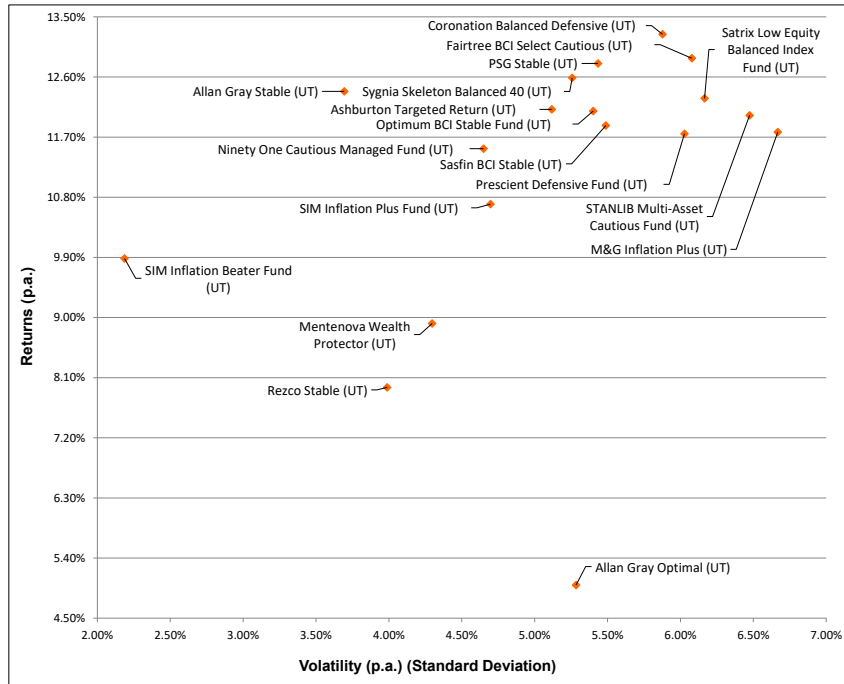

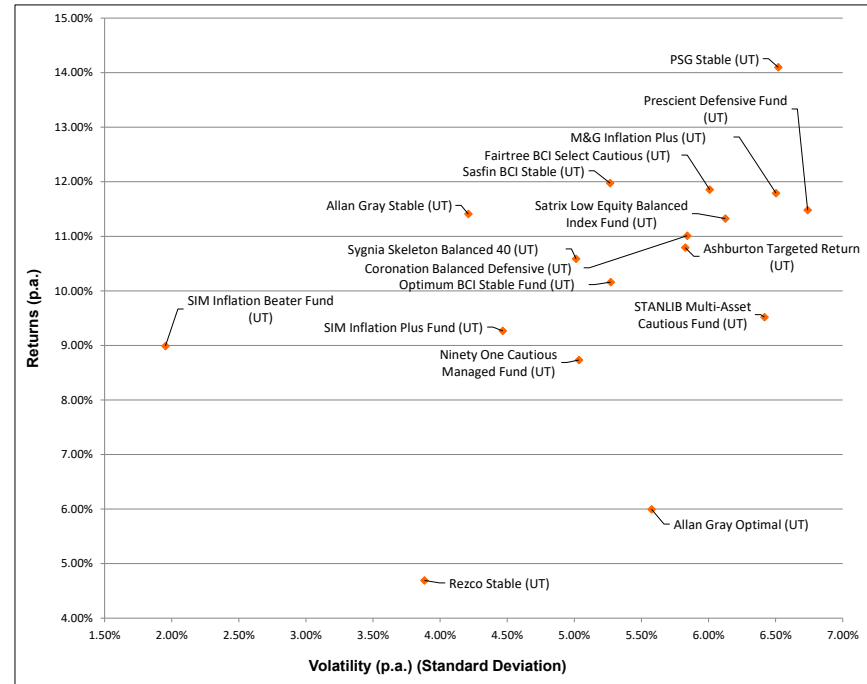

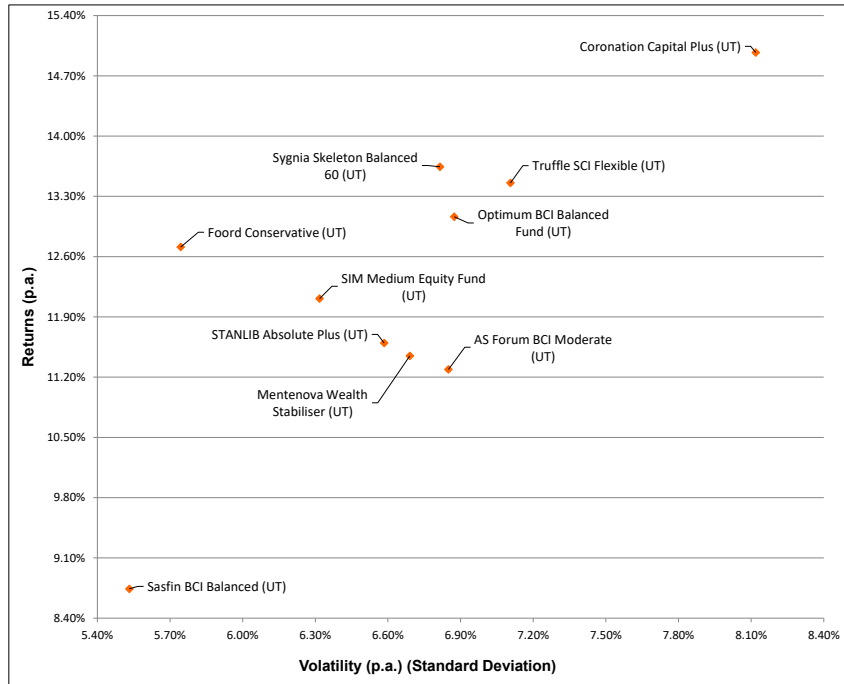


Risk vs Return
5 years ended 31 July 2025

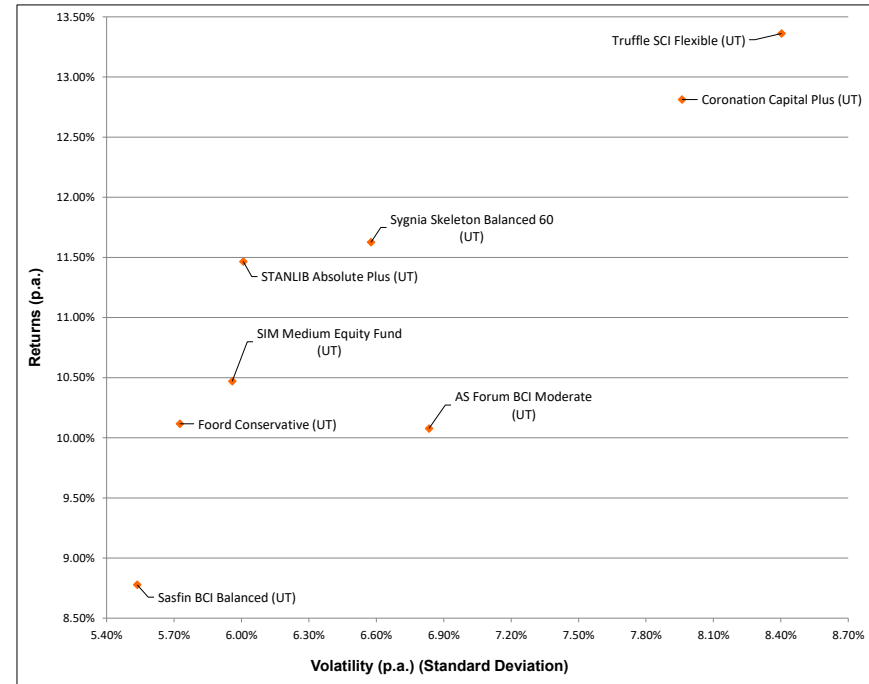


RETAIL S.A. INCLUDING GLOBAL MULTI-ASSET SURVEY - MEDIUM EQUITY

3 years ended 31 July 2025

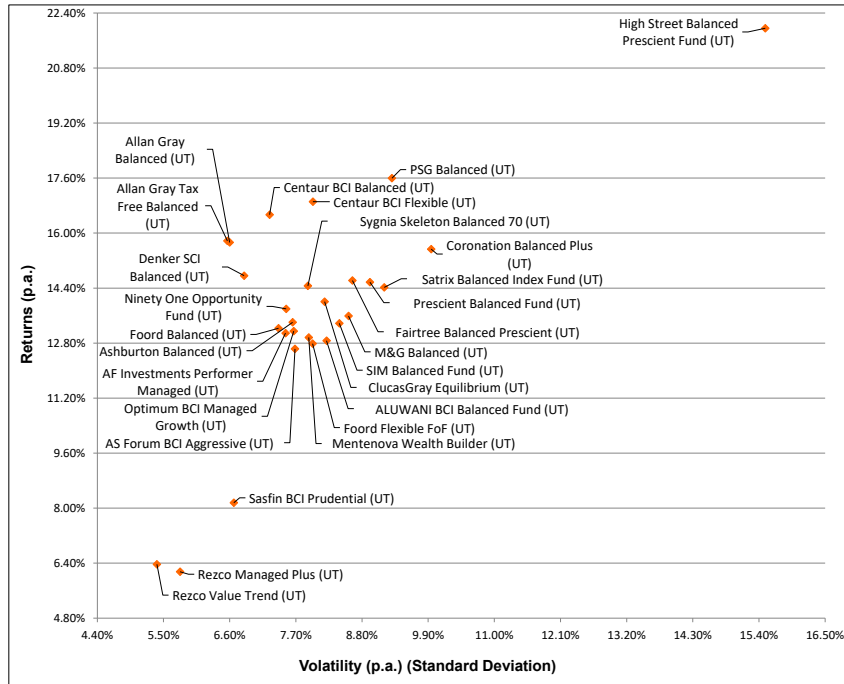

5 years ended 31 July 2025

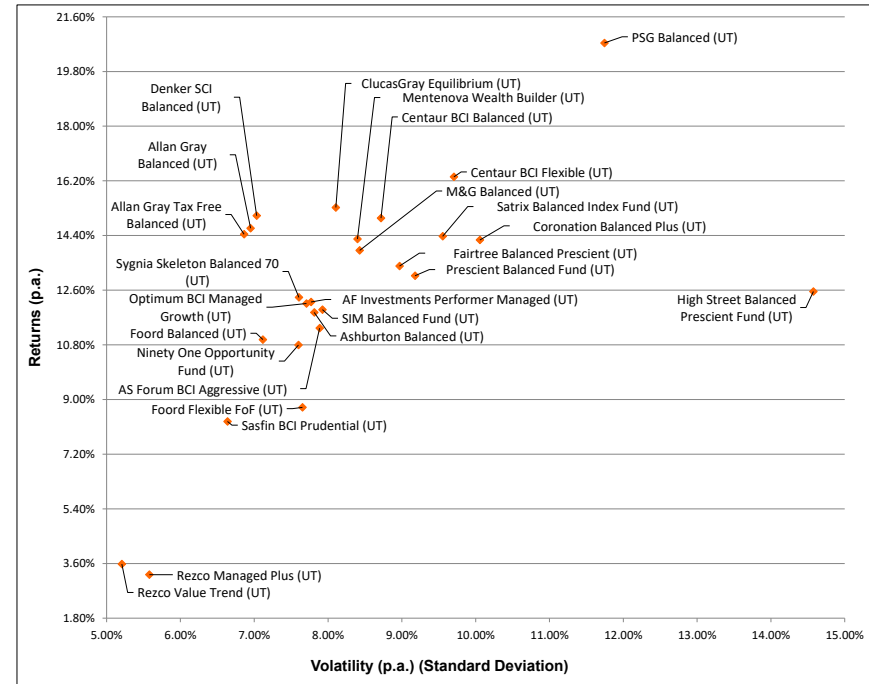


RETAIL S.A. INCLUDING GLOBAL MULTI-ASSET SURVEY - HIGH EQUITY

3 years ended 31 July 2025

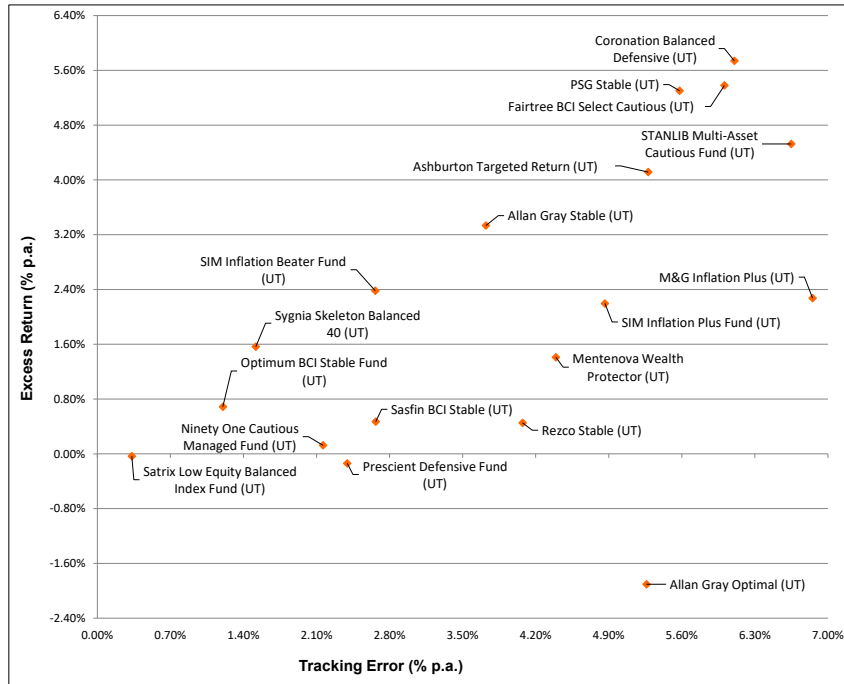


Risk vs Return
5 years ended 31 July 2025

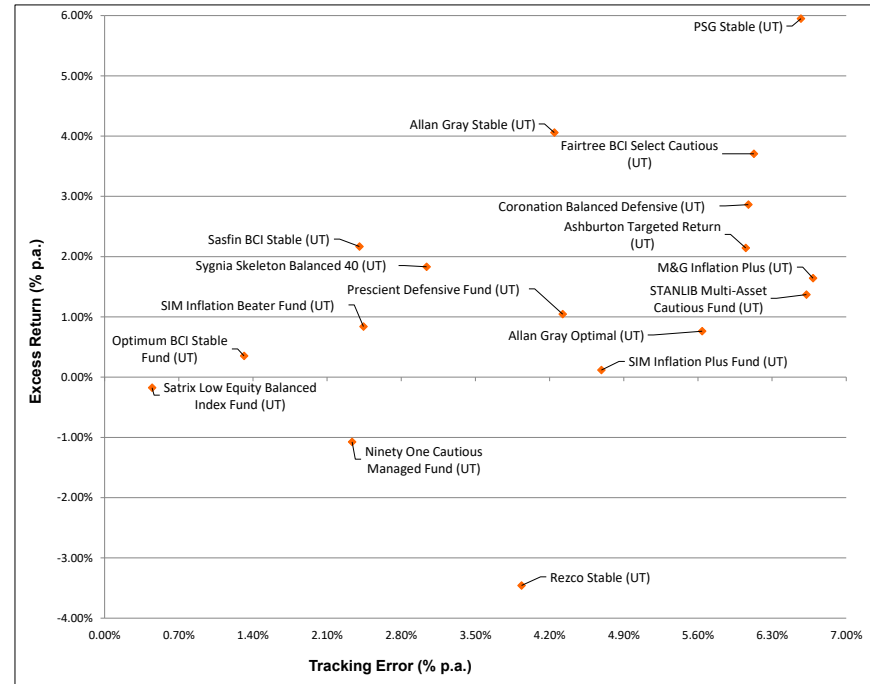


RETAIL S.A. INCLUDING GLOBAL MULTI-ASSET SURVEY - LOW EQUITY

3 years ended 31 July 2025

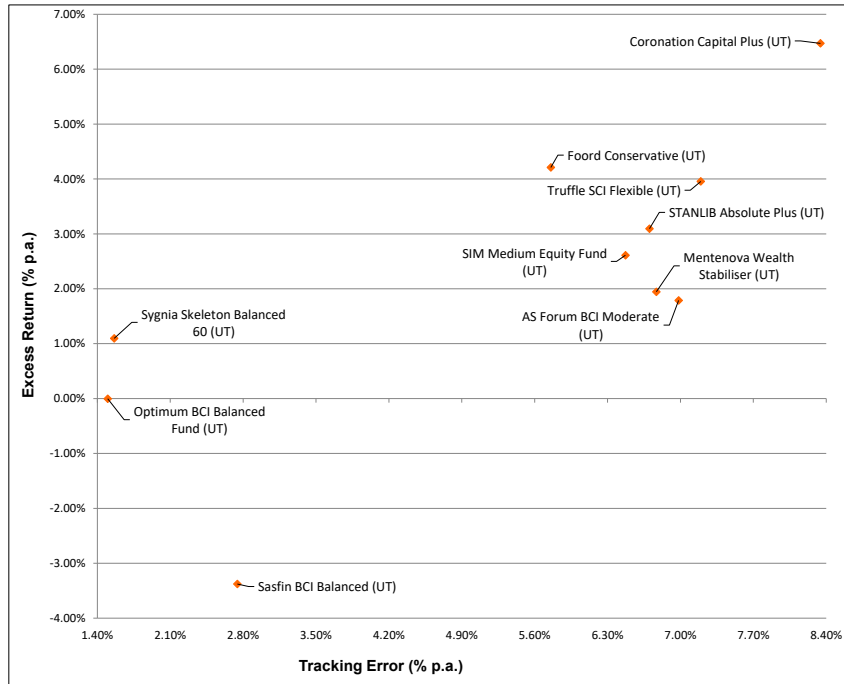


Excess Return vs Tracking Error
5 years ended 31 July 2025

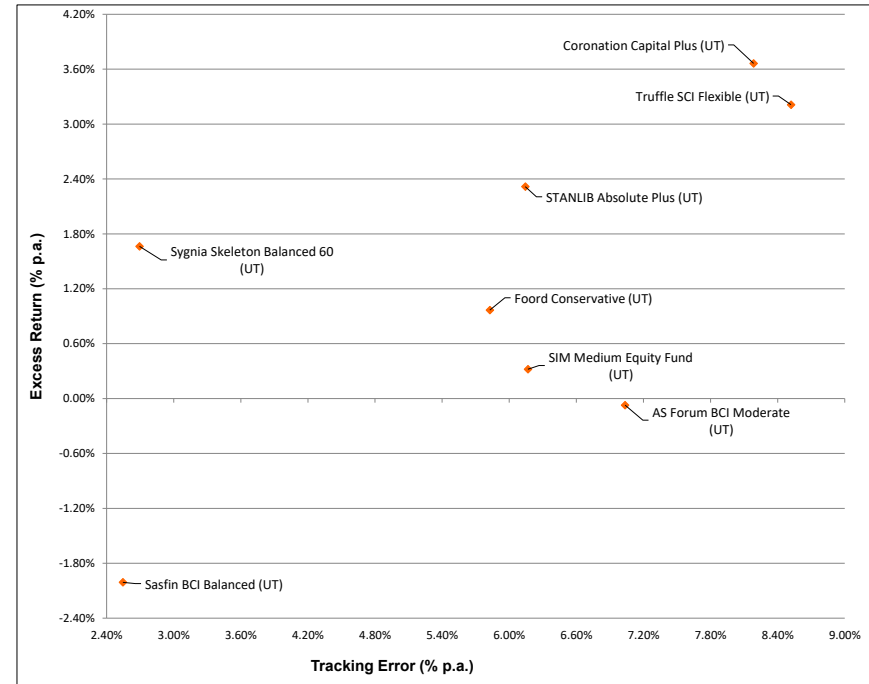

3 years ended 31 July 2025

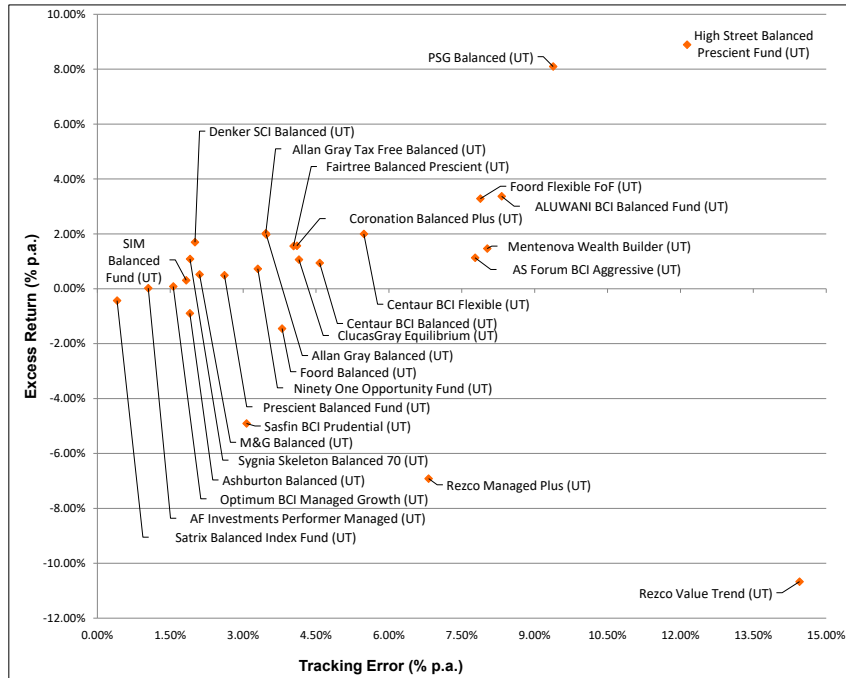


Excess Return vs Tracking Error
5 years ended 31 July 2025

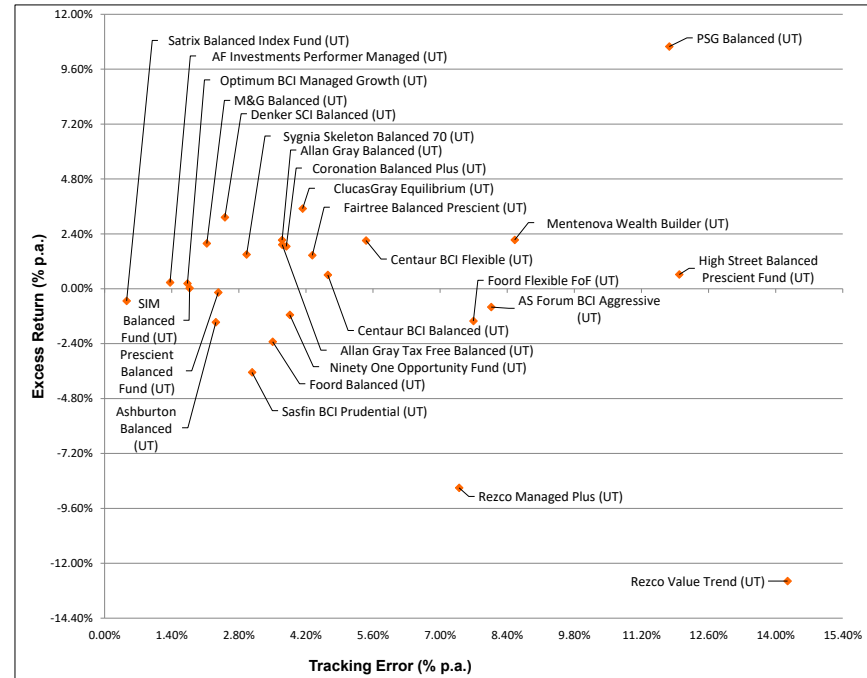

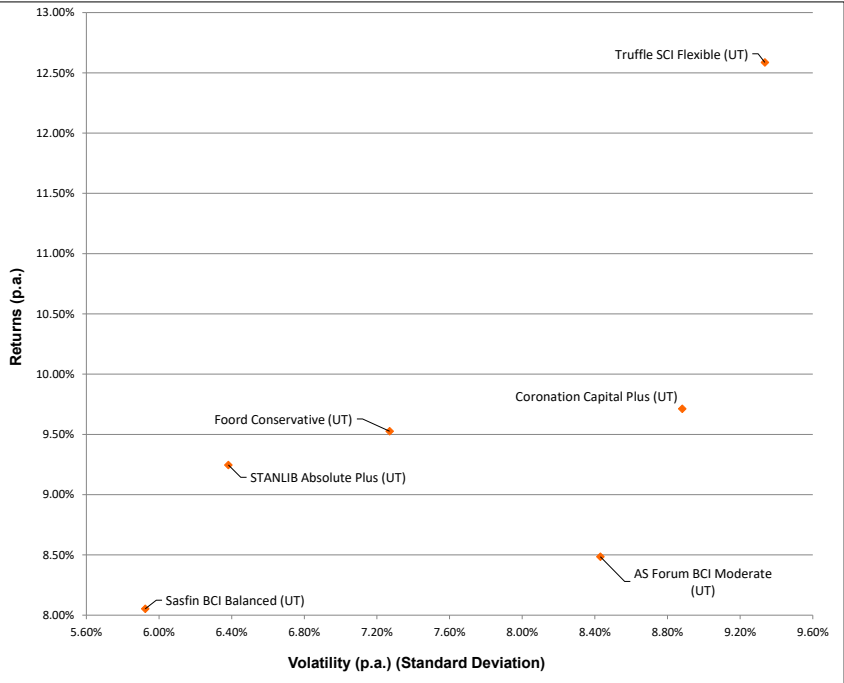


Risk vs Return
10 years ended 31 July 2025

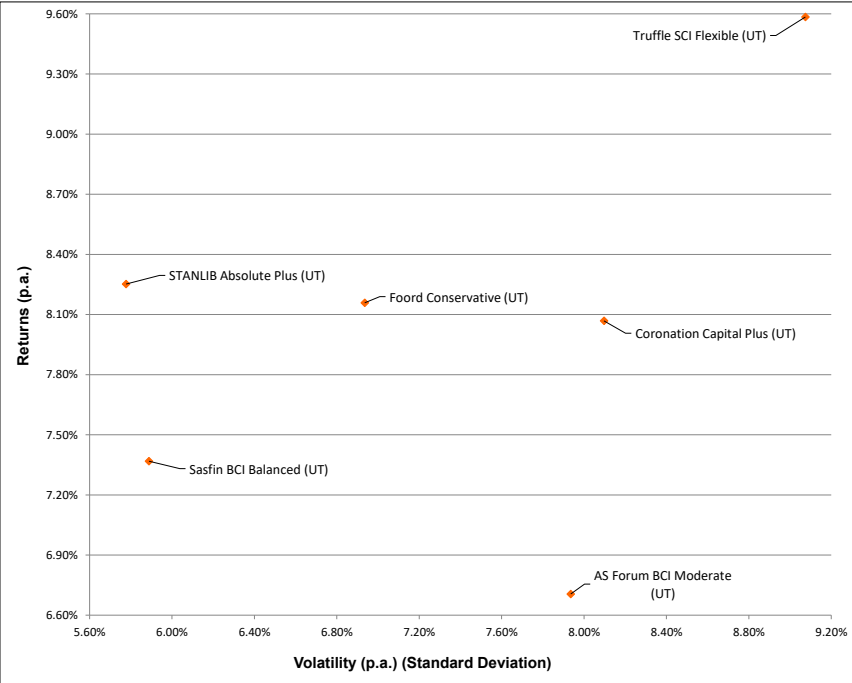


DECATHLON RETAIL S.A. INCLUDING GLOBAL - MEDIUM EQUITY

7 years ended 31 July 2025

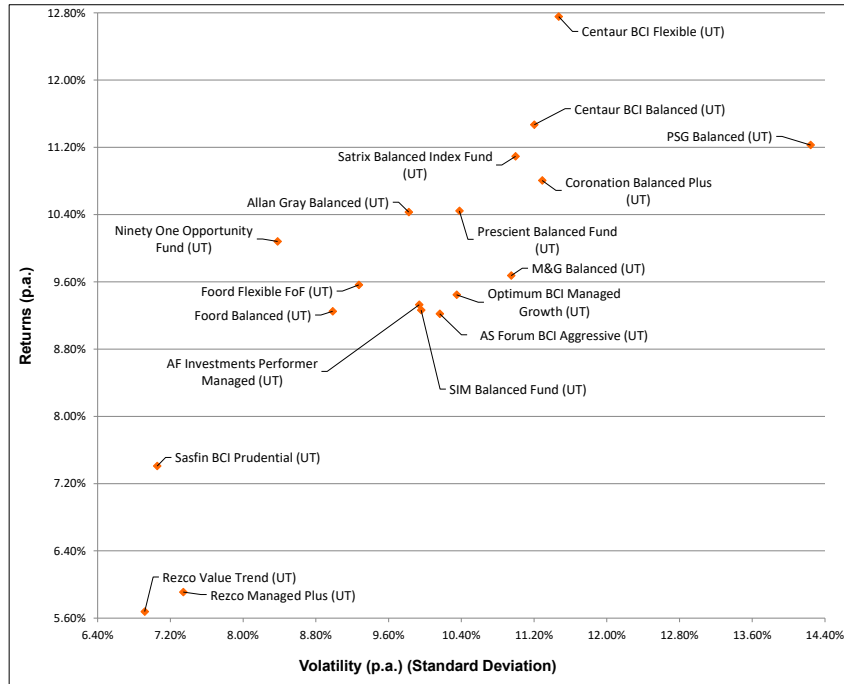

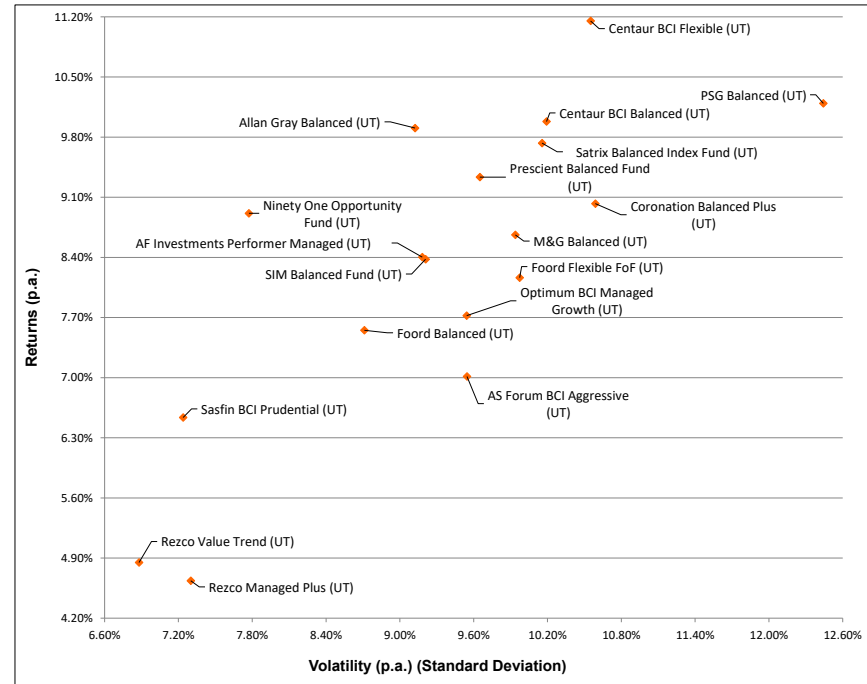


DECATHLON RETAIL S.A. INCLUDING GLOBAL - HIGH EQUITY
