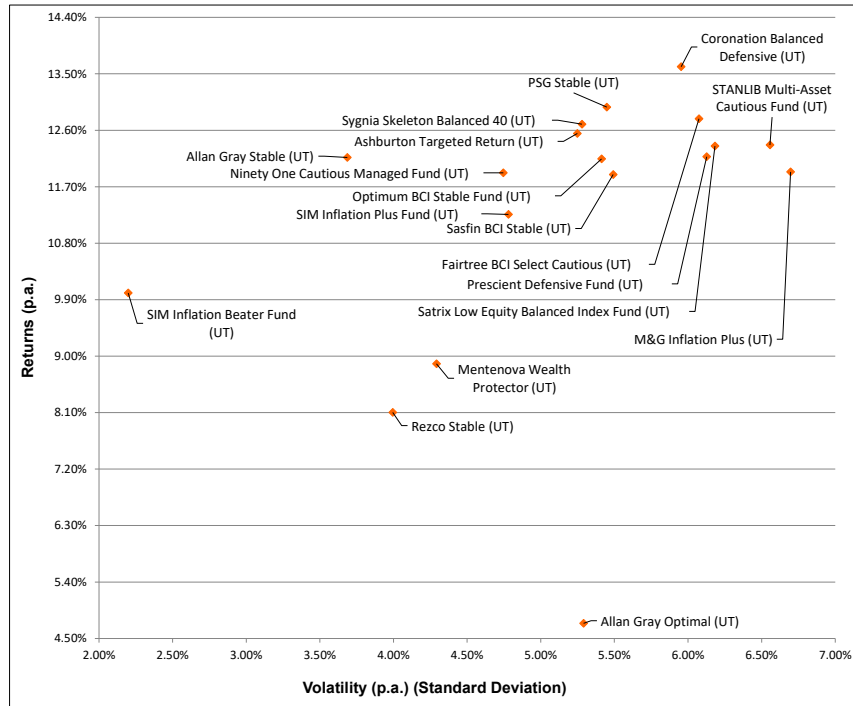

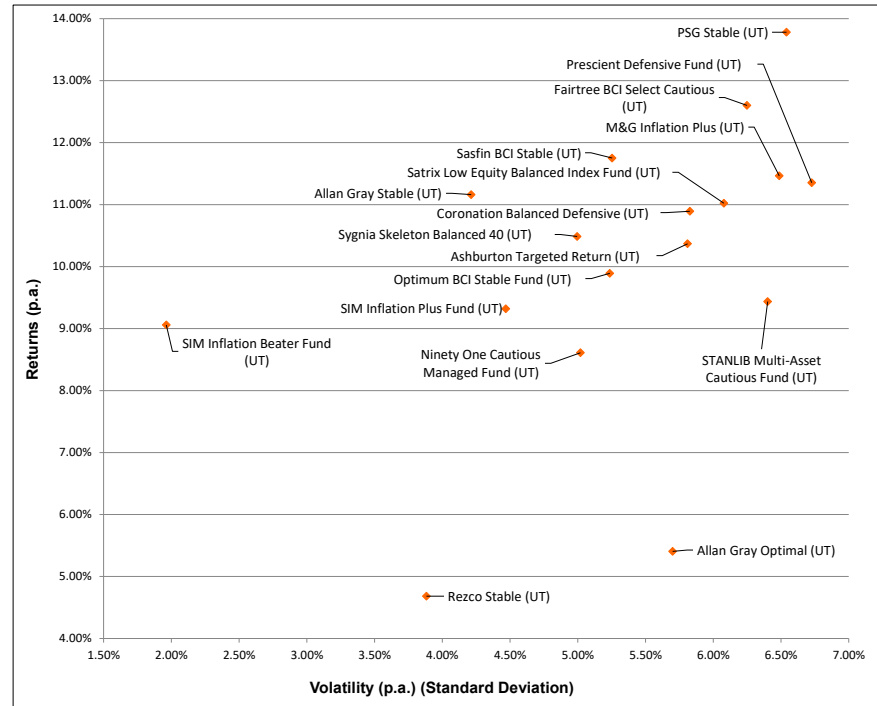

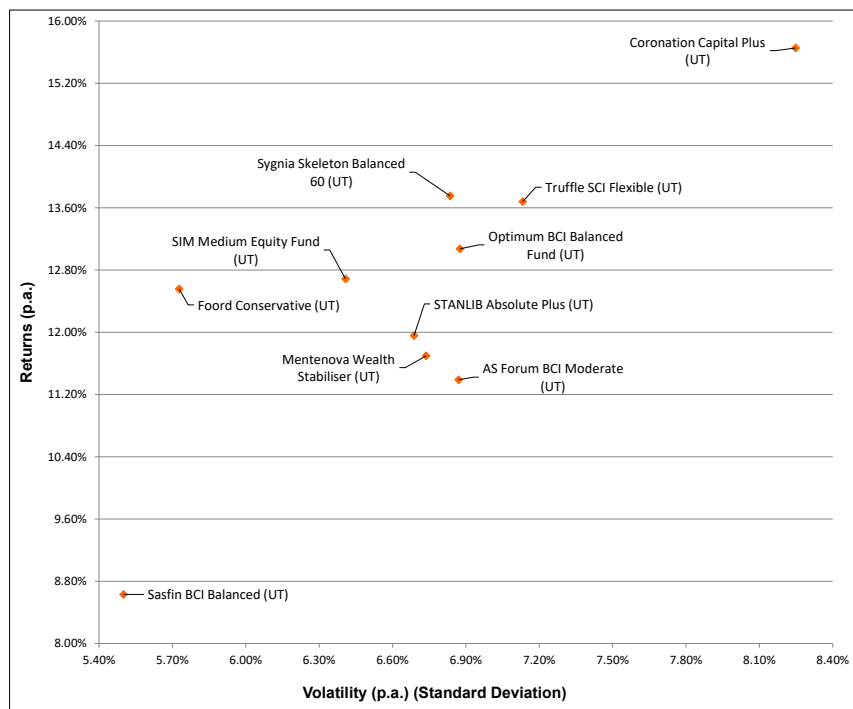


Risk vs Return
5 years ended 30 June 2025

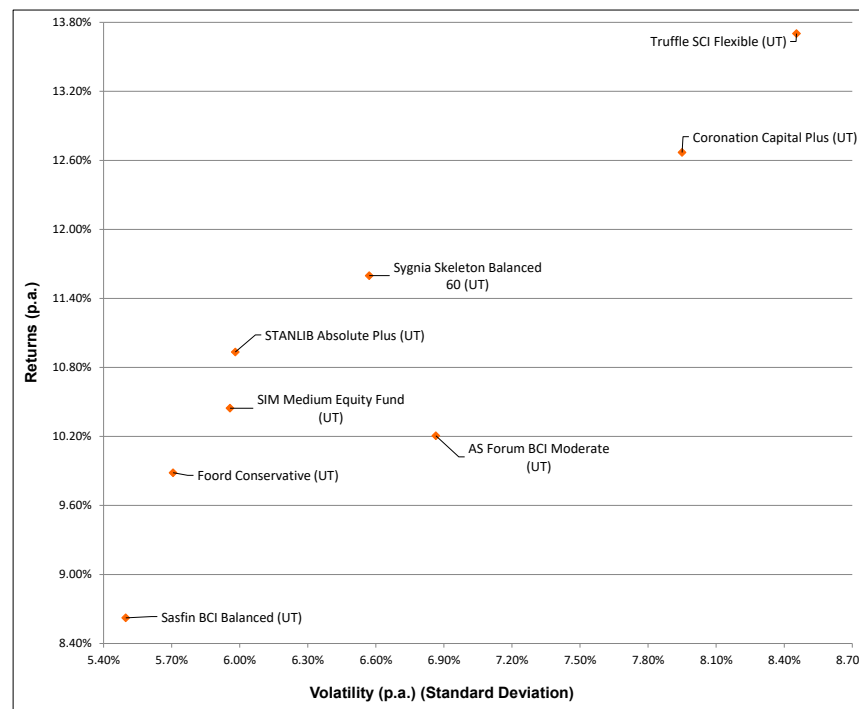

3 years ended 30 June 2025

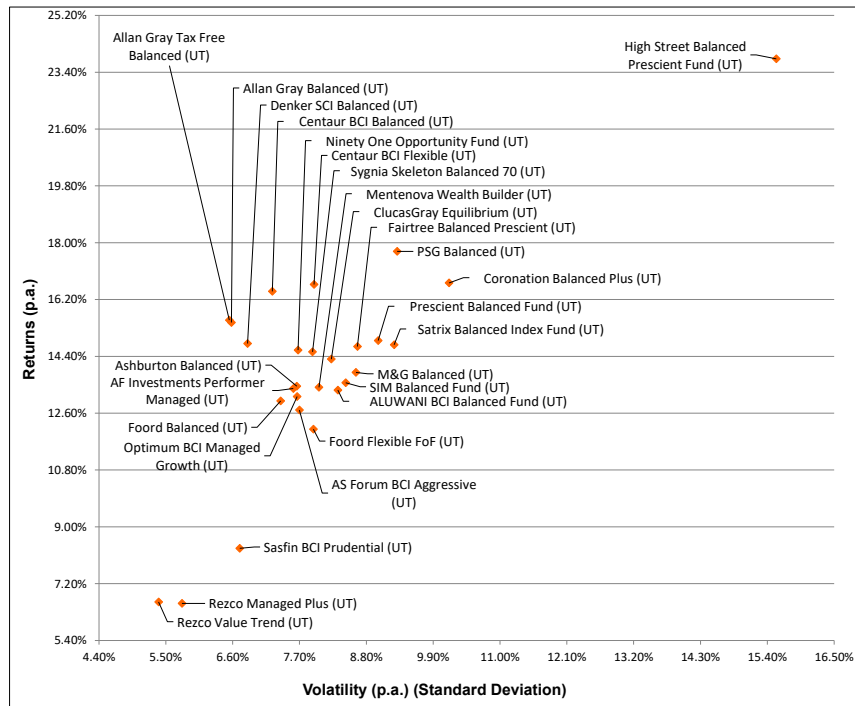

5 years ended 30 June 2025

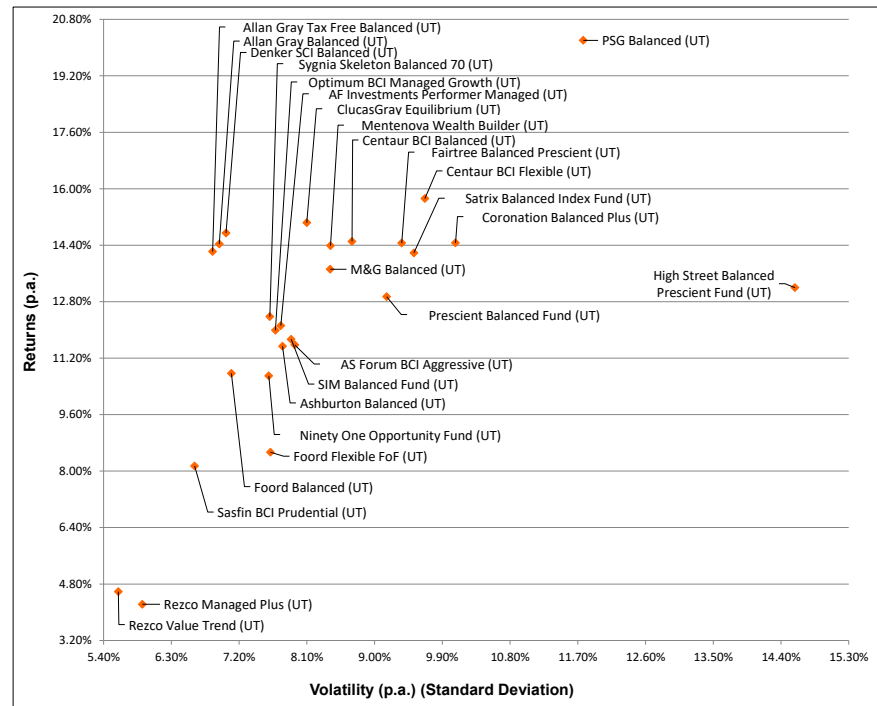


RETAIL S.A. INCLUDING GLOBAL MULTI-ASSET SURVEY - HIGH EQUITY

3 years ended 30 June 2025

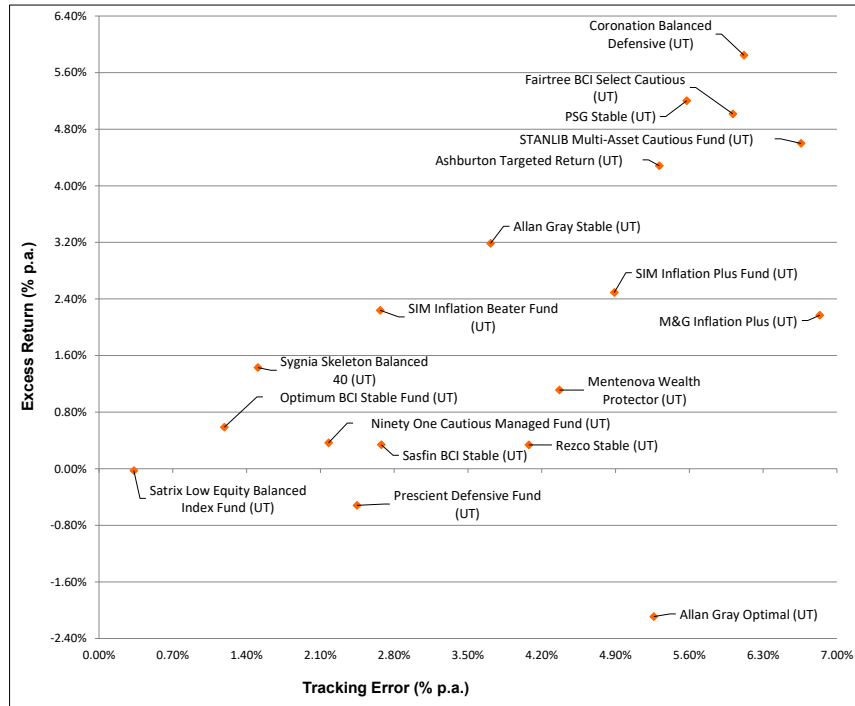

5 years ended 30 June 2025

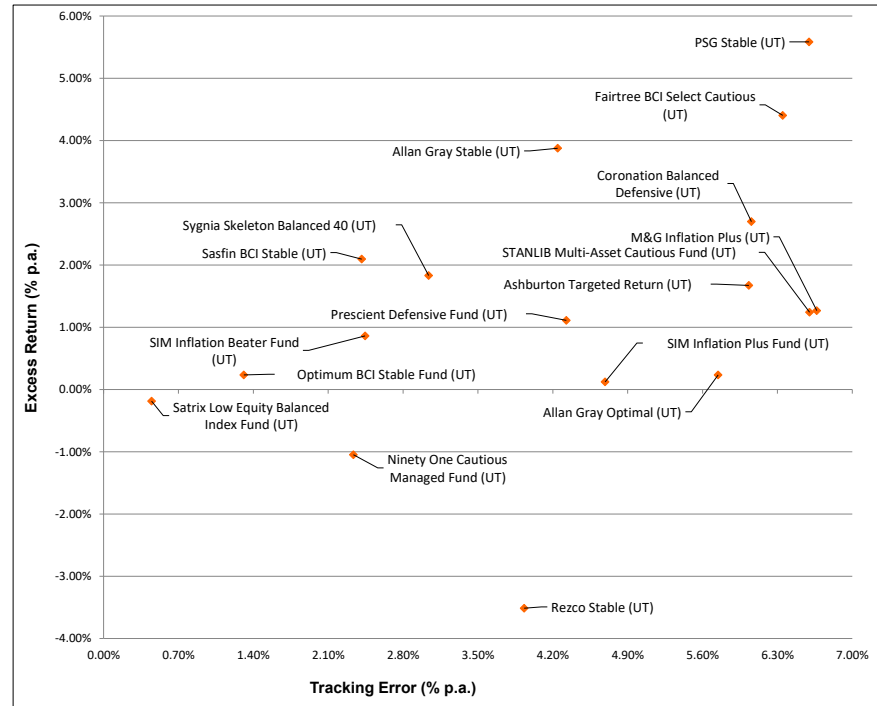


RETAIL S.A. INCLUDING GLOBAL MULTI-ASSET SURVEY - LOW EQUITY

3 years ended 30 June 2025**

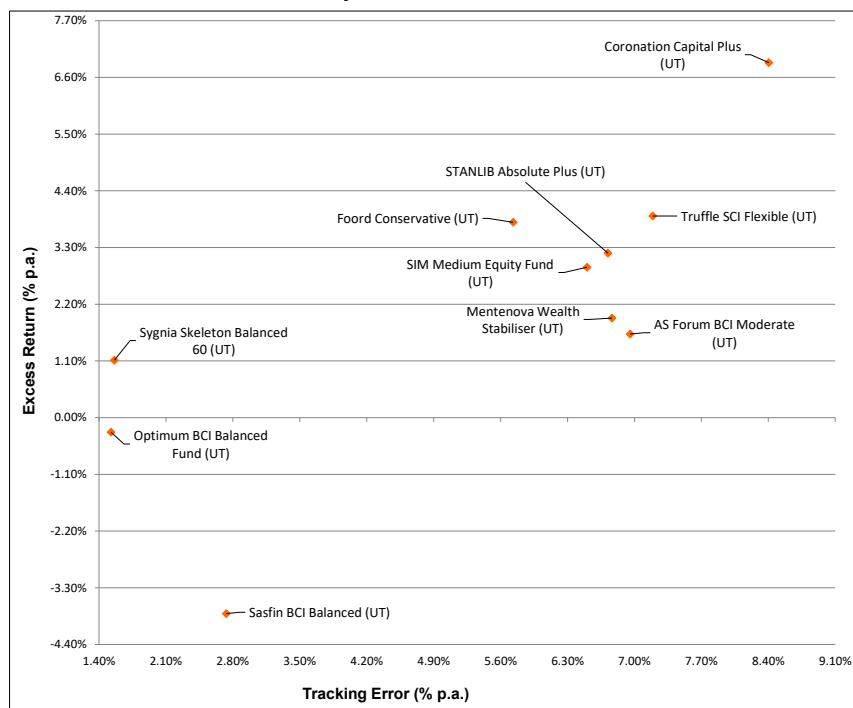


**Excess Return vs Tracking Error
5 years ended 30 June 2025**

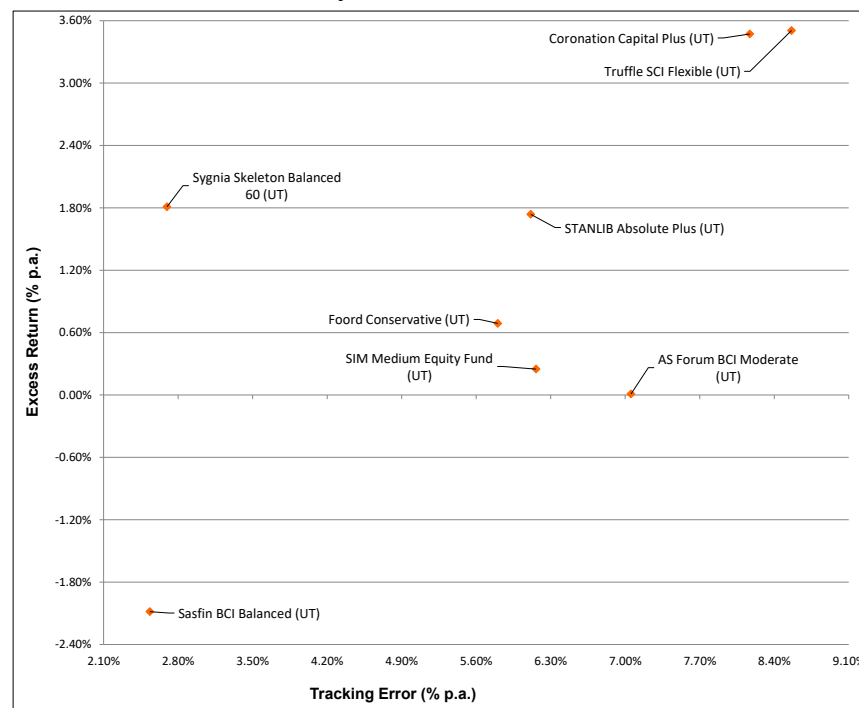

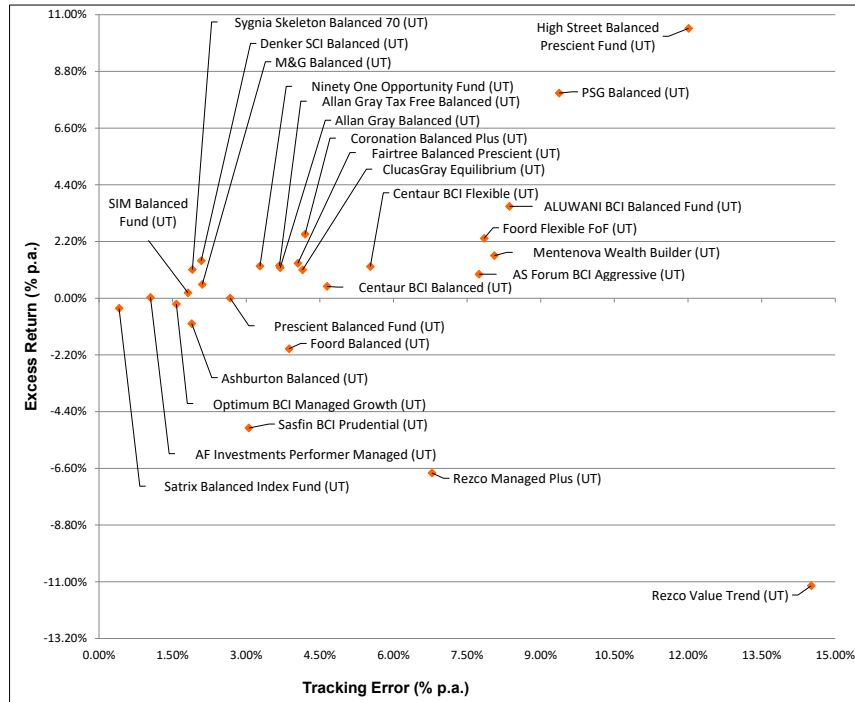


Excess Return vs Tracking Error
5 years ended 30 June 2025

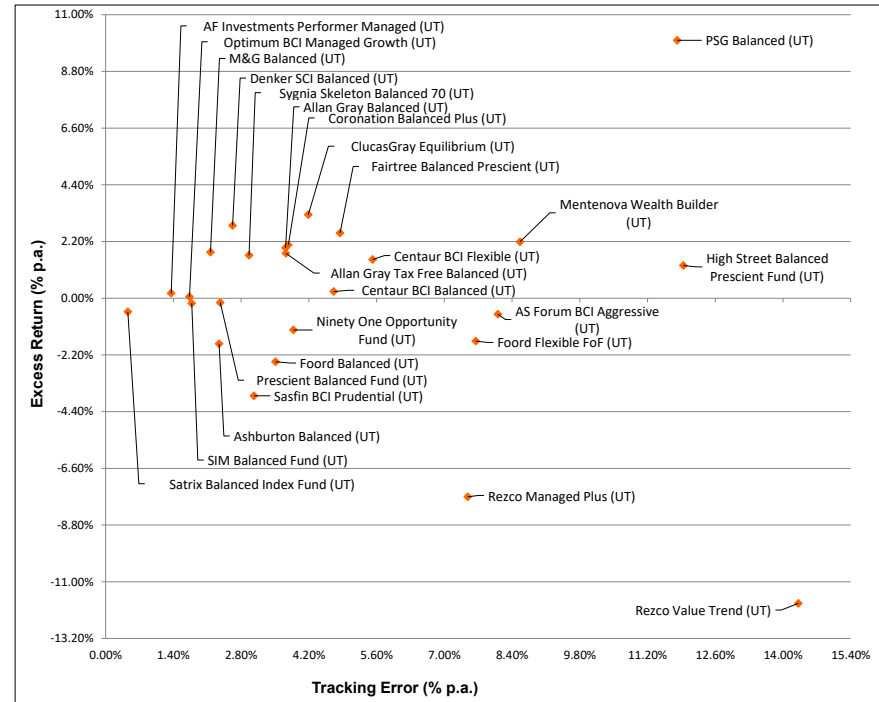

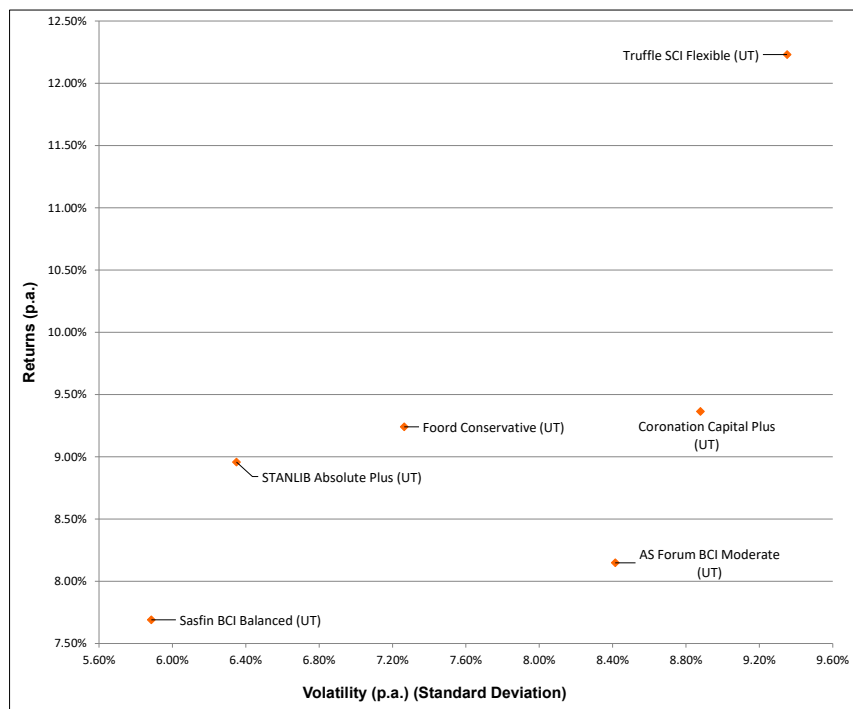


Risk vs Return
10 years ended 30 June 2025

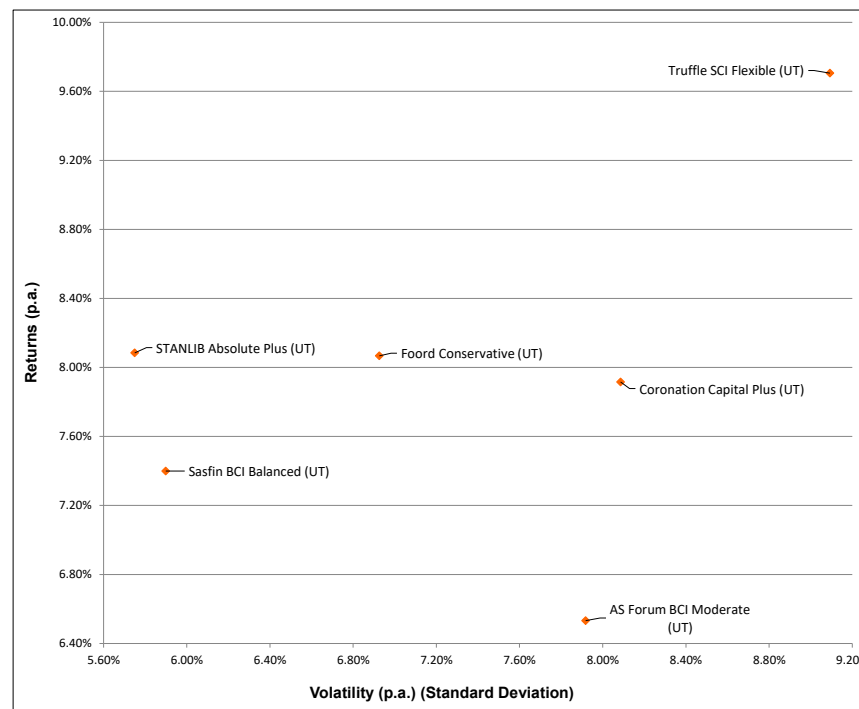

7 years ended 30 June 2025

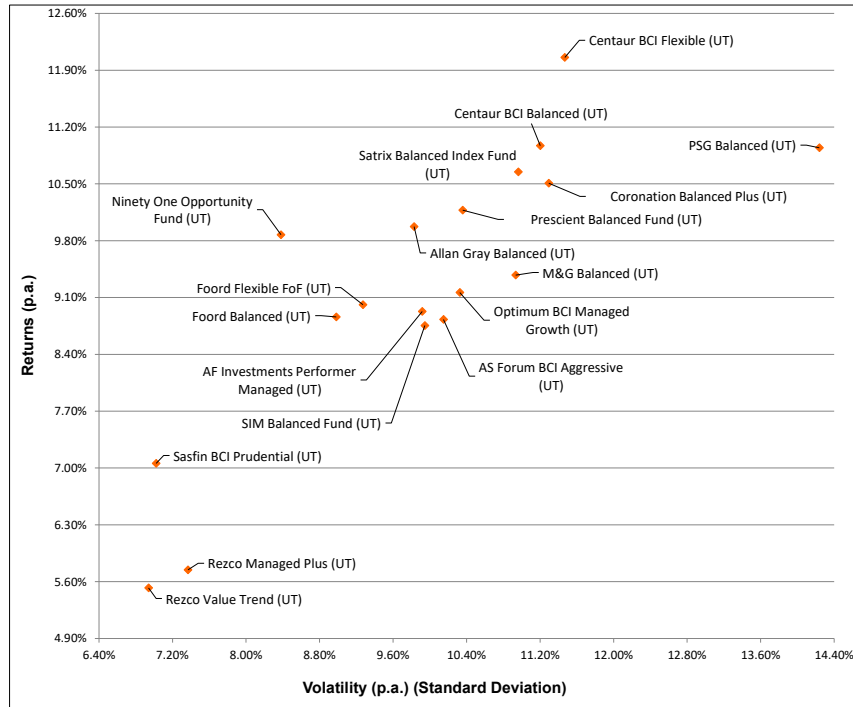

10 years ended 30 June 2025

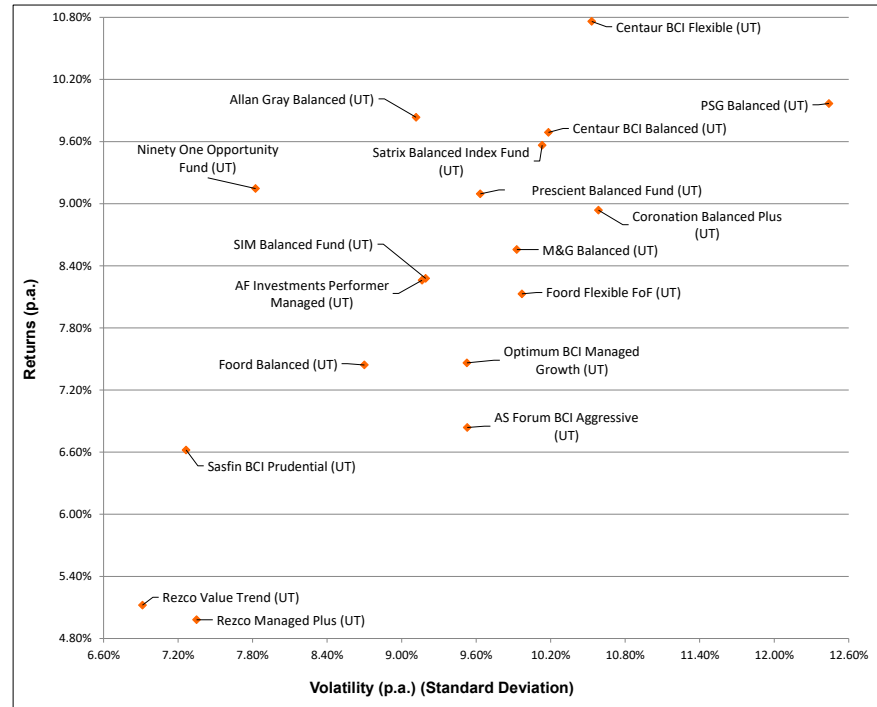
