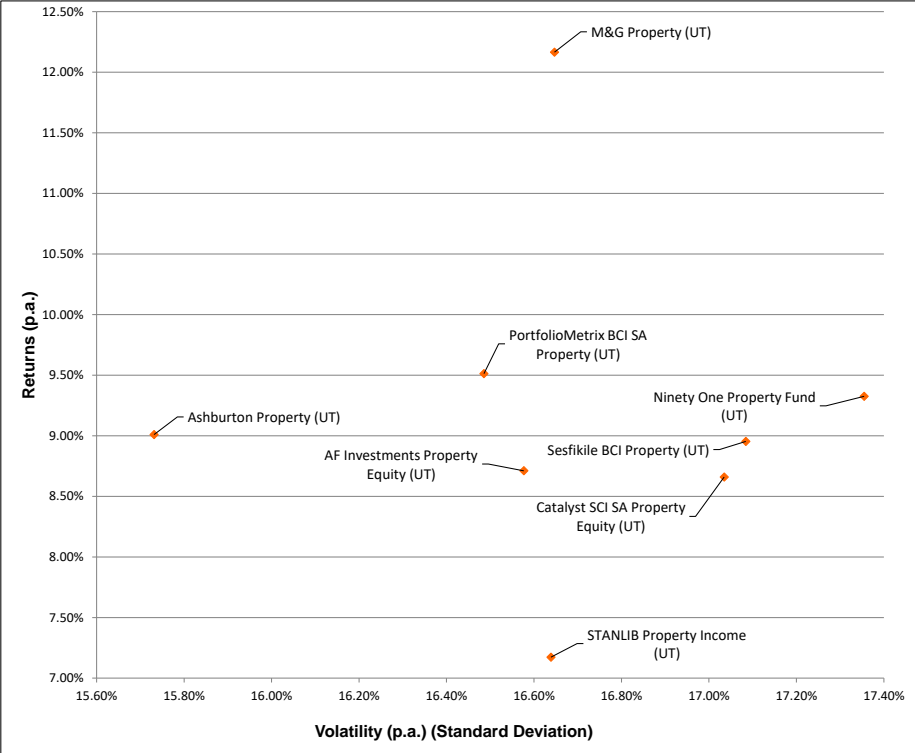

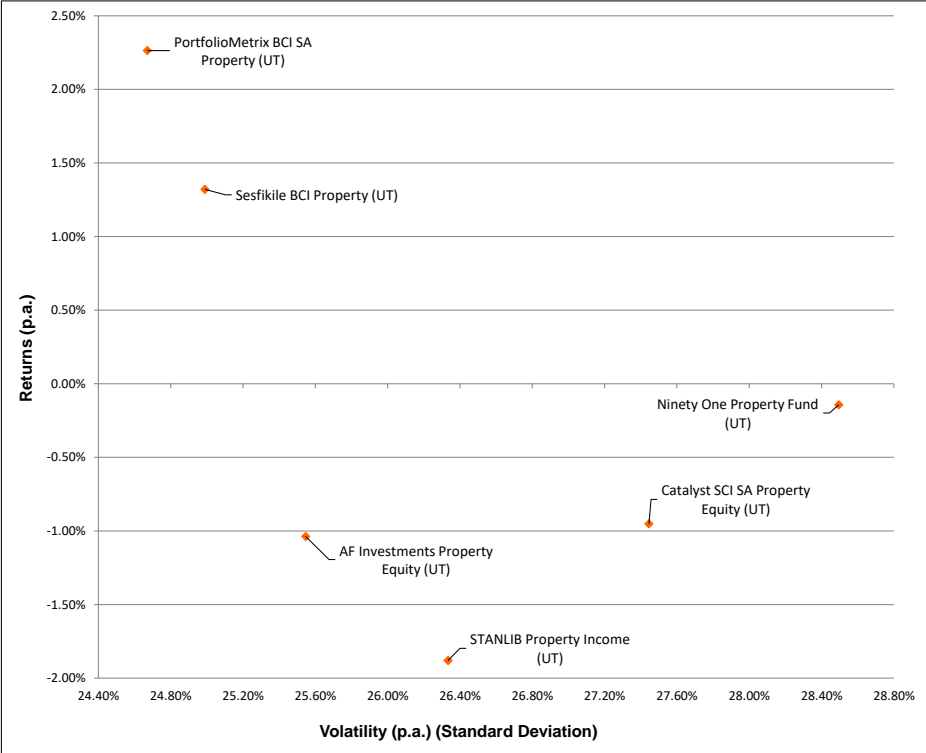

3 years ended 31 May 2024

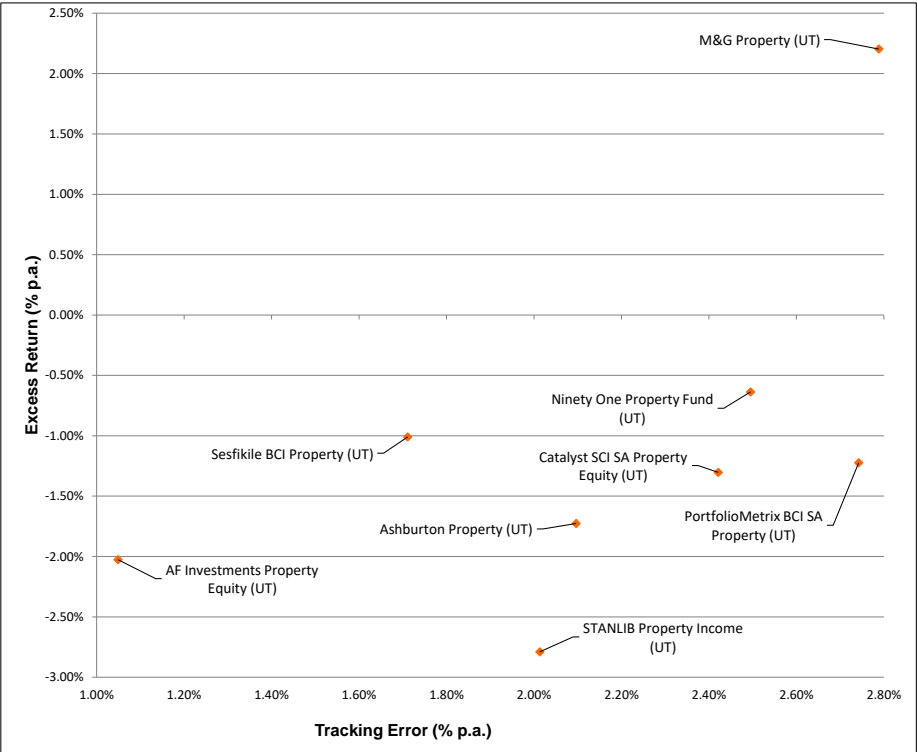


Risk vs Return
5 years ended 31 May 2024

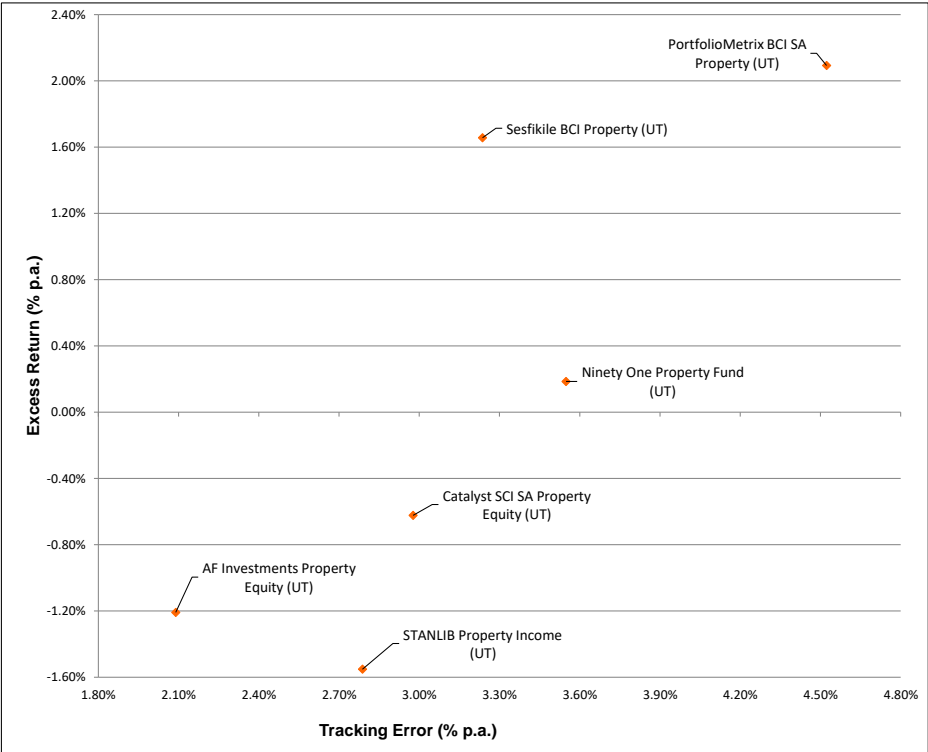

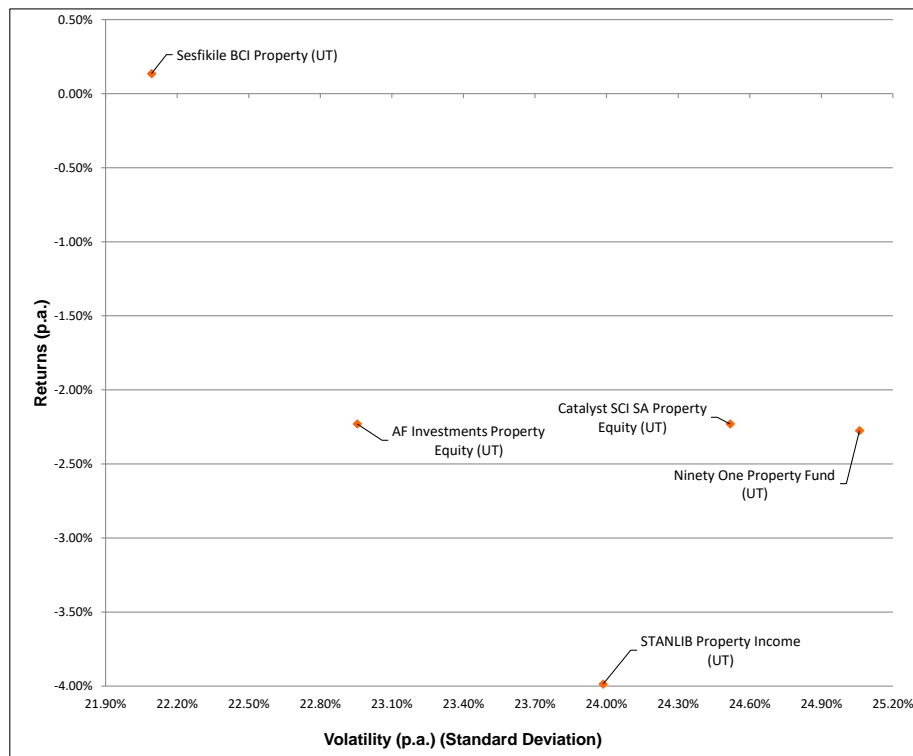

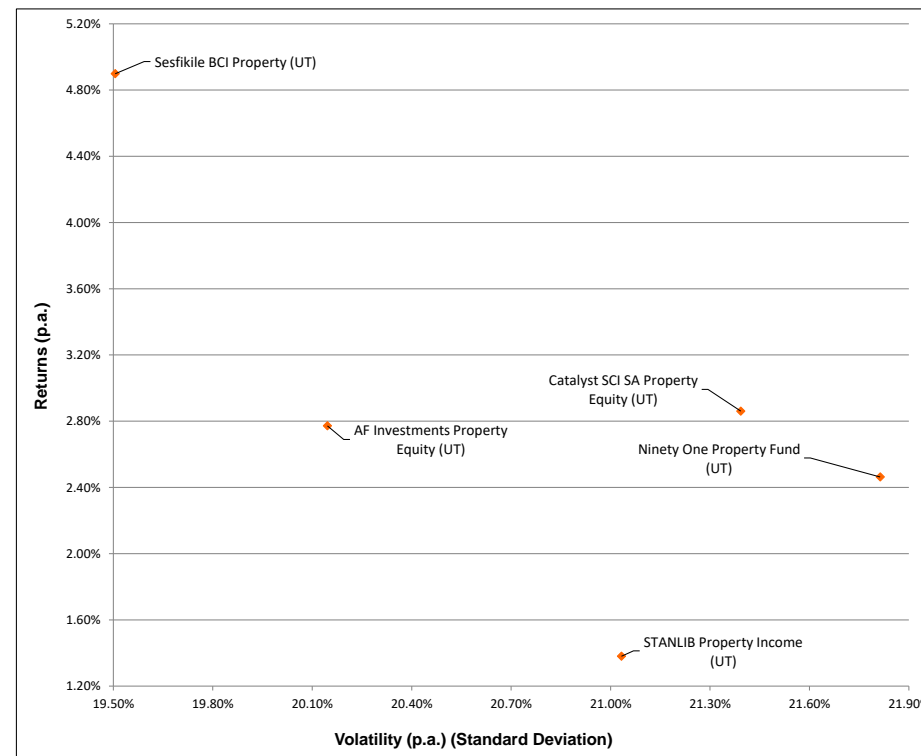
